- Information Technology Department (Request #1645) - To increase special funds spending authority and the criminal justice information sharing line item by \$1,410,160 to accept federal funds from the United States Department of Justice to implement a statewide automated victim information and notification (SAVIN) system. The system will be administered by the Department of Corrections and Rehabilitation.

- 1:35 p.m. Committee consideration of the following state agency requests, pursuant to NDCC Chapter 54-16, that have been authorized by the Emergency Commission and require consideration by the Budget Section:
- Adjutant General (Request #1656) - For \$52,100 from the state contingencies appropriation for costs incurred by the National Guard for assisting residents of Northwood with necessary repairs to damaged homes (\$48,000), providing the Department of Transportation with diesel fuel supply assistance (\$2,236), and providing operational support in Mandan during a natural gas pipeline break (\$1,852)
  - North Dakota Department of Health (Request #1657) - To increase the salaries and wages line item by \$74,000 of federal funds from the Centers for Disease Control and Prevention (CDC), to maintain North Dakota immunization information system (NDIIS) data, enhance the data quality in the NDIIS, and conduct statistical analysis of NDIIS data. The funding is for one FTE epidemiologist II.
  - North Dakota Veterans Home (Request #1658) - To increase the salaries and wages line item by \$133,500 of special funds available due to actual Veterans Home collections exceeding estimates. The request is necessary to comply with recommendations resulting from a federal Department of Veterans Affairs survey and focus review. The increase will allow the Veterans Home to hire an additional three FTE positions.
  - North Dakota Veterans Home (Request #1659) - For \$109,000 from the state contingencies appropriation and to increase the capital assets line item by \$2,128,000. The additional funding includes \$1,400,000 in federal funds, \$619,000 in special funds, and \$109,000 from the state contingencies appropriation. The cost estimate for the new 150-bed Veterans Home has increased from \$21.1 million to \$25.6 million. The cost of the 121-bed portion of the project has increased from \$18.5 million to \$20.7 million. The federal Department of Veterans Affairs will provide the additional federal funds necessary for 65 percent of the increased cost of the 121-bed facility if the Veterans Home provides written verification of its 35 percent match required for this portion of the project.
  - Department of Agriculture (Request #1660) - To increase federal funds spending authority by \$264,365 for the salaries and wages line item (\$132,832) and operating expenses line item (\$131,533). The federal funds are received through the United States Department of Agriculture to conduct a survey related to potato cyst nematode.
  - Secretary of State (Request #1661) - To increase federal funds spending authority by \$575,000 to accept federal funds from the United States Election Assistance Commission for the Help America Vote Act election reform fund and for \$30,263 from the state contingencies appropriation for the 5 percent state match required to obtain the \$575,000 of federal funds
