## REMARKS OF MISS NORTH DAKOTA, ANNETTE OLSON

Good afternoon ladies and gentlemen, my name is Annette Olson. I appreciate the opportunity to speak with you today. As Miss North Dakota, I have the privilege of meeting and talking with students across the state. I have visited 40 schools and spoken to approximately five thousand students. I have been so impressed with the young people I have met, and the administration and teachers at our North Dakota schools. I attended a tiny country school in Regan, North Dakota. I was the only student in my grade. I feel so fortunate to have been able to receive my education in such a setting. From the largest schools in the state to the very smallest, education in North Dakota is top-notch.

This year I have traveled the state promoting the "Eat Smart, Play Hard" campaign. This is a program of the NDSU Extension Service. As an employee of the State Health Department, I am aware of the correlation between diet and disease. I find the recent trends toward childhood obesity and chronic illness particularly alarming. I teach kids about the importance of making healthy lifestyle choices in regard to nutrition and exercise.

When I am visiting with youth, we often discuss their goals and future ambitions. This is my favorite part of being Miss North Dakota. These young people have bright futures and big dreams. I am convinced that we have some of the country's best educated, most talented, and hardest working kids. Thank you for the work you do to support education in our small schools as well as our larger schools. You have deemed youth leadership and achievement programs in our state, programs like 4-H, a priority. These programs give our children the skills to achieve their dreams.

The ongoing work to bring new businesses and opportunities in technology, research, and renewable energy offers promising futures for the youth of North Dakota. This is an exciting time of growth and economic development in our state. With all of the potential on the horizon, North Dakota is a great place for young people.

**HB 1515:** A BILL for an Act to create and enact a new section to chapter 20.1-02 and a new section to chapter 54-17 of the North Dakota Century Code, relating to establishment of a private land open to sportsmen biomass demonstration project and the duty of the industrial commission to establish a biomass incentive and research program; and to provide an appropriation.

Was read the first time and referred to the **Natural Resources Committee**.

**HB 1517:** A BILL for an Act to amend and reenact section 65-05-32 of the North Dakota Century Code, relating to release of information by workforce safety and insurance; and to provide a penalty.

Was read the first time and referred to the **Industry, Business and Labor Committee**.

#### FIRST READING OF HOUSE CONCURRENT RESOLUTIONS

**HCR 3004:** A concurrent resolution directing the Legislative Council to study issues relating to child custody, visitation, and child support in this state, including issues of fairness and equity as they relate to the issuance and enforcement of child custody, visitation, and child support orders and whether the state should pursue nonadversarial alternatives for the resolution of family law disputes.

Was read the first time and referred to the **Human Services Committee**.

**HCR 3007:** A concurrent resolution urging Congress to require a nationwide referendum of beef producers before allowing an increase in the beef checkoff rate.

Was read the first time and referred to the **Agriculture Committee**.

**HCR 3010:** A concurrent resolution urging Congress to implement country of origin labeling for all meat products.

Was read the first time and referred to the **Agriculture Committee**.

**HCR 3022:** A concurrent resolution directing the Legislative Council to study the availability and future need for dementia-related services, as well as funding for programs for individuals with dementias.

Was read the first time and referred to the **Human Services Committee**.

**HCR 3023:** A concurrent resolution urging the President of the United States and Congress to open the coastal plain of the Arctic National Wildlife Refuge to oil and gas exploration and development.

Was read the first time and referred to the **Natural Resources Committee**.

**HCR 3024:** A concurrent resolution in support of the efforts of the Congressional Delegation, the Governor's Task Force on Military in North Dakota, the Grand Forks Council on Military Relations, the Minot Task Force 21, and the Fargo-Moorhead (F-M) Air National Guard Support Group to maintain and enhance military force structure and missions in this state and support of state and local officials in their efforts to keep this state a first-class place for members of the armed forces to live and work.

Was read the first time and referred to the **Political Subdivisions Committee**.

**HCR 3025:** A concurrent resolution directing the Legislative Council to study possible methods of growing North Dakota's population and increasing the available workforce in the state.

Was read the first time and referred to the **Industry, Business and Labor Committee**.

**HCR 3026:** A concurrent resolution directing the Legislative Council to study the feasibility and desirability of establishing legislation for the enforcement and assessment of civil penalties for violation of the one-call excavation notice system.

Was read the first time and referred to the **Judiciary Committee**.

**HCR 3028:** A concurrent resolution urging Congress to recognize the multiple benefits of industrial hemp and to facilitate the growing of industrial hemp and the expansion of industries reliant on industrial hemp-based products.

Was read the first time and referred to the **Agriculture Committee**.

**HCR 3032:** A concurrent resolution acknowledging the actions of the 44th Legislative Assembly of North Dakota and the sponsors of Senate Concurrent Resolution No. 4007 affirming the equal application of the United States Constitution to all citizens through the passage of the Equal Rights Amendment; declaring Friday, March 9, 2007, North Dakota Equal Rights Amendment Recognition Day; and encouraging a recommitment to the ratification of the Equal Rights Amendment in all states and final passage in Congress.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**HCR 3033:** A concurrent resolution urging Congress not to allow the importation of Canadian cattle over 30 months of age.

Was read the first time and referred to the **Agriculture Committee**.

**HCR 3034:** A concurrent resolution directing the Legislative Council to study the feasibility and desirability of eliminating refunds from the potato assessment law.

Was read the first time and referred to the **Agriculture Committee**.

**HCR 3035:** A concurrent resolution proclaiming February 12, 2008, through February 12, 2010, the official observance of the bicentennial of Abraham Lincoln's birth.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**HCR 3036:** A concurrent resolution urging Congress and the President of the United States to enact federal legislation to deny unintended tax benefits to foreign subsidiaries of United States companies which are set up in tax haven countries.

Was read the first time and referred to the **Finance and Taxation Committee**.

**HCR 3037:** A concurrent resolution urging Congress to decouple federal mineral royalty revenue payments from states to counties when calculating PILT payments.

Was read the first time and referred to the **Political Subdivisions Committee**.

**HCR 3038:** A concurrent resolution supporting the efforts of the President of the United States, the North Dakota Congressional Delegation, North Dakota Insurance Commissioner Jim Poolman, North Dakota Attorney General Wayne Stenehjem, and United States Attorney Drew Wrigley to make prescription drugs safer and more affordable and urging Congress to take the necessary actions to study the lifesaving value, affordability, accessibility, and efficacy of prescription drugs for all Americans.

Was read the first time and referred to the **Human Services Committee**.

**HCR 3039:** A concurrent resolution urging the United States Secretary of Commerce to complete a Taiwan-United States free trade agreement.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**HCR 3041:** A concurrent resolution directing the Legislative Council to study the trends and correlations of property tax revenue in relation to funding human service delivery in individual counties.

Was read the first time and referred to the **Human Services Committee**.

**HCR 3042:** A concurrent resolution urging Congress to direct the United States Drug Enforcement Administration to differentiate between industrial hemp and marijuana.

Was read the first time and referred to the **Agriculture Committee**.

**HCR 3043:** A concurrent resolution proclaiming January 29, 2007, as American Cancer Society Awareness Day.

Was read the first time and referred to the **Human Services Committee**.

**HCR 3044:** A concurrent resolution directing the Legislative Council to study how the state might pursue additional uses of Lake Sakakawea and Missouri River waters for such beneficial purposes as domestic and industrial uses, recreation, fish and wildlife, and irrigation, and how the state, to enhance its use of the lake and river, might promote congressional review of the 1944 Flood Control Act and a reexamination by the Corps of Engineers of the way in which it manages the Missouri River system.

Was read the first time and referred to the **Natural Resources Committee**.

**HCR 3046:** A concurrent resolution directing the Legislative Council to study ways in which various public and private entities can cooperate to promote healthy lifestyles for children and create awareness about the interplay of healthy lifestyle choices and educational success.

Was read the first time and referred to the **Human Services Committee**.
