1 A BILL for an Act to amend and reenact section 61-04-04.1 of the North Dakota Century Code,
2 relating to water permit application fees.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 61-04-04.1 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **61-04-04.1. Application fees.** The following fees must accompany an application and
7 must be paid by the state engineer into the water use fund of the state treasury:
