1 A BILL for an Act to create and enact chapter 26.1-33.4 of the North Dakota Century Code,  
2 relating to the national conference of insurance legislators Life Settlements Model Act; to  
3 amend and reenact subsections 19 and 21 of section 10-04-02 of the North Dakota Century  
4 Code, relating to the definition of the terms viatical or life settlement contract and security; to  
5 repeal chapter 26.1-33.3 of the North Dakota Century Code, relating to viatical settlement  
6 contracts; and to provide a penalty.

7 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

8 **SECTION 1. AMENDMENT.** Subsections 19 and 21 of section 10-04-02 of the North  
9 Dakota Century Code are amended and reenacted as follows:

10 19. "Security" means any note; stock; treasury stock; bond; debenture; evidence of  
11 indebtedness; certificate of interest or participation in any profit-sharing agreement;  
12 certificate of interest or participation in an oil, gas, or mining title or lease or in  
13 payments out of production under such a title or lease; collateral trust certificate;  
14 preorganization certificate or subscription; transferable share; investment contract;  
15 viatical or life settlement contract or a fractionalized or pooled interest therein;  
16 program, contract, or other arrangement in which persons invest in a common  
17 enterprise the returns of which depend to any extent upon inducing other persons  
18 to participate or invest in the enterprise; investment of money or money's worth  
19 including goods furnished or services performed in the risk capital of a venture with  
20 the expectation of profit or some other form of benefit to the investor when the  
21 investor has no direct control over the investment or policy decisions of the  
22 venture; voting-trust certificate; certificate of deposit for a security; foreign currency  
23 commodity contract, as used in chapter 51-23; or beneficial interest in title to  
24 property, profits, or earnings; or, in general, any interest or instrument commonly

1 known as a "security"; or any certificate of interest or participation in, temporary or  
2 interim certificate for, receipt for, guarantee of, or warrant or right to subscribe to or  
3 purchase, any of the foregoing.

4 21. "Viatical or life settlement contract" means an agreement for the purchase, sale,  
5 assignment, transfer, devise, or bequest of any portion of the death benefit or  
6 ownership of a life insurance policy or certificate, for consideration that is less than  
7 the expected death benefit of the life insurance policy or certificate. "Viatical or life  
8 settlement contract" does not include:

- 9 a. The assignment, transfer, sale, devise, or bequest of a death benefit, life  
10 insurance policy, or certificate of insurance by the ~~viator~~ owner to the ~~viatical~~  
11 ~~settlement~~ provider pursuant to chapter ~~26.1-33.3~~ 26.1-33.4;
- 12 b. The assignment of a life insurance policy to a bank or depository institution; or  
13 c. The exercise of accelerated benefits pursuant to the terms of a life insurance  
14 policy issued in accordance with the insurance laws of this state.

15 **SECTION 2.** Chapter 26.1-33.4 of the North Dakota Century Code is created and  
16 enacted as follows:

17 **26.1-33.4-01. Definitions.** As used in this chapter, unless the context requires  
18 otherwise:

19 1. "Advertisement" means any written, electronic, or printed communication or any  
20 communication by means of recorded telephone messages or transmitted on  
21 radio; television; the internet; or similar communications media, including filmstrips,  
22 motion pictures, and videos; published, disseminated, circulated, or placed before  
23 the public, directly or indirectly, for the purpose of creating an interest in or  
24 inducing a person to purchase or sell, assign, devise, bequest, or transfer the  
25 death benefit or ownership of a life insurance policy or an interest in a life  
26 insurance policy pursuant to a life settlement contract.

27 2. "Broker" means an individual who, on behalf of an owner and for a fee,  
28 commission, or other valuable consideration, offers or attempts to negotiate life  
29 settlement contracts between an owner and providers. A broker represents only  
30 the owner and owes a fiduciary duty to the owner to act according to the owner's  
31 instructions, and in the best interest of the owner, notwithstanding the manner in

- 1           which the broker is compensated. The term does not include an attorney, certified  
2           public accountant, or financial planner retained in the type of practice customarily  
3           performed in that individual's professional capacity to represent the owner whose  
4           compensation is not paid directly or indirectly by the provider or any other person,  
5           except the owner.
- 6           3. "Business of life settlements" includes an activity involved in offering to enter,  
7           soliciting, negotiating, procuring, effectuating, monitoring, or tracking of life  
8           settlement contracts.
- 9           4. "Chronically ill" means:
- 10           a. Being unable to perform at least two activities of daily living, such as eating,  
11           toileting, transferring, bathing, dressing, or continence;
- 12           b. Requiring substantial supervision to protect the individual from threats to  
13           health and safety due to severe cognitive impairment; or
- 14           c. Having a level of disability similar to that described in subdivision a as  
15           determined by the United States secretary of health and human services.
- 16           5. "Financing entity" means an underwriter, a placement agent, a lender, a purchaser  
17           of securities, a purchaser of a policy or certificate from a provider, a credit  
18           enhancer, or any entity that has a direct ownership in a policy or certificate that is  
19           the subject of a life settlement contract, but whose principal activity related to the  
20           transaction is providing funds to effect the life settlement contract or purchase of  
21           one or more polices, and who has an agreement in writing with one or more  
22           providers to finance the acquisition of life settlements contracts. The term does  
23           not include a nonaccredited investor or purchaser.
- 24           6. "Financing transaction" means a transaction in which a licensed provider obtains  
25           financing from a financing entity, including any secured or unsecured financing,  
26           any securitization transaction, or any securities offering which either is registered  
27           or exempt from registration under federal and state securities law.
- 28           7. "Fraudulent life settlement act" includes:
- 29           a. Any act or omission committed by any person that, knowingly and with intent  
30           to defraud, for the purpose of depriving another of property or for pecuniary

- 1                   gain, commits or permits the person's employees or agents to engage in acts,  
2                   including:
- 3                   (1)   Presenting, causing to be presented, or preparing with knowledge and  
4                   belief that it will be presented to or by a provider, premium finance  
5                   lender, broker, insurer, insurance producer, or any other person, false  
6                   material information, or concealing material information, as part of, in  
7                   support of, or concerning a fact material to one or more of the following:
- 8                   (a)   An application for the issuance of a life settlement contract or  
9                   insurance policy;
- 10                  (b)   The underwriting of a life settlement contract or insurance policy;
- 11                  (c)   A claim for payment or benefit pursuant to a life settlement  
12                  contract or insurance policy;
- 13                  (d)   Premiums paid on an insurance policy;
- 14                  (e)   Payments and changes in ownership or beneficiary made in  
15                  accordance with the terms of a life settlement contract or  
16                  insurance policy;
- 17                  (f)   The reinstatement or conversion of an insurance policy;
- 18                  (g)   In the solicitation, offer to enter, or effectuation of a life  
19                  settlement contract or insurance policy;
- 20                  (h)   The issuance of written evidence of life settlement contracts or  
21                  insurance;
- 22                  (i)   Any application for, the existence of, or any payments related to  
23                  a loan secured directly or indirectly by any interest in a life  
24                  insurance policy; or
- 25                  (j)   Enter into any practice or plan which involves stranger-originated  
26                  life insurance;
- 27                  (2)   Failing to disclose to the insurer where the request for such disclosure  
28                  has been asked for by the insurer that the prospective insured has  
29                  undergone a life expectancy evaluation by any individual or entity other  
30                  than the insurer or the insurer's authorized representatives in  
31                  connection with the issuance of the policy.

- 1                   (3) Employing any device, scheme, or artifice to defraud in the business of  
2                   life settlements.
- 3                   (4) In the solicitation, application, or issuance of a life insurance policy,  
4                   employing any device, scheme, or artifice in violation of state insurable  
5                   interest laws.
- 6           b. In the furtherance of a fraud or to prevent the detection of a fraud, any person  
7           commits or permits the person's employees or agents to:
- 8                   (1) Remove, conceal, alter, destroy, or sequester from the commissioner  
9                   the assets or records of a licensee or other person engaged in the  
10                  business of life settlements;
- 11                  (2) Misrepresent or conceal the financial condition of a licensee, financing  
12                  entity, insurer, or other person;
- 13                  (3) Transact the business of life settlements in violation of laws requiring a  
14                  license, certificate of authority, or other legal authority for the  
15                  transaction of the business of life settlements;
- 16                  (4) File with the commissioner or the chief insurance regulatory official of  
17                  another jurisdiction a document containing false information or  
18                  otherwise concealing information about a material fact from the  
19                  commissioner;
- 20                  (5) Engage in embezzlement, theft, misappropriation, or conversion of  
21                  moneys, funds, premiums, credits, or other property of a provider, an  
22                  insurer, an insured, an owner, an insurance, a policyowner, or any  
23                  other person engaged in the business of life settlements or insurance;
- 24                  (6) Knowingly and with intent to defraud, enter, broker, or otherwise deal in  
25                  a life settlement contract, the subject of which is a life insurance policy  
26                  that was obtained by presenting false information concerning any fact  
27                  material to the policy or by concealing, for the purpose of misleading  
28                  another, information concerning any fact material to the policy, where  
29                  the owner or the owner's agent intended to defraud the policy's issuer;

- 1                   (7) Attempt to commit, assist, aid, or abet in the commission of or  
2                   conspiracy to commit the acts or omissions specified in this subsection;  
3                   or  
4                   (8) Misrepresent the state of residence of an owner to be a state or  
5                   jurisdiction that does not have a law substantially similar to this chapter  
6                   for the purpose of evading or avoiding the provisions of this chapter.
- 7           8. "Insured" means the individual covered under the policy being considered for sale  
8           in a life settlement contract.
- 9           9. "Life expectancy" means the arithmetic mean of the number of months the insured  
10           under the life insurance policy to be settled can be expected to live as determined  
11           by a life expectancy company considering medical records and appropriate  
12           experiential data.
- 13           10. "Life insurance producer" means any person licensed in this state as a resident or  
14           nonresident insurance producer that has received qualification or authority for life  
15           insurance coverage or a life line of coverage pursuant to chapter 26.1-26.
- 16           11. "Life settlement contract" means a written agreement entered between a provider,  
17           or any affiliate of the provider, and an owner establishing the terms under which  
18           compensation or anything of value will be paid, which compensation or thing of  
19           value is less than the expected death benefit of the insurance policy or certificate,  
20           in return for the owner's present or future assignment, transfer, sale, devise, or  
21           bequest of the death benefit or ownership of any portion of an insurance policy or  
22           certificate of insurance for compensation; provided, however, that the minimum  
23           value for a life settlement contract must be greater than a cash surrender value or  
24           accelerated death benefit available at the time of an application for a life settlement  
25           contract. The term includes the transfer for compensation or value of ownership or  
26           beneficial interest in a trust or other entity that owns such policy if the trust or other  
27           entity was formed or availed of for the principal purpose of acquiring one or more  
28           life insurance contracts, which life insurance contract insures the life of an  
29           individual residing in this state.
- 30           a. "Life settlement contract" also includes:

- 1                   (1) A written agreement for a loan or other lending transaction, secured  
2                               primarily by an individual or group life insurance policy; or  
3                   (2) A premium finance loan made for a policy on or before the date of  
4                               issuance of the policy when:  
5                               (a) The loan proceeds are not used solely to pay premiums for the  
6                                       policy and any costs or expenses incurred by the lender or the  
7                                       borrower in connection with the financing;  
8                               (b) The owner receives on the date of the premium finance loan a  
9                                       guarantee of the future life settlement value of the policy; or  
10                              (c) The owner agrees on the date of the premium finance loan to sell  
11                                       the policy or any portion of the policy's death benefit on any date  
12                                       following the issuance of the policy.  
13            b. "Life settlement contract" does not include:  
14                              (1) A policy loan by a life insurance company pursuant to the terms of the  
15                                       life insurance policy or accelerated death provisions contained in the  
16                                       life insurance policy, whether issued with the original policy or as a  
17                                       rider;  
18                              (2) A premium finance loan, as defined herein, or any loan made by a bank  
19                                       or other licensed financial institution, provided that neither default on  
20                                       such loan nor the transfer of the policy in connection with such default  
21                                       is pursuant to an agreement or understanding with any other person for  
22                                       the purpose of evading regulation under this chapter;  
23                              (3) A collateral assignment of a life insurance policy by an owner;  
24                              (4) A loan made by a lender that does not violate chapter 26.1-20.1,  
25                                       provided the loan is not described in paragraph 1, and is not otherwise  
26                                       within the definition of life settlement contract;  
27                              (5) An agreement where all the parties:  
28                                       (a) Are closely related to the insured by blood or law; or  
29                                       (b) Have a lawful substantial economic interest in the continued life,  
30                                       health, and bodily safety of the individual insured, or are trusts  
31                                       established primarily for the benefit of such parties;

- 1                   (6) Any designation, consent, or agreement by an insured who is an  
2                   employee of an employer in connection with the purchase by the  
3                   employer, or trust established by the employer, of life insurance on the  
4                   life of the employee;
- 5                   (7) A bona fide business succession planning arrangement:
- 6                   (a) Between one or more shareholders in a corporation or between a  
7                   corporation and one or more of the corporation's shareholders or  
8                   one or more trusts established by the corporation's shareholders;
- 9                   (b) Between one or more partners in a partnership or between a  
10                  partnership and one or more of the partnership's partners or one  
11                  or more trusts established by the partnership's partners; or
- 12                  (c) Between one or more members in a limited liability company or  
13                  between a limited liability company and one or more of the  
14                  limited liability company's members or one or more trusts  
15                  established by the limited liability company's members;
- 16                  (8) An agreement entered by a service recipient, or a trust established by  
17                  the service recipient, and a service provider, or a trust established by  
18                  the service provider, who performs significant services for the service  
19                  recipient's trade or business; or
- 20                  (9) Any other contract, transaction, or arrangement from the definition of  
21                  life settlement contract that the commissioner determines is not of the  
22                  type intended to be regulated by this chapter.
- 23                  12. "Net death benefit" means the amount of the life insurance policy or certificate to  
24                  be settled less any outstanding debt or lien.
- 25                  13. "Owner" means the owner of a life insurance policy or a certificate holder under a  
26                  group policy, with or without a terminal illness, who enters or seeks to enter a life  
27                  settlement contract. For the purposes of this definition, an owner is not limited to  
28                  an owner of a life insurance policy or a certificate holder under a group policy that  
29                  insures the life of an individual with a terminal or chronic illness or condition except  
30                  where specifically addressed. The term does not include:
- 31                  a. Any provider or other licensee under this chapter;



- 1            b. A qualified institutional buyer as defined in rule 144A of the federal Securities  
2            Act of 1933, as amended [15 U.S.C. 77a et seq.];
- 3            c. A financing entity;
- 4            d. A special purpose entity; or
- 5            e. A related provider trust.
- 6        14. "Patient identifying information" means an insured's address, telephone number,  
7            facsimile number, electronic mail address, photograph or likeness, employer,  
8            employment status, social security number, or any other information that is likely to  
9            lead to the identification of the insured.
- 10       15. "Policy" means an individual or group policy, group certificate, contract, or  
11            arrangement of life insurance owned by a resident of this state, regardless of  
12            whether delivered or issued for delivery in this state.
- 13       16. "Premium finance loan" means a loan made primarily for the purposes of making  
14            premium payments on a life insurance policy, which loan is secured by an interest  
15            in such life insurance policy.
- 16       17. "Provider" means a person, other than an owner, that enters or effectuates a life  
17            settlement contract with an owner. The term does not include:
- 18            a. Any bank, savings bank, savings and loan association, or credit union;
- 19            b. A licensed lending institution, creditor, or secured party pursuant to a  
20            premium finance loan agreement which takes an assignment of a life  
21            insurance policy or certificate issued pursuant to a group life insurance policy  
22            as collateral for a loan;
- 23            c. The insurer of a life insurance policy or rider to the extent of providing  
24            accelerated death benefits or riders or cash surrender value;
- 25            d. Any individual who enters or effectuates no more than one agreement in a  
26            calendar year for the transfer of a life insurance policy or certificate issued  
27            pursuant to a group life insurance policy, for compensation or anything of  
28            value less than the expected death benefit payable under the policy;
- 29            e. A purchaser;

- 1           f. Any authorized or eligible insurer that provides stop-loss coverage to a  
2                   provider, purchaser, financing entity, special purpose entity, or related  
3                   provider trust;
- 4           g. A financing entity;
- 5           h. A special purpose entity;
- 6           i. A related provider trust;
- 7           j. A broker; or
- 8           k. An accredited investor or qualified institutional buyer as defined respectively  
9                   in regulation D, rule 501 or rule 144A of the federal Securities Act of 1933, as  
10                  amended [15 U.S.C. 77a et seq.], that purchases a life settlement policy from  
11                  a provider.
- 12        18. "Purchased policy" means a policy or group certificate that has been acquired by a  
13                  provider pursuant to a life settlement contract.
- 14        19. "Purchaser" means a person that pays compensation or anything of value as  
15                  consideration for a beneficial interest in a trust which is vested with, or for the  
16                  assignment, transfer, or sale of, an ownership or other interest in a life insurance  
17                  policy or a certificate issued pursuant to a group life insurance policy which has  
18                  been the subject of a life settlement contract.
- 19        20. "Related provider trust" means a titling trust or other trust established by a licensed  
20                  provider or a financing entity for the sole purpose of holding the ownership or  
21                  beneficial interest in purchased policies in connection with a financing transaction.  
22                  In order to qualify as a related provider trust, the trust must have a written  
23                  agreement with the licensed provider under which the licensed provider is  
24                  responsible for ensuring compliance with all statutory and regulatory requirements  
25                  and under which the trust agrees to make all records and files relating to life  
26                  settlement transactions available to the insurance department as if those records  
27                  and files were maintained directly by the licensed provider.
- 28        21. "Settled policy" means a life insurance policy or certificate that has been acquired  
29                  by a provider pursuant to a life settlement contract.
- 30        22. "Special purpose entity" means an organization formed solely to provide either  
31                  directly or indirectly access to institutional capital markets for a financing entity or

1           provider; or in connection with a transaction in which the securities in the special  
2           purpose entity are acquired by the owner or by a "qualified institutional buyer" as  
3           defined in rule 144 promulgated under the federal Securities Act of 1933, as  
4           amended [15 U.S.C. 77a et seq.]; or the securities pay a fixed rate of return  
5           commensurate with established a set-backed institutional capital markets.

6           23. "Stranger-originated life insurance" is a practice or plan to initiate a life insurance  
7           policy for the benefit of a third-party investor that at the time of policy origination  
8           has no insurable interest in the insured. Stranger-originated life insurance  
9           practices include cases in which life insurance is purchased with resources or  
10           guarantees from or through a person that at the time of policy inception could not  
11           lawfully initiate the policy on its own, and where at the time of inception there is an  
12           arrangement or agreement, whether verbal or written, to directly or indirectly  
13           transfer the ownership of the policy or the policy benefits or both to a third party.  
14           Trusts that are created to give the appearance of insurable interest, and are used  
15           to initiate policies for investors, violate insurable interest laws and the prohibition  
16           against wagering on life. Stranger-originated life insurance arrangements do not  
17           include those practices set forth in subdivision b of subsection 11.

18           24. "Terminally ill" means having an illness or sickness that can reasonably be  
19           expected to result in death in twenty-four months or less.

20           **26.1-33.4-02. Licensing and bonding requirements.**

21           1. A person, wherever located, may not act as a provider or broker with an owner or  
22           multiple owners who is a resident of this state without first having obtained a  
23           license from the commissioner. If there is more than one owner on a single policy  
24           and the owners are residents of different states, the life settlement contract must  
25           be governed by the law of the state in which the owner having the largest  
26           percentage ownership resides or, if the owners hold equal ownership, the state of  
27           residence of one owner agreed upon in writing by all owners.

28           2. Application for a provider or broker license must be made to the commissioner by  
29           the applicant on a form prescribed by the commissioner, and the application must  
30           be accompanied by a fee in an amount established by the commissioner; provided,  
31           however, that the license and renewal fees for a provider license must be

- 1           reasonable and that the license and renewal fees for a broker license may not  
2           exceed those established for an insurance producer, as such fees are otherwise  
3           provided for in this title.
- 4           3. A life insurance producer who has been duly licensed as a resident insurance  
5           producer with a life line of authority in this state or the producer's home state for at  
6           least one year and is licensed as a nonresident producer in this state is deemed to  
7           meet the licensing requirements of this section and must be permitted to operate  
8           as a broker.
- 9           4. Not later than thirty days from the first day of operating as a broker, the life  
10           insurance producer shall notify the commissioner that the broker is acting as a  
11           broker on a form prescribed by the commissioner, and shall pay any applicable fee  
12           to be determined by the commissioner. Notification must include an  
13           acknowledgement by the life insurance producer that the broker will operate as a  
14           broker in accordance with this chapter.
- 15           5. The insurer that issued the policy that is the subject of a life settlement contract  
16           may not be responsible for any act or omission of a broker, provider, or purchaser  
17           arising out of or in connection with the life settlement transaction, unless the  
18           insurer receives compensation for the placement of a life settlement contract from  
19           the provider, purchaser, or broker in connection with the life settlement contract.
- 20           6. An individual licensed as an attorney, certified public accountant, or financial  
21           planner accredited by a nationally recognized accreditation agency, who is  
22           retained to represent the owner, whose compensation is not paid directly or  
23           indirectly by the provider or purchaser, may negotiate life settlement contracts on  
24           behalf of the owner without having to obtain a license as a broker.
- 25           7. Licenses may be renewed annually on the anniversary date upon payment of the  
26           periodic renewal fee. As specified in subsection 2, the renewal fee for a provider  
27           may not exceed a reasonable fee. Failure to pay the fee within the terms  
28           prescribed results in the automatic revocation of the license requiring periodic  
29           renewal.
- 30           8. The term of provider license must be equal to that of a domestic stock life  
31           insurance company and the term of a broker license must be equal to that of an

- 1           insurance producer license. Licenses requiring periodic renewal may be renewed  
2           on their anniversary date upon payment of the periodic renewal fee as specified in  
3           subsection 2. Failure to pay the fees before the expiration of the renewal date  
4           results in expiration of the license.
- 5           9. The applicant shall provide such information as the commissioner may require on  
6           forms prepared by the commissioner. The commissioner, at any time, may require  
7           the applicant to fully disclose the identity of the applicant's stockholders (except  
8           stockholders owning fewer than ten percent of the shares of an applicant whose  
9           shares are publicly traded), partners, officers, and employees, and the  
10           commissioner may refuse to issue the license in the name of any person if not  
11           satisfied that any officer, employee, stockholder, or partner thereof who may  
12           materially influence the applicant's conduct meets the standards of this chapter.
- 13           10. A license issued to a partnership, corporation, or other entity authorizes all  
14           members, officers, and designated employees to act as a licensee under the  
15           license, if those individuals are named in the application and any supplements to  
16           the application.
- 17           11. Upon the filing of an application and the payment of the license fee, the  
18           commissioner shall make an investigation of each applicant and may issue a  
19           license if the commissioner finds that the applicant:
- 20           a. If a provider, has provided a detailed plan of operation;  
21           b. Is competent and trustworthy and intends to transact the applicant's business  
22           in good faith;  
23           c. Has a good business reputation and has had experience, training, or  
24           education so as to be qualified in the business for which the license is  
25           applied;  
26           d. If the applicant is a legal entity, is formed or organized pursuant to the laws of  
27           this state, or is a foreign legal entity authorized to transact business in this  
28           state, or provides a certificate of good standing from the state of its domicile;  
29           e. Has provided to the commissioner an antifraud plan that meets the  
30           requirements of section 26.1-33.4-12 and includes:

- 1                   (1) A description of the procedures for detecting and investigating possible  
2                   fraudulent acts and procedures for resolving material inconsistencies  
3                   between medical records and insurance applications;  
4                   (2) A description of the procedures for reporting fraudulent insurance acts  
5                   to the commissioner;  
6                   (3) A description of the plan for antifraud education and training of the  
7                   applicant's underwriters and other personnel; and  
8                   (4) A written description or chart outlining the arrangement of the antifraud  
9                   personnel who are responsible for the investigation and reporting of  
10                  possible fraudulent insurance acts and investigating unresolved  
11                  material inconsistencies between medical records and insurance  
12                  applications; and
- 13                  f. If a provider or broker, has demonstrated evidence of financial responsibility  
14                  in a format prescribed by the commissioner through a surety bond executed  
15                  and issued by an insurer authorized to issue surety bonds in this state or  
16                  through a deposit of cash, certificates of deposit, or securities or any  
17                  combination thereof in the amount of one hundred fifty thousand dollars. The  
18                  commissioner shall accept, as evidence of financial responsibility under this  
19                  subdivision, proof that financial instruments in accordance with the  
20                  requirements in this subdivision have been filed with one or more states in  
21                  which the applicant is licensed as a provider or broker. The commissioner  
22                  may ask for evidence of financial responsibility at any time the commissioner  
23                  determines necessary. Any surety bond issued pursuant to this subdivision  
24                  must specifically authorize recovery by the commissioner on behalf of any  
25                  person in this state which sustained damages as the result of erroneous acts,  
26                  failure to act, conviction of fraud, or conviction of unfair practices by the  
27                  provider or broker.
- 28                  12. The commissioner may not issue any license to any nonresident applicant unless a  
29                  written designation of an agent for service of process is filed and maintained with  
30                  the commissioner or unless the applicant has filed with the commissioner the

1           applicant's written irrevocable consent that any action against the applicant may be  
2           commenced against the applicant by service of process on the commissioner.

3       13. Each licensee shall file with the commissioner before March first of each year an  
4           annual statement containing such information as the commissioner by rule may  
5           prescribe.

6       14. A provider may not use any person to perform the functions of a broker, as  
7           provided under this chapter, unless the person holds a current, valid license as a  
8           broker, and as provided in this section.

9       15. A broker may not use any person to perform the functions of a provider as defined  
10           in this chapter unless such person holds a current, valid license as a provider and  
11           as provided in this section.

12       16. A provider or broker shall provide to the commissioner new or revised information  
13           about officers, ten percent or more stockholders, partners, directors, members, or  
14           designated employees within thirty days of the change.

15       17. An individual licensed as a broker shall complete on a biennial basis fifteen hours  
16           of training related to life settlements and life settlement transactions as required by  
17           the commissioner; provided, however, that a life insurance producer who is  
18           operating as a broker pursuant to this section is not subject to the requirements of  
19           this subsection. Any person failing to meet the requirements of this subsection  
20           shall be subject to the penalties imposed by the commissioner.

21       **26.1-33.4-03. License suspension, revocation, or refusal to renew.**

22       1. The commissioner may suspend, revoke, or refuse to renew the license of any  
23           licensee if the commissioner finds that:

24           a. There was any material misrepresentation in the application for the license;

25           b. The licensee or any officer, partner, member, or director has been guilty of  
26           fraudulent or dishonest practices, is subject to a final administrative action, or  
27           is otherwise shown to be untrustworthy or incompetent to act as a licensee;

28           c. The provider demonstrates a pattern of unreasonably withholding payments  
29           to policyowners;

30           d. The licensee no longer meets the requirements for initial licensure;

- 1           e. The licensee or any officer, partner, member, or director has been convicted  
2           of a felony or of any misdemeanor of which criminal fraud is an element; or  
3           the licensee has pleaded guilty or nolo contendere with respect to any felony  
4           or any misdemeanor of which criminal fraud or moral turpitude is an element,  
5           regardless whether a judgment of conviction has been entered by the court;  
6           f. The provider has entered any life settlement contract that has not been  
7           approved pursuant to this chapter;  
8           g. The provider has failed to honor contractual obligations set out in a life  
9           settlement contract;  
10          h. The provider has assigned, transferred, or pledged a settled policy to a  
11          person other than a provider licensed in this state, a purchaser, an accredited  
12          investor or qualified institutional buyer as defined respectively in regulation D,  
13          rule 501 or rule 144A of the federal Securities Act of 1933, as amended [15  
14          U.S.C. 77a et seq.], financing entity, special purpose entity, or related  
15          provider trust; or  
16          i. The licensee or any officer, partner, member, or key management personnel  
17          has violated any of the provisions of this chapter.  
18          2. The commissioner may suspend, revoke, or refuse to renew the license of a broker  
19          if the commissioner finds that the broker has violated this chapter or has otherwise  
20          engaged in bad-faith conduct with one or more owners.  
21          3. Before the commissioner denies a license application or suspends, revokes, or  
22          refuses to renew the license of any licensee under this chapter, the commissioner  
23          shall conduct a hearing.

24          **26.1-33.4-04. Contract requirements.**

- 25          1. A person may not use any form of life settlement contract in this state unless the  
26          contract has been filed with and approved, if required, by the commissioner in a  
27          manner that conforms with the filing procedures and any time restrictions or  
28          deeming provisions, if any, for life insurance forms, policies, and contracts.  
29          2. An insurer may not require, as a condition of responding to a request for  
30          verification of coverage or in connection with the transfer of a policy pursuant to a  
31          life settlement contract, that the owner, insured, provider, or broker sign any form,



1           disclosure, consent, waiver, or acknowledgment that has not been expressly  
2           approved by the commissioner for use in connection with life settlement contracts  
3           in this state.

4           3. A person may not use a life settlement contract form or provide to an owner a  
5           disclosure statement form in this state unless first filed with and approved by the  
6           commissioner. The commissioner shall disapprove a life settlement contract form  
7           or disclosure statement form if, in the commissioner's opinion, the contract or  
8           provisions contained therein fail to meet the requirements of sections 26.1-33.4-07,  
9           26.1-33.4-08, and 26.1-33.4-10 and subsection 2 of section 26.1-33.4-14 or are  
10           unreasonable, contrary to the interests of the public, or otherwise misleading or  
11           unfair to the owner. The commissioner may require the submission of advertising  
12           material.

13           **26.1-33.4-05. Reporting requirements and privacy.**

14           1. For any policy settled within five years of policy issuance, each provider shall file  
15           with the commissioner before March first of each year an annual statement  
16           containing such information as the commissioner may prescribe by regulation. In  
17           addition to any other requirements, the annual statement must specify the total  
18           number, aggregate face amount, and life settlement proceeds of policies settled  
19           during the immediately preceding calendar year, together with a breakdown of the  
20           information by policy issue year. The annual statement also must include the  
21           names of the insurance companies whose policies have been settled and the  
22           brokers that have settled said policies.

23           a. Such information must be limited to only those transactions where the insured  
24           is a resident of this state and may not include individual transaction data  
25           regarding the business of life settlements or information that there is a  
26           reasonable basis to believe could be used to identify the owner or the  
27           insured.

28           b. Every provider that willfully fails to file an annual statement as required in this  
29           section, or willfully fails to reply within thirty days to a written inquiry by the  
30           commissioner in connection therewith, shall, in addition to other penalties  
31           provided by this chapter, be subject, upon due notice and opportunity to be

- 1                   heard, to a penalty of up to two hundred fifty dollars per day of delay, not to  
2                   exceed twenty-five thousand dollars in the aggregate, for each such failure.
- 3           2. Except as otherwise allowed or required by law, a provider, broker, insurance  
4           company, insurance producer, information bureau, rating agency or company, or  
5           any other person with actual knowledge of an insured's identity, may not disclose  
6           the identify of an insured or information that there is a reasonable basis to believe  
7           could be used to identify the insured or the insured's financial or medical  
8           information to any other person unless the disclosure:
- 9           a. Is necessary to effect a life settlement contract between the owner and a  
10           provider and the owner and insured have provided prior written consent to the  
11           disclosure;
- 12           b. Is necessary to effectuate the sale of life settlement contracts, or interests  
13           therein, as investments, provided the sale is conducted in accordance with  
14           applicable state and federal securities law, and provided further that the  
15           owner and the insured have both provided prior written consent to the  
16           disclosure;
- 17           c. Is provided in response to an investigation or examination by the  
18           commissioner or any other governmental officer or agency or pursuant to the  
19           requirements of section 26.1-33.4-12;
- 20           d. Is a term or condition to the transfer of a policy by one provider to another  
21           provider, in which case the receiving provider shall comply with the  
22           confidentiality requirements of subsection 2 of section 26.1-33.4-05;
- 23           e. Is necessary to allow the provider or broker or its authorized representative to  
24           make contacts for the purpose of determining health status. For the purposes  
25           of this section, the term "authorized representative" does not include any  
26           person that has or may have any financial interest in the settlement contract  
27           other than a provider, licensed broker, financing entity, related provider trust,  
28           or special purpose entity; further, a provider or broker shall require its  
29           authorized representative to agree in writing to adhere to the privacy  
30           provisions of this chapter; or
- 31           f. Is required to purchase stop-loss coverage.

1           3. Nonpublic personal information solicited or obtained in connection with a proposed  
2           or actual life settlement contract is subject to the provisions applicable to financial  
3           institutions under the federal Gramm Leach Bliley Act [Pub. L. 106-102] and all  
4           other state and federal laws relating to confidentiality of nonpublic personal  
5           information.

6           **26.1-33.4-06. Examination.**

7           1. The commissioner, when the commissioner deems it reasonably necessary to  
8           protect the interests of the public, may examine the business and affairs of any  
9           licensee or applicant for a license. The commissioner may order any licensee or  
10          applicant to produce any records, books, files, or other information reasonably  
11          necessary to ascertain whether such licensee or applicant is acting or has acted in  
12          violation of the law or otherwise contrary to the interests of the public. The  
13          expenses incurred in conducting any examination must be paid by the licensee or  
14          applicant.

15          2. In lieu of an examination under this chapter of any foreign or alien licensee  
16          licensed in this state, the commissioner may, at the commissioner's discretion,  
17          accept an examination report on the licensee as prepared by the commissioner for  
18          the licensee's state of domicile or port-of-entry state.

19          3. Names of and individual identification data for all owners and insureds must be  
20          considered private and confidential information and may not be disclosed by the  
21          commissioner unless required by law.

22          4. Records of all consummated transactions and life settlement contracts must be  
23          maintained by the provider for three years after the death of the insured and must  
24          be available to the commissioner for inspection during reasonable business hours.

25          5. a. Upon determining that an examination should be conducted, the  
26          commissioner shall issue an examination warrant appointing one or more  
27          examiners to perform the examination and instructing the examiners as to the  
28          scope of the examination. In conducting the examination, the examiner shall  
29          use methods common to the examination of any life settlement licensee and  
30          should use those guidelines and procedures set forth in an examiners'  
31          handbook adopted by a national organization.

- 1           b. Every licensee or person from whom information is sought, its officers,  
2           directors, and agents shall provide to the examiners timely, convenient, and  
3           free access at all reasonable hours at its offices to all books, records,  
4           accounts, papers, documents, assets, and computer or other recordings  
5           relating to the property, assets, business, and affairs of the licensee being  
6           examined. The officers, directors, employees, and agents of the licensee or  
7           person shall facilitate the examination and aid in the examination so far as it  
8           is in their power to do so. The refusal of a licensee, by its officers, directors,  
9           employees, or agents, to submit to examination or to comply with any  
10           reasonable written request of the commissioner is grounds for suspension or  
11           refusal of, or nonrenewal of any license or authority held by the licensee to  
12           engage in the life settlement business or other business subject to the  
13           commissioner's jurisdiction. Any proceedings for suspension, revocation, or  
14           refusal of any license or authority must be conducted pursuant to section  
15           26.1-01-03.1.
- 16           c. The commissioner may issue subpoenas, administer oaths, and examine  
17           under oath any person as to any matter pertinent to the examination. Upon  
18           the failure or refusal of a person to obey a subpoena, the commissioner may  
19           petition a court of competent jurisdiction, and upon proper showing, the court  
20           may enter an order compelling the witness to appear and testify or produce  
21           documentary evidence.
- 22           d. When making an examination under this chapter, the commissioner may  
23           retain attorneys, appraisers, independent actuaries, independent certified  
24           public accountants, or other professionals and specialists as examiners, the  
25           reasonable cost of which must be borne by the licensee that is the subject of  
26           the examination.
- 27           e. This chapter does not limit the commissioner's authority to terminate or  
28           suspend an examination in order to pursue other legal or regulatory action  
29           pursuant to the insurance laws of this state. Findings of fact and conclusions  
30           made pursuant to any examination are prima facie evidence in any legal or  
31           regulatory action.

- 1           f. This chapter does not limit the commissioner's authority to use and, if  
2           appropriate, to make public any final or preliminary examination report, any  
3           examiner or licensee workpapers, or other documents, or any other  
4           information discovered or developed during the course of any examination in  
5           the furtherance of any legal or regulatory action which the commissioner  
6           determines appropriate.
- 7           6. a. Examination reports must be composed of only facts appearing upon the  
8           books, from the testimony of its officers or agents, or other persons examined  
9           concerning its affairs, and such conclusions and recommendations as the  
10           examiners find reasonably warranted from the facts.
- 11           b. No later than sixty days following completion of the examination, the examiner  
12           in charge shall file with the commissioner a verified written report of  
13           examination under oath. Upon receipt of the verified report, the  
14           commissioner shall transmit the report to the licensee examined, together  
15           with a notice that shall afford the licensee examined a reasonable opportunity  
16           of not more than thirty days to make a written submission or rebuttal with  
17           respect to any matters contained in the examination report and which shall  
18           become part of the report or to request a hearing on any matter in dispute.
- 19           c. If the commissioner determines that regulatory action is appropriate as a  
20           result of an examination, the commissioner may initiate any proceedings or  
21           actions provided by law.
- 22           7. a. Names and individual identification data for all owners, purchasers, and  
23           insureds must be considered private and confidential information and may  
24           not be disclosed by the commissioner, unless the disclosure is to another  
25           regulator, is required under law, or is allowed under section 26.1-03-19.4.
- 26           b. Except as otherwise provided in this chapter, all examination reports, working  
27           papers, recorded information, documents, and copies thereof produced by,  
28           obtained by, or disclosed to the commissioner or any other person in the  
29           course of an examination made under this chapter, or in the course of  
30           analysis or investigation by the commissioner of the financial condition or  
31           market conduct of a licensee must be confidential by law and privileged, is not

1           subject to the state's open records laws, is not subject to subpoena, and is  
2           not subject to discovery or admissible in evidence in any private civil action.  
3           The commissioner may use the documents, materials, or other information in  
4           the furtherance of any regulatory or legal action brought as part of the  
5           commissioner's official duties. The licensee being examined may have  
6           access to all documents used to make the report.

7           8.    a.   An examiner may not be appointed by the commissioner if the examiner,  
8           either directly or indirectly, has a conflict of interest or is affiliated with the  
9           management of or owns a pecuniary interest in any person subject to  
10          examination under this chapter. This section may not be construed to  
11          automatically preclude an examiner from being:

12           (1)   An owner;

13           (2)   An insured in a life settlement contract or insurance policy; or

14           (3)   A beneficiary in an insurance policy that is proposed for a life  
15           settlement contract.

16           b.   Notwithstanding the requirements of this subsection, the commissioner may  
17           retain from time to time, on an individual basis, qualified actuaries, certified  
18           public accountants, or other similar individuals who are independently  
19           practicing their professions, even though these persons may from time to time  
20           be similarly employed or retained by persons subject to examination under  
21           this chapter.

22          9.    a.   No cause of action arises nor may any liability be imposed against the  
23           commissioner, the commissioner's authorized representatives, or any  
24           examiner appointed by the commissioner for any statements made or conduct  
25           performed in good faith while carrying out this chapter.

26           b.   No cause of action arises, nor may any liability be imposed against any  
27           person for the act of communicating or delivering information or data to the  
28           commissioner or the commissioner's authorized representative or examiner  
29           pursuant to an examination made under this chapter, if the act of  
30           communication or delivery was performed in good faith and without fraudulent  
31           intent or the intent to deceive. This subdivision does not abrogate or modify

1                   in any way any common law or statutory privilege or immunity heretofore  
2                   enjoyed by any person identified in subdivision a.  
3                   c. A person identified in subdivision a or b is entitled to an award of attorney's  
4                   fees and costs if the person is the prevailing party in a civil cause of action for  
5                   libel, slander, or any other relevant tort arising out of activities in carrying out  
6                   the provisions of this chapter and the party bringing the action was not  
7                   substantially justified in doing so. For purposes of this section a proceeding is  
8                   "substantially justified" if it had a reasonable basis in law or fact at the time  
9                   that it was initiated.

10                  10. The commissioner may investigate suspected fraudulent life settlement acts and  
11                   persons engaged in the business of life settlements.

12                  11. The commissioner may charge for examinations as provided for under section  
13                   26.1-01-07.

14                  **26.1-33.4-07. Advertising.**

15                  1. A broker or provider licensed pursuant to this chapter may conduct or participate in  
16                   advertisements within this state. Advertisements must comply with all advertising  
17                   and marketing laws or rules adopted by the commissioner which are applicable to  
18                   life insurers or to brokers and providers licensed pursuant to this chapter.

19                  2. Advertisements must be accurate and truthful, and may not be misleading in fact  
20                   or by implication.

21                  3. A person or trust may not:

22                   a. Directly or indirectly, market, advertise, solicit, or otherwise promote the  
23                   purchase of a policy for the sole purpose of or with an emphasis on settling  
24                   the policy; or

25                   b. Use the words "free" or "no cost" or words of similar import in the marketing,  
26                   advertising, soliciting, or otherwise promoting of the purchase of a policy.

27                  **26.1-33.4-08. Disclosures to owners.**

28                  1. The provider shall provide in writing, in a separate document that is signed by the  
29                   owner and provider, the following information to the owner no later than the date  
30                   the life settlement contract is signed by all parties:

- 1           a. The fact that possible alternatives to life settlement contracts exist, including  
2           accelerated benefits offered by the issuer of the life insurance policy.
- 3           b. The fact that some or all of the proceeds of a life settlement contract may be  
4           taxable and that assistance should be sought from a professional tax adviser.
- 5           c. The fact that the proceeds from a life settlement contract could be subject to  
6           the claims of creditors.
- 7           d. The fact that receipt of proceeds from a life settlement contract may adversely  
8           affect the recipient's eligibility for public assistance or other government  
9           benefits or entitlements and that advice should be obtained from the  
10           appropriate agencies.
- 11          e. The fact the owner has the right to rescind a life settlement contract before  
12           the earlier of sixty calendar days after the date upon which the life settlement  
13           contract is executed by all parties or thirty calendar days after the life  
14           settlement proceeds have been delivered to the escrow agent by or on behalf  
15           of the provider as provided in subsection 11 of section 26.1-33.4-10.  
16           Rescission, if exercised by the owner, is effective only if both notice of the  
17           rescission is given and the owner repays all proceeds and any premiums,  
18           loans, and loan interest paid on account of the provider within the rescission  
19           period. If the insured dies during the rescission period, the contract is  
20           deemed to have been rescinded subject to repayment by the owner or the  
21           owner's estate of all proceeds and any premiums, loans, and loan interest to  
22           the provider.
- 23          f. The fact that proceeds will be sent to the owner within three business days  
24           after the provider has received the insurer or group administrator's  
25           acknowledgement that ownership of the policy or interest in the certificate has  
26           been transferred and the beneficiary has been designated in accordance with  
27           the terms of the life settlement contract.
- 28          g. The fact that entering into a life settlement contract may cause other rights or  
29           benefits, including conversion rights and waiver of premium benefits, that may  
30           exist under the policy or certificate of a group policy to be forfeited by the



- 1                   owner and that assistance should be sought from a professional financial  
2                   adviser.
- 3           h.   The amount and method of calculating the compensation paid or to be paid to  
4                   the broker, or any other person acting for the owner in connection with the  
5                   transaction, wherein the term compensation includes anything of value paid  
6                   or given.
- 7           i.   The date by which the funds will be available to the owner and the transmitter  
8                   of the funds.
- 9           j.   The fact that the commissioner shall require delivery of a buyer's guide or a  
10                   similar consumer advisory package in the form prescribed by the  
11                   commissioner to owners during the solicitation process.
- 12           k.   The disclosure document must contain the following language:
- 13                   All medical, financial, or personal information solicited or obtained by a  
14                   provider or broker about an insured, including the insured's identity or  
15                   the identity of family members, a spouse, or a significant other may be  
16                   disclosed as necessary to effect the life settlement contract between  
17                   the owner and provider. If you are asked to provide this information,  
18                   you will be asked to consent to the disclosure. The information may be  
19                   provided to someone who buys the policy or provides funds for the  
20                   purchase. You may be asked to renew your permission to share  
21                   information every two years.
- 22           l.   The fact that the commissioner shall require providers and brokers to print  
23                   separate signed fraud warnings on their applications and on their life  
24                   settlement contracts the following statement:
- 25                   Any person that knowingly presents false information in an application  
26                   for insurance or life settlement contract is guilty of a crime and may be  
27                   subject to fines and confinement in prison.
- 28           m.   The fact that the insured may be contacted by either the provider or broker or  
29                   its authorized representative for the purpose of determining the insured's  
30                   health status or to verify the insured's address. This contact is limited to once  
31                   every three months if the insured has a life expectancy of more than one

- 1                   year, and no more than once per month if the insured has a life expectancy of  
2                   one year or less. This contact may be made only by a provider or broker  
3                   licensed in the state in which the owner resided at the time of the settlement  
4                   or by the authorized representative of such a provider or broker.
- 5           n.   The affiliation, if any, between the provider and the issuer of the insurance  
6                   policy to be settled.
- 7           o.   That a broker represents exclusively the owner, and not the insurer or the  
8                   provider or any other person, and owes a fiduciary duty to the owner,  
9                   including a duty to act according to the owner's instructions and in the best  
10                   interest of the owner.
- 11           p.   The document must include the name, address, and telephone number of the  
12                   provider.
- 13           q.   The name, business address, and telephone number of the independent  
14                   third-party escrow agent, and the fact that the owner may inspect or receive  
15                   copies of the relevant escrow or trust agreements or documents.
- 16           r.   The fact that a change of ownership could in the future limit the insured's  
17                   ability to purchase future insurance on the insured's life because there is a  
18                   limit to how much coverage insurers will issue on one life.
- 19           s.   If an insurance policy to be settled has been issued as a joint policy or  
20                   involves family riders or any coverage of a life other than the insured under  
21                   the policy to be settled, that the owner must be informed of the possible loss  
22                   of coverage on the other lives under the policy and must be advised to  
23                   consult with the owner's insurance producer or the insurer issuing the policy  
24                   for advice on the proposed settlement.
- 25           t.   The dollar amount of the current death benefit payable to the provider under  
26                   the policy or certificate. If known, the provider also shall disclose the  
27                   availability of any additional guaranteed insurance benefits, the dollar amount  
28                   of any accidental death and dismemberment benefits under the policy or  
29                   certificate, and the extent to which the owner's interest in those benefits will  
30                   be transferred as a result of the viatical settlement contract.

- 1           u. Any affiliations or contractual arrangements between the provider and the  
2           purchaser.
- 3           2. The written disclosures must be conspicuously displayed in any life settlement  
4           contract furnished to the owner by a provider, including any affiliations or  
5           contractual arrangements between the provider and the broker.
- 6           3. A broker shall provide the owner and the provider with at least the following  
7           disclosures no later than the date the life settlement contract is signed by all  
8           parties. The disclosures must be conspicuously displayed in the life settlement  
9           contract or in a separate document signed by the owner and provide the following  
10           information:
- 11           a. The name, business address, and telephone number of the broker.
- 12           b. A full, complete, and accurate description of all the offers, counteroffers,  
13           acceptances, and rejections relating to the proposed life settlement contract.
- 14           c. A written disclosure of any affiliations or contractual arrangements between  
15           the broker and any person making an offer in connection with the proposed  
16           life settlement contracts.
- 17           d. The name of each broker who receives compensation and the amount of  
18           compensation received by that broker, which compensation includes anything  
19           of value paid or given to the broker in connection with the life settlement  
20           contract.
- 21           e. A complete reconciliation of the gross offer or bid by the provider to the net  
22           amount of proceeds or value to be received by the owner. For the purpose of  
23           this section, gross offer or bid means the total amount or value offered by the  
24           provider for the purchase of one or more life insurance policies, inclusive of  
25           commissions and fees.
- 26           f. The failure to provide the disclosures or rights described in this section is  
27           deemed an unfair trade practice pursuant to section 26.1-33.4-16.

28           **26.1-33.4-09. Disclosure to insurer.** Without limiting the ability of an insurer from  
29           assessing the insurability of a policy applicant and determining whether to issue the policy, and  
30           in addition to other questions an insurance carrier may lawfully pose to a life insurance  
31           applicant, insurance carriers may inquire in the application for insurance whether the proposed

1 owner intends to pay premiums with the assistance of financing from a lender that will use the  
2 policy as collateral to support the financing.

3 1. If, as described in subsection 11 of section 26.1-33.4-01, the loan provides funds  
4 that can be used for a purpose other than paying for the premiums, costs, and  
5 expenses associated with obtaining and maintaining the life insurance policy and  
6 loan, the application must be rejected as a violation of the prohibited practices in  
7 section 26.1-33.4-12.

8 2. If the financing does not violate section 26.1-33.4-12 in this manner, the insurance  
9 carrier:

10 a. May make disclosures, such as the following, to the applicant and the  
11 insured, either on the application or an amendment to the application to be  
12 completed no later than the delivery of the policy: "If you have entered a loan  
13 arrangement where the policy is used as collateral, and the policy does  
14 change ownership at some point in the future in satisfaction of the loan, the  
15 following may be true:

16 (1) A change of ownership could lead to a stranger owning an interest in  
17 the insured's life;

18 (2) A change of ownership could in the future limit your ability to purchase  
19 future insurance on the insured's life because there is a limit to how  
20 much coverage insurers will issue on one life;

21 (3) Should there be a change of ownership and you wish to obtain more  
22 insurance coverage on the insured's life in the future, the insured's  
23 higher issue age, a change in health status, and other factors may  
24 reduce the ability to obtain coverage and may result in significantly  
25 higher premiums; and

26 (4) You should consult a professional adviser, since a change in ownership  
27 in satisfaction of the loan may result in tax consequences to the owner,  
28 depending on the structure of the loan;" and

29 b. May require certifications, such as the following, from the applicant or the  
30 insured or both:

1                   I have entered into any agreement or arrangement providing for  
2                   the future sale of this life insurance policy;

3                   My loan arrangement for this policy provides funds sufficient to  
4                   pay for some or all of the premiums, costs, and expenses associated  
5                   with obtaining and maintaining my life insurance policy, but I have not  
6                   entered into any agreement by which I am to receive consideration in  
7                   exchange for procuring this policy; and

8                   The borrower has an insurable interest in the insured.

9                   **26.1-33.4-10. General rules.**

- 10                  1. A provider entering a life settlement contract with any owner of a policy, wherein  
11                  the insured is terminally or chronically ill, first shall obtain:
- 12                  a. If the owner is the insured, a written statement from a licensed attending  
13                  physician that the owner is of sound mind and under no constraint or undue  
14                  influence to enter into a settlement contract; and
- 15                  b. A document in which the insured consents to the release of the insured's  
16                  medical records to a provider, settlement broker, or insurance producer and, if  
17                  the policy was issued less than two years from the date of application for a  
18                  settlement contract, to the insurance company that issued the policy.
- 19                  2. The insurer shall respond to a request for verification of coverage submitted by a  
20                  provider, settlement broker, or life insurance producer not later than thirty calendar  
21                  days from the date the request is received. The request for verification of  
22                  coverage must be made on a form approved by the commissioner. The insurer  
23                  shall complete and issue the verification of coverage or indicate in which respects  
24                  it is unable to respond. In its response, the insurer shall indicate whether, based  
25                  on the medical evidence and documents provided, the insurer intends to pursue an  
26                  investigation at this time regarding the validity of the insurance contract.
- 27                  3. Before or at the time of execution of the settlement contract, the provider shall  
28                  obtain a witnessed document in which the owner consents to the settlement  
29                  contract, represents that the owner has a full and complete understanding of the  
30                  settlement contract, that the owner has a full and complete understanding of the  
31                  benefits of the policy, acknowledges that the owner is entering into the settlement

- 1           contract freely and voluntarily, and, for persons with a terminal or chronic illness or  
2           condition, acknowledges that the insured has a terminal or chronic illness and that  
3           the terminal or chronic illness or condition was diagnosed after the policy was  
4           issued.
- 5           4. The insurer may not unreasonably delay effecting change of ownership or  
6           beneficiary with any life settlement contract lawfully entered in this state or with a  
7           resident of this state.
- 8           5. If a settlement broker or life insurance producer performs any of these activities  
9           required of the provider, the provider is deemed to have fulfilled the requirements  
10           of this section.
- 11           6. If a broker performs the verification of coverage activities required of the provider,  
12           the provider is deemed to have fulfilled the requirements of subsection 1 of section  
13           26.1-33.4-08.
- 14           7. Within twenty days after an owner executes the life settlement contract, the  
15           provider shall give written notice to the insurer that issued that insurance policy  
16           that the policy has become subject to a life settlement contract. The notice must  
17           be accompanied by the documents required by subdivision b of subsection 1 of  
18           section 26.1-33.4-09.
- 19           8. All medical information solicited or obtained by any licensee must be subject to the  
20           applicable provision of state law relating to confidentiality of medical information if  
21           not otherwise provided in this chapter.
- 22           9. All life settlement contracts entered in this state must provide the owner with a right  
23           to rescind the contract before the earlier of sixty calendar days after the date upon  
24           which the life settlement contract is executed by all parties or thirty calendar days  
25           after the life settlement proceeds have been sent to the escrow agent by or on  
26           behalf of the provider as provided in subsection 11. Rescission by the owner may  
27           be conditioned upon the owner giving notice and repaying to the provider within  
28           the rescission period all proceeds of the settlement and any premiums, loans, and  
29           loan interest paid by or on behalf of the provider in connection with or as a  
30           consequence of the life settlement. If the insured dies during the rescission period,  
31           the life settlement contract is deemed to have been rescinded, subject to

- 1           repayment to the provider or purchaser of all life settlement proceeds and any  
2           premiums, loans, and loan interest that have been paid by the provider or  
3           purchaser, within sixty calendar days of the death of the insured. In the event of  
4           any rescission, if the provider has paid commissions or other compensation to a  
5           broker in connection with the rescinded transaction, the broker shall refund all the  
6           commissions and compensation to the provider within five business days following  
7           receipt of written demand from the provider, which demand must be accompanied  
8           by either the owner's notice of rescission if rescinded at the election of the owner  
9           or notice of the death of the insured if rescinded by reason of the death of the  
10           insured within the applicable rescission period.
- 11        10. Within three business days after receipt from the owner of documents to effect the  
12        transfer of the insurance policy, the provider shall pay the proceeds of the  
13        settlement to an escrow or trust account managed by a trustee or escrow agent in  
14        a state or federally chartered financial institution pending acknowledgment of the  
15        transfer by the issuer of the policy. The trustee or escrow agent must be required  
16        to transfer the proceeds due to the owner within three business days of the later to  
17        occur of the expiration of any then remaining rescission period or the escrow  
18        agent's receipt of the acknowledgment of the properly completed transfer of  
19        ownership, assignment, or designation of beneficiary from the insurance company.
- 20        11. Failure to tender the life settlement contract proceeds to the owner by the date  
21        disclosed to the owner renders the contract voidable by the owner for lack of  
22        consideration until the time the proceeds are tendered to and accepted by the  
23        owner. A failure to give written notice of the right of rescission tolls the right of  
24        rescission until sixty days after the written notice of the right of rescission has been  
25        given.
- 26        12. Any fee paid by a provider, party, individual, or an owner to a broker in exchange  
27        for services provided to the owner pertaining to a life settlement contract must be  
28        computed as a percentage of the offer obtained, not the face value of the policy.  
29        This section does not prohibit a broker from reducing such broker's fee below this  
30        percentage if the broker so chooses.

- 1           13. The broker shall disclose to the owner anything of value paid or given to a broker  
2           which relates to a life settlement contract.
- 3           14. It is a violation of this chapter for any person to enter a life settlement contract at  
4           any time before or at the time of the application for or issuance of a policy that is  
5           the subject of a life settlement contract or within a five-year period commencing  
6           with the date of issuance of the insurance policy or certificate unless the owner  
7           certifies to the provider or the provider otherwise conclusively shows that one or  
8           more of the following conditions have been met within the five-year period:
- 9           a. The policy was issued upon the owner's exercise of conversion rights arising  
10           out of a group or individual policy, provided the total of the time covered under  
11           the conversion policy plus the time covered under the prior policy is at least  
12           sixty months. The time covered under a group policy must be calculated  
13           without regard to any change in insurance carriers, provided the coverage  
14           has been continuous and under the same group sponsorship;
- 15           b. The owner submitted independent evidence to the provider that one or more  
16           of the following conditions have been met within the five-year period:
- 17               (1) The owner or insured is terminally or chronically ill;  
18               (2) The owner's spouse died or no remaining beneficiaries are then  
19               surviving;  
20               (3) The owner retired from full-time employment; or  
21               (4) The owner became physically or mentally disabled and a physician  
22               determined that the disability prevents the owner from maintaining  
23               full-time employment;
- 24           c. A final order, judgment, or decree has been entered by a court of competent  
25           jurisdiction, on the application of a creditor of the owner, adjudicating the  
26           owner in default, bankrupt, or insolvent, or approving a petition seeking  
27           reorganization of the owner or appointing a receiver, trustee, or liquidator to  
28           all or a substantial part of the owner's assets; or
- 29           d. The owner entered a life settlement contract more than two years after the  
30           date of issuance of a policy and, with respect to the policy, at all times before



1           the date that is two years after policy issuance, the following conditions are  
2           met:  
3           (1) Policy premiums have been funded exclusively with unencumbered  
4           assets, including an interest in the life insurance policy being financed  
5           only to the extent of the policy's net cash surrender value, provided by,  
6           or fully recourse liability incurred by, the insured or a person described  
7           in paragraph 5 of subdivision b of subsection 11 of section  
8           26.1-33.4-01;  
9           (2) There is no agreement or understanding with any other person to  
10           guarantee any such liability or to purchase, or stand ready to purchase,  
11           the policy, including through an assumption or forgiveness of the loan;  
12           and  
13           (3) Neither the insured nor the policy has been evaluated for settlement in  
14           connection with the issuance of the policy.

15       15. Copies of the independent evidence described in subdivision b of subsection 14  
16       and documents required by subsection 1, 2, 3, or 7 must be submitted to the  
17       insurer when the provider submits a request to the insurer for verification of  
18       coverage. The copies must be accompanied by a letter of attestation from the  
19       provider that the copies are true and correct copies of the documents received by  
20       the provider.

21       16. If the provider submits to the insurer a copy of the owner's or insured's certification  
22       described in and the independent evidence required by subdivision b of  
23       subsection 14 when the provider submits a request to the insurer to effect the  
24       transfer of the policy or certificate to the provider, the copy is deemed to establish  
25       conclusively that the life settlement contract satisfies the requirements of this  
26       section and the insurer timely shall respond to the request.

27       **26.1-33.4-11. Authority to adopt regulations - Conflict of laws.**

28       1. The commissioner may adopt rules implementing this chapter and regulating the  
29       activities and relationships of providers, brokers, and insurers and their agents.  
30       2. The commissioner may establish standards for evaluating reasonableness of a  
31       payment under a life settlement contract for an individual who is terminally or

- 1           chronically ill. This authority includes regulation of discount rates used to  
2           determine the amount paid in exchange for assignment, transfer, sale, devise, or  
3           bequest of a benefit under a life insurance policy insuring the life of an individual  
4           who is chronically or terminally ill.
- 5           3.   The commissioner may establish appropriate licensing requirements, fees, and  
6           standards for continued licensure for providers and brokers.
- 7           4.   a.   If there is more than one owner on a single policy and the owners are  
8           residents of different states, the life settlement contract must be governed by  
9           the law of the state in which the owner having the largest percentage  
10           ownership resides, or if the owners hold equal ownership, the state of  
11           residence of one owner agreed upon in writing by all of the owners. The law  
12           of the state of the insured governs if equal owners fail to agree in writing upon  
13           a state of residence for jurisdictional purposes.
- 14           b.   A provider from this state who enters a life settlement contract with an owner  
15           who is a resident of another state that has enacted statutes or adopted  
16           regulations governing life settlement contracts is governed in the effectuation  
17           of that life settlement contract by the statutes and regulations of the owner's  
18           state of residence. If the state in which the owner is a resident has not  
19           enacted statutes or regulations governing life settlement contracts, the  
20           provider shall give the owner notice that neither state regulates the  
21           transaction upon which the owner is entering. For transactions in those  
22           states, however, the provider is to maintain all records required if the  
23           transactions were executed in the state of residence. The forms used in  
24           those states need not be approved by the commissioner.
- 25           c.   If there is a conflict in the laws that apply to an owner and a purchaser in any  
26           individual transaction, the laws of the state that apply to the owner shall take  
27           precedence and the provider shall comply with those laws.

28           **26.1-33.4-12. Prohibited practices.**

- 29           1.   It is unlawful for any person to:

- 1           a. Enter a life settlement contract if such person knows or reasonably should  
2           have known that the life insurance policy was obtained by means of a false,  
3           deceptive, or misleading application for such policy;
- 4           b. Engage in any transaction, practice, or course of business if such person  
5           knows or reasonably should have known that the intent was to avoid the  
6           notice requirements of this chapter;
- 7           c. Engage in any fraudulent act or practice in connection with any transaction  
8           relating to any settlement involving an owner who is a resident of this state;
- 9           d. Issue, solicit, market, or otherwise promote the purchase of an insurance  
10          policy for the purpose of or with an emphasis on settling the policy;
- 11          e. Enter a premium finance agreement with any person or agency, or any  
12          person affiliated with such person or agency, pursuant to which such person  
13          shall receive any proceeds, fees, or other consideration, directly or indirectly,  
14          from the policy or owner of the policy or any other person with respect to the  
15          premium finance agreement or any settlement contract or other transaction  
16          related to such policy that are in addition to the amounts required to pay the  
17          principal, interest, and service charges related to policy premiums pursuant to  
18          the premium finance agreement or subsequent sale of such agreement;  
19          provided, further, that any payments, charges, fees, or other amounts in  
20          addition to the amounts required to pay the principal, interest, and service  
21          charges related to policy premiums paid under the premium finance  
22          agreement must be remitted to the original owner of the policy or to the  
23          original owner's estate if the original owner is not living at the time of the  
24          determination of the overpayment;
- 25          f. With respect to any settlement contract or insurance policy and a broker,  
26          knowingly solicit an offer from, effectuate a life settlement contract with, or  
27          make a sale to any provider, financing entity, or related provider trust that is  
28          controlling, controlled by, or under common control with such broker;
- 29          g. With respect to any life settlement contract or insurance policy and a provider,  
30          knowingly enter into a life settlement contract with an owner, if, in connection  
31          with such life settlement contract, anything of value will be paid to a broker

1           that is controlling, controlled by, or under common control with such provider  
2           or the financing entity or related provider trust that is involved in such  
3           settlement contract;

4           h. With respect to a provider, enter into a life settlement contract unless the life  
5           settlement promotional, advertising, and marketing materials, as may be  
6           prescribed by regulation, have been filed with the commissioner. In no event  
7           may any marketing materials expressly reference that the insurance is "free"  
8           for any period of time. The inclusion of any reference in the marketing  
9           materials that would cause an owner to reasonably believe that the insurance  
10           is free for any period of time must be considered a violation of this chapter; or

11           i. With respect to any life insurance producer, insurance company, broker, or  
12           provider, make any statement or representation to the applicant or  
13           policyholder in connection with the sale or financing of a life insurance policy  
14           to the effect that the insurance is free or without cost to the policyholder for  
15           any period of time unless provided in the policy.

16           2. A violation of this section is deemed a fraudulent life settlement act.

17           **26.1-33.4-13. Fraud prevention and control.**

18           1. a. A person may not commit a fraudulent life settlement act.

19           b. A person may not knowingly and intentionally interfere with the enforcement  
20           of the provisions of this chapter or investigations of suspected or actual  
21           violations of this chapter.

22           c. A person in the business of life settlements may not knowingly or intentionally  
23           permit any person convicted of a felony involving dishonesty or breach of trust  
24           to participate in the business of life settlements.

25           2. a. Life settlement contracts and applications for life settlement contracts,  
26           regardless of the form of transmission, must contain the following statement  
27           or a substantially similar statement:

28                   Any person that knowingly presents false information in an application  
29                   for insurance or life settlement contract is guilty of a crime and may be  
30                   subject to fines and confinement in prison.

- 1           b. The lack of a statement as required in subdivision a does not constitute a  
2           defense in any prosecution for a fraudulent life settlement act.
- 3           3. a. Any person engaged in the business of life settlements having knowledge or  
4           a reasonable belief that a fraudulent life settlement act is being, will be, or has  
5           been committed shall provide to the commissioner the information required by  
6           and in a manner prescribed by the commissioner.
- 7           b. Any other person having knowledge or a reasonable belief that a fraudulent  
8           life settlement act is being, will be, or has been committed may provide to the  
9           commissioner the information required by and in a manner prescribed by the  
10           commissioner.
- 11          4. a. Civil liability may not be imposed on and no cause of action may arise from a  
12          person's furnishing information concerning suspected, anticipated, or  
13          completed fraudulent life settlement acts or suspected or completed  
14          fraudulent insurance acts if the information is provided to or received from:
- 15               (1) The commissioner or the commissioner's employees, agents, or  
16               representatives;
- 17               (2) Federal, state, or local law enforcement or regulatory officials or their  
18               employees, agents, or representatives;
- 19               (3) A person involved in the prevention and detection of fraudulent life  
20               settlement acts or that person's agents, employees, or representatives;
- 21               (4) Any regulatory body or its employees, agents, or representatives  
22               overseeing life insurance, life settlements, securities, or investment  
23               fraud;
- 24               (5) The life insurer that issued the life insurance policy covering the life of  
25               the insured; or
- 26               (6) The licensee and any agents, employees, or representatives.
- 27          b. Subdivision a does not apply to statements made with actual malice. In an  
28          action brought against a person for filing a report or furnishing other  
29          information concerning a fraudulent life settlement act or a fraudulent  
30          insurance act, the party bringing the action shall plead specifically any

- 1                   allegation that subdivision a does not apply because the person filing the  
2                   report or furnishing the information did so with actual malice.
- 3                   c. A person identified in subdivision a is entitled to an award of attorney's fees  
4                   and costs if that person is the prevailing party in a civil cause of action for  
5                   libel, slander, or any other relevant tort arising out of activities in carrying out  
6                   the provisions of this chapter and the party bringing the action was not  
7                   substantially justified in doing so. For purposes of this section, a proceeding  
8                   is "substantially justified" if the proceeding had a reasonable basis in law or  
9                   fact at the time the proceeding was initiated.
- 10                  d. This section does not abrogate or modify common law or statutory privileges  
11                  or immunities enjoyed by a person described in subdivision a.
- 12                  5. a. The documents and evidence provided pursuant to subsection 4 or obtained  
13                  by the commissioner in an investigation of suspected or actual fraudulent life  
14                  settlement acts is privileged and confidential and may not be a public record  
15                  and may not be subject to discovery or subpoena in a civil or criminal action.
- 16                  b. Subdivision a does not prohibit release by the commissioner of documents  
17                  and evidence obtained in an investigation of suspected or actual fraudulent  
18                  life settlement acts:
- 19                    (1) In administrative or judicial proceedings to enforce laws administered  
20                    by the commissioner;
- 21                    (2) To federal, state, or local law enforcement or regulatory agencies, to an  
22                    organization established for the purpose of detecting and preventing  
23                    fraudulent life settlement acts, or to the national association of  
24                    insurance commissioners; or
- 25                    (3) At the discretion of the commissioner, to a person in the business of life  
26                    settlements that is aggrieved by a fraudulent life settlement act.
- 27                  c. Release of documents and evidence under subdivision b does not abrogate  
28                  or modify the privilege granted in subdivision a.
- 29                  6. This chapter does not:

- 1           a. Preempt the authority or relieve the duty of other law enforcement or  
2           regulatory agencies to investigate, examine, and prosecute suspected  
3           violations of law;
- 4           b. Preempt, supersede, or limit any provision of any state securities law or any  
5           rule, order, or notice issued thereunder;
- 6           c. Prevent or prohibit a person from disclosing voluntarily information concerning  
7           life settlement fraud to a law enforcement or regulatory agency other than the  
8           insurance department; or
- 9           d. Limit the powers granted elsewhere by the laws of this state to the  
10           commissioner or an insurance fraud unit to investigate and examine possible  
11           violations of law and to take appropriate action against wrongdoers.
- 12        7. a. Providers and brokers shall have in place antifraud initiatives reasonably  
13           calculated to detect, prosecute, and prevent fraudulent life settlement acts.  
14           The commissioner may order, or a licensee may request and the  
15           commissioner may grant, such modifications of the following required  
16           initiatives as necessary to ensure an effective antifraud program. The  
17           modifications may be more or less restrictive than the required initiatives so  
18           long as the modifications may reasonably be expected to accomplish the  
19           purpose of this section. Antifraud initiatives include:
- 20           (1) Fraud investigators, who may be provider or broker employees or  
21           independent contractors; and
- 22           (2) An antifraud plan, which must be submitted to the commissioner. The  
23           antifraud plan must include:
- 24           (a) A description of the procedures for detecting and investigating  
25           possible fraudulent life settlement acts and procedures for  
26           resolving material inconsistencies between medical records and  
27           insurance applications;
- 28           (b) A description of the procedures for reporting possible fraudulent  
29           life settlement acts to the commissioner;
- 30           (c) A description of the plan for antifraud education and training of  
31           underwriters and other personnel; and

1                   (d) A description or chart outlining the organizational arrangement of  
2                   the antifraud personnel who are responsible for the investigation  
3                   and reporting of possible fraudulent life settlement acts and  
4                   investigating unresolved material inconsistencies between  
5                   medical records and insurance applications.

6                   b. Antifraud plans submitted to the commissioner are privileged and confidential  
7                   and are not a public record and may not be subject to discovery or subpoena  
8                   in a civil or criminal action.

9                   **26.1-33.4-14. Injunctions - Civil remedies - Cease and desist.**

10                  1. In addition to the penalties and other enforcement provisions of this chapter, if any  
11                  person violates this chapter or any rule implementing this chapter, the  
12                  commissioner may seek an injunction in a court of competent jurisdiction in the  
13                  county where the person resides or has a principal place of business and may  
14                  apply for temporary and permanent orders that the commissioner determines  
15                  necessary to restrain the person from further committing the violation.

16                  2. Any person damaged by the acts of another person in violation of this chapter or  
17                  any rule or regulation implementing this chapter may bring a civil action for  
18                  damages against the person committing the violation in a court of competent  
19                  jurisdiction.

20                  3. The commissioner may issue a cease and desist order upon a person that violates  
21                  any provision of this part, any rule or order adopted by the commissioner, or any  
22                  written agreement entered into with the commissioner in accordance with chapter  
23                  28-32.

24                  4. When the commissioner finds that such an action presents an immediate danger to  
25                  the public and requires an immediate final order, the commissioner may issue an  
26                  emergency cease and desist order reciting with particularity the facts underlying  
27                  such findings. The emergency cease and desist order is effective immediately  
28                  upon service of a copy of the order on the respondent and remains effective for  
29                  ninety days. If the commissioner begins nonemergency cease and desist  
30                  proceedings under subsection 1, the emergency cease and desist order remains  
31                  effective, absent an order by an appellate court of competent jurisdiction pursuant



1           to chapter 28-32. In the event of a willful violation of this chapter, the trial court  
2           may award statutory damages in addition to actual damages in an additional  
3           amount up to three times the actual damage award. The provisions of this chapter  
4           may not be waived by agreement. A choice of law provision may not be utilized to  
5           prevent the application of this chapter to any settlement in which a party to the  
6           settlement is a resident of this state.

7           **26.1-33.4-15. Penalties.**

- 8           1. It is a violation of this chapter for any person, provider, broker, or any other party  
9           related to the business of life settlements to commit a fraudulent life settlement act.  
10          2. For criminal liability purposes, a person that commits a fraudulent life settlement  
11          act is guilty of committing insurance fraud.  
12          3. The commissioner may levy a civil penalty not exceeding fifty thousand dollars per  
13          violation and the amount of the claim for each violation upon any person, including  
14          those persons and their employees licensed pursuant to this chapter, who is found  
15          to have committed a fraudulent life settlement act or violated any other provision of  
16          this chapter.  
17          4. The license of a person licensed under this chapter which commits a fraudulent life  
18          settlement act must be revoked.

19           **26.1-33.4-16. Unfair trade practices.** A violation of this chapter is considered an  
20 unfair trade practice pursuant to state law and subject to the penalties provided by state law.

21           **SECTION 3. REPEAL.** Chapter 26.1-33.3 of the North Dakota Century Code is  
22 repealed.
