1 A BILL for an Act to amend and reenact subsection 1 of section 6-09.8-01, subsection 4 of  
2 section 10-33-124, subsection 5 of section 11-37-08, sections 27-17-06 and 37-28-07,  
3 subsections 1 and 3 of section 40-63-04, section 40-63-06, subsection 4 of section 40-63-07,  
4 subsections 1 and 2 of section 57-38-01.7, subsections 1 and 4 of section 57-38-01.8, sections  
5 57-38-01.14, 57-38-01.16, and 57-38-01.17, subsection 1 of section 57-38-01.20, subsections  
6 2 and 4 of section 57-38-01.21, sections 57-38-01.22, 57-38-01.23, 57-38-01.24, 57-38-01.25,  
7 and 57-38-01.26, subsection 6 of section 57-38-01.27, subsection 1 of section 57-38-01.29,  
8 subsection 1 of section 57-38-01.30, section 57-38-04, subsection 2 of section 57-38-08.1,  
9 sections 57-38-30.3 and 57-38-30.5, subdivision b of subsection 1 of section 57-38-40, and  
10 sections 57-38.5-03 and 57-38.6-03 of the North Dakota Century Code, relating to elimination  
11 of the optional long-form individual, estate, and trust income tax return; to repeal sections  
12 57-38-01.2, 57-38-01.18, 57-38-02, 57-38-06.1, 57-38-29, 57-38-29.2, 57-38-30.4, 57-38-67,  
13 57-38-68, 57-38-69, and 57-38-70 of the North Dakota Century Code, relating to elimination of  
14 the optional long-form individual, estate, and trust income tax return; to provide an effective  
15 date; and to provide an expiration date.

16 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

17 **SECTION 1. AMENDMENT.** Subsection 1 of section 6-09.8-01 of the North Dakota  
18 Century Code is amended and reenacted as follows:

- 19 1. "Beginning farmer" means ~~a person~~ an individual who qualifies as a beginning  
20 farmer ~~under subsection 2 of section 57-38-67~~ who:
- 21 a. Is a resident of this state;
- 22 b. Receives more than half of that person's gross annual income from farming,  
23 unless the person initially commences farming during the year of the  
24 application under this chapter;

- 1           c. Intends to use any farmland to be purchased or rented for agricultural  
2           purposes;
- 3           d. Is adequately trained by education in the type of farming operation which the  
4           person wishes to begin on the purchased or rented land referred to in  
5           subdivision c through satisfactory participation in the adult farm management  
6           education program of the state board for career and technical education or an  
7           equivalent program approved by the agriculture commissioner; and
- 8           e. Has, including the net worth of any dependents and spouse, a net worth of  
9           less than one hundred thousand dollars, not including the value of their equity  
10           in their principal residence, the value of one personal or family motor vehicle,  
11           and the value of their household goods, including furniture, appliances,  
12           musical instruments, clothing, and other personal belongings.

13           **SECTION 2. AMENDMENT.** Subsection 4 of section 10-33-124 of the North Dakota  
14 Century Code is amended and reenacted as follows:

- 15           4. a. ~~An individual or a~~ A corporation that buys membership in, or pays dues or  
16           contributes to, a nonprofit development corporation is entitled to an income  
17           tax credit against the tax liability under section 57-38-30 equal to twenty-five  
18           percent of the amount paid.
- 19           b. This credit may not be claimed by ~~an individual who elects to file an income~~  
20           ~~tax return under section 57-38-30.3~~ or by a corporation that is recognized as  
21           a subchapter S corporation under section 57-38-01.4.
- 22           c. No taxpayer is entitled to more than two thousand dollars in total income tax  
23           credits under this section.
- 24           d. The amount of the credit under this section in excess of the taxpayer's income  
25           tax liability may be carried forward for up to seven taxable years.

26           **SECTION 3. AMENDMENT.** Subsection 5 of section 11-37-08 of the North Dakota  
27 Century Code is amended and reenacted as follows:

- 28           5. Bonds issued by a commerce authority under this section are declared to be  
29           issued for an essential public government purpose, and together with interest and  
30           income on the bonds, are exempt from all individual and corporate taxes imposed  
31           under sections 57-35.3-03, ~~57-38-29~~, 57-38-30, and 57-38-30.3.

1           **SECTION 4. AMENDMENT.** Section 27-17-06 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3           **27-17-06. Immediate withdrawal of present active judges from judges retirement**  
4 **fund.**

5           1. From and after July 1, 1973, each judge of the supreme or district court serving on  
6 that date and each former judge of the supreme or district court, not receiving  
7 judicial retirement salary, may elect to withdraw the judge's previous contributions  
8 made pursuant to this chapter, and thereafter not participate in a judicial retirement  
9 program provided for by law. This option ceases to be available and may not be  
10 exercised after June 30, 1975. If a judge selects this option, the judge is entitled to  
11 receive the combined total of the following sums:

12           ~~1.~~ a. The entire amount of the judge's previous contributions made pursuant to this  
13 chapter, to be calculated to the date of election under this section; plus

14           ~~2.~~ b. An amount calculated by applying the vesting schedule set forth in section  
15 54-52-11 to an amount equal to sixty percent of the judge's individual  
16 contributions as calculated in subsection 1, plus earnings thereon as  
17 calculated in subsection 3; plus

18           ~~3.~~ c. An amount calculated by applying the figure .05625 to the periodic annual or  
19 partial annual balances in the individual judge's account during the judge's  
20 years of service prior to selecting the option provided by this section. The  
21 figure applied pursuant to this ~~subsection~~ subdivision must be compounded  
22 annually.

23           2. The total amounts received pursuant to this section may not be considered taxable  
24 income for the purposes of chapter 57-38 ~~and may be treated as an additional~~  
25 ~~adjustment reducing the amount of taxable income in addition to those provided in~~  
26 ~~section 57-38-01.2.~~ Selection of the option provided by this section must be made  
27 in writing to the director of the office of management and budget.

28           **SECTION 5. AMENDMENT.** Section 37-28-07 of the North Dakota Century Code is  
29 amended and reenacted as follows:

30           **37-28-07. Payments exempt from taxation and from execution - Assignments**  
31 **void - Debts to state and political subdivisions not deducted.** Payments under this chapter

1 are exempt from all state and local taxes, including taxes determined under section ~~57-38-29~~ or  
2 57-38-30.3, and from levy, garnishment, attachment, and sale on execution. Any pledge,  
3 mortgage, sale, assignment, or transfer of any right, claim, or interest in any claim or payment  
4 under this chapter is void and payment to the veteran may not be denied because of any sums  
5 owed to the state or any political subdivisions, except as provided in section 37-26-05.

6 **SECTION 6. AMENDMENT.** Subsections 1 and 3 of section 40-63-04 of the North  
7 Dakota Century Code are amended and reenacted as follows:

- 8 1. An individual taxpayer who purchases or rehabilitates single-family residential  
9 property for the individual's primary place of residence as a zone project is exempt  
10 from up to ten thousand dollars of personal income tax liability as determined  
11 under section ~~57-38-29~~ or 57-38-30.3 for five taxable years beginning with the date  
12 of occupancy or completion of rehabilitation.
- 13 3. If the cost of a new business purchase or expansion of an existing business,  
14 approved as a zone project, exceeds seventy-five thousand dollars, and the  
15 business is located in a city with a population of not more than two thousand five  
16 hundred, an individual taxpayer may, in lieu of the exemption provided in  
17 subsection 2, elect to take an income tax exemption of up to two thousand dollars  
18 of personal income tax liability as determined under section ~~57-38-29~~ or  
19 57-38-30.3. The election must be made on the taxpayer's zone project application.  
20 The election is irrevocable and binding for the duration of the exemptions provided  
21 in subsection 2 or this subsection. If no election is made on the zone project  
22 application, the taxpayer is only eligible for the exemption provided in subsection 2.

23 **SECTION 7. AMENDMENT.** Section 40-63-06 of the North Dakota Century Code is  
24 amended and reenacted as follows:

25 **40-63-06. Historic preservation and renovation tax credit.** A credit against state tax  
26 liability as determined under sections 57-35.3-03, ~~57-38-29~~, 57-38-30, and 57-38-30.3 is  
27 allowed for investments in the historic preservation or renovation of property within the  
28 renaissance zone. The amount of the credit is twenty-five percent of the amount invested, up  
29 to a maximum of two hundred fifty thousand dollars. The credit may be claimed in the year in  
30 which the preservation or renovation is completed. Any excess credit may be carried forward  
31 for a period of up to five taxable years.

1           **SECTION 8. AMENDMENT.** Subsection 4 of section 40-63-07 of the North Dakota  
2 Century Code is amended and reenacted as follows:

3           4. A credit against state tax liability as determined under section 57-35.3-03,  
4           ~~57-38-29~~, 57-38-30, or 57-38-30.3 is allowed for investments in a renaissance fund  
5 organization. The amount of the credit is fifty percent of the amount invested in the  
6 renaissance fund organization during the taxable year. Any amount of credit which  
7 exceeds a taxpayer's tax liability for the taxable year may be carried forward for up  
8 to five taxable years after the taxable year in which the investment was made.

9           **SECTION 9. AMENDMENT.** Subsections 1 and 2 of section 57-38-01.7 of the North  
10 Dakota Century Code are amended and reenacted as follows:

11           1. At the election of the taxpayer, there must be allowed, subject to the applicable  
12 limitations provided in this subsection, as a credit against the income tax ~~imposed~~  
13 ~~by this chapter~~ liability under section 57-38-30 for the taxable year, an amount  
14 equal to fifty percent of the aggregate amount of charitable contributions made by  
15 the taxpayer during the year to nonprofit private institutions of higher education  
16 located within the state or to the North Dakota independent college fund.

17           a. ~~In the case of a taxpayer other than a corporation, the amount allowable as a~~  
18 ~~credit under this subsection for any taxable year may not exceed forty percent~~  
19 ~~of the taxpayer's total income tax under this chapter for the year, or two~~  
20 ~~hundred fifty dollars, whichever is less.~~

21           b. ~~In the case of a corporation, the~~ The amount allowable as a credit under this  
22 subsection for any taxable year may not exceed twenty percent of the  
23 corporation's total income tax under this chapter for the year, or two thousand  
24 five hundred dollars, whichever is less.

25           2. At the election of the taxpayer, there must be allowed, subject to the applicable  
26 limitations provided in this subsection, as a credit against the income tax ~~imposed~~  
27 ~~by this chapter~~ liability under section 57-38-30 for the taxable year, an amount  
28 equal to fifty percent of the aggregate amount of charitable contributions made by  
29 the taxpayer during the year directly to nonprofit private institutions of secondary  
30 education, located within the state.

- 1           a. ~~In the case of a taxpayer other than a corporation, the amount allowable as a~~  
2           ~~credit under this subsection for any taxable year may not exceed forty percent~~  
3           ~~of the taxpayer's total income tax under this chapter for the year, or two~~  
4           ~~hundred fifty dollars, whichever is less.~~
- 5           b. ~~In the case of a corporation, the~~ The amount allowable as a credit under this  
6           subsection for any taxable year may not exceed twenty percent of the  
7           corporation's total income tax under this chapter for the year, or two thousand  
8           five hundred dollars, whichever is less.

9           **SECTION 10. AMENDMENT.** Subsections 1 and 4 of section 57-38-01.8 of the North  
10          Dakota Century Code are amended and reenacted as follows:

- 11           1. ~~Any~~ A taxpayer filing a North Dakota income tax return pursuant to the provisions  
12           of this chapter may claim a credit against the tax liability under section 57-38-30  
13           for the cost of a geothermal, solar, wind, or biomass energy device installed before  
14           January 1, 2011, in a building or on property owned or leased by the taxpayer in  
15           North Dakota. The credit provided in this section for a device installed before  
16           January 1, 2001, must be in an amount equal to five percent per year for three  
17           years, and for a device installed after December 31, 2000, must be in an amount  
18           equal to three percent per year for five years of the actual cost of acquisition and  
19           installation of the geothermal, solar, wind, or biomass energy device and must be  
20           subtracted from any income tax liability of the taxpayer as determined pursuant to  
21           the provisions of this chapter.
- 22           4. A partnership, subchapter S corporation, limited partnership, limited liability  
23           company, or any other passthrough entity that installs a geothermal, solar, wind, or  
24           biomass energy device in a building or on property owned or leased by the  
25           passthrough entity must be considered to be the taxpayer for purposes of this  
26           section, and the amount of the credit allowed with respect to the entity's  
27           investments must be determined at the passthrough entity level. The amount of  
28           the total credit determined at the entity level must be passed through to the  
29           corporate partners, shareholders, or members in proportion to their respective  
30           interests in the passthrough entity.

1           **SECTION 11. AMENDMENT.** Section 57-38-01.14 of the North Dakota Century Code  
2 is amended and reenacted as follows:

3           **57-38-01.14. No gain recognized on property subject to eminent domain sale or**  
4 **transfer.** If any private property, through the exercise of eminent domain, is involuntarily  
5 converted into property of either like or unlike kind, no gain, either ordinary or capital, may be  
6 recognized for corporate income tax purposes.

7           **SECTION 12. AMENDMENT.** Section 57-38-01.16 of the North Dakota Century Code  
8 is amended and reenacted as follows:

9           **57-38-01.16. Income tax credit for employment of developmentally disabled or**  
10 **chronically mentally ill persons.** ~~Any~~ A taxpayer filing an income tax return under this  
11 chapter, ~~except a return on which liability is determined under section 57-38-30.3,~~ may claim a  
12 credit against the tax liability imposed under section 57-38-30 for a portion of the wages paid to  
13 a developmentally disabled or chronically mentally ill employee. The credit allowed under this  
14 section equals five percent of up to six thousand dollars in wages paid during the first twelve  
15 months of employment by the taxpayer for each developmentally disabled or chronically  
16 mentally ill employee of the taxpayer. Only wages actually paid during the taxpayer's taxable  
17 year may be considered for purposes of this section. An employee of a subcontractor is  
18 considered an employee of the contractor to the extent of any wages paid under the contract.

19           The total of credits allowed under this section may not exceed fifty percent of the  
20 taxpayer's liability under this chapter.

21           **SECTION 13. AMENDMENT.** Section 57-38-01.17 of the North Dakota Century Code  
22 is amended and reenacted as follows:

23           **57-38-01.14. Credit for investments in development corporations.** ~~An individual,~~  
24 ~~estate, trust, or~~ A corporation is allowed, as a credit against a tax otherwise due under section  
25 ~~57-38-29 or~~ 57-38-30, the credit for buying membership in, or paying dues or contributions to, a  
26 certified nonprofit development corporation as provided in section 10-33-124.

27           **SECTION 14. AMENDMENT.** Subsection 1 of section 57-38-01.20 of the North  
28 Dakota Century Code is amended and reenacted as follows:

29           1. An individual is entitled to a credit against the tax imposed under section ~~57-38-29~~  
30 ~~or~~ 57-38-30.3 in the amount of qualified care expenses under this section paid by  
31 the individual for the care of a qualifying family member during the taxable year.

1           **SECTION 15. AMENDMENT.** Subsections 2 and 4 of section 57-38-01.21 of the North  
2 Dakota Century Code are amended and reenacted as follows:

3           2. An individual is allowed a tax credit against the tax imposed by section ~~57-38-29~~ or  
4 57-38-30.3 in an amount equal to forty percent of the present value of the  
5 aggregate amount of the charitable gift portion of planned gifts made by the  
6 taxpayer during the year to a qualified nonprofit organization or qualified  
7 endowment. The maximum credit that may be claimed under this subsection for  
8 contributions made in a taxable year is ten thousand dollars, or twenty thousand  
9 dollars for married individuals filing a joint return. The credit allowed under this  
10 section may not exceed the taxpayer's income tax liability.

11           4. An estate or trust is allowed a tax credit in an amount equal to forty percent of a  
12 charitable gift to a qualified endowment. The maximum credit allowed under this  
13 subsection for contributions made in a taxable year is ten thousand dollars. The  
14 allowable credit must be apportioned to the estate or trust and to its beneficiaries  
15 on the basis of the income of the estate or trust allocable to each, and the  
16 beneficiaries may claim their share of the credit against the tax imposed by section  
17 ~~57-38-29~~, 57-38-30, or 57-38-30.3. A beneficiary may claim the credit only in the  
18 beneficiary's taxable year in which the taxable year of the estate or trust ends.  
19 Subsections 6 and 7 apply to the estate or trust and its beneficiaries with respect  
20 to their respective shares of the apportioned credit.

21           **SECTION 16. AMENDMENT.** Section 57-38-01.22 of the North Dakota Century Code  
22 is amended and reenacted as follows:

23           **57-38-01.22. Income tax credit for blending of biodiesel fuel.** A fuel supplier  
24 licensed pursuant to section 57-43.2-05 who blends biodiesel fuel is entitled to a credit against  
25 tax liability determined under section ~~57-38-29~~, 57-38-30, or 57-38-30.3 in the amount of five  
26 cents per gallon [3.79 liters] of biodiesel fuel of at least five percent blend, otherwise known as  
27 B5. For purposes of this section, "biodiesel" means fuel meeting the specifications adopted by  
28 the American society for testing and materials. The credit under this section may not exceed  
29 the taxpayer's liability as determined under this chapter for the taxable year and each year's  
30 unused credit amount may be carried forward for up to five taxable years.



1           A partnership, subchapter S corporation, limited partnership, limited liability company, or  
2 any other passthrough entity entitled to the credit under this section must be considered to be  
3 the taxpayer for purposes of this section, and the amount of the credit allowed must be  
4 determined at the passthrough entity level. The amount of the total credit determined at the  
5 entity level must be passed through to the partners, shareholders, or members in proportion to  
6 their respective interests in the passthrough entity.

7           **SECTION 17. AMENDMENT.** Section 57-38-01.23 of the North Dakota Century Code  
8 is amended and reenacted as follows:

9           **57-38-01.23. Income tax credit for biodiesel sales equipment costs.** A seller of  
10 biodiesel fuel is entitled to a credit against tax liability determined under section ~~57-38-29~~,  
11 57-38-30; or 57-38-30.3 in the amount of ten percent per year for five years of the biodiesel fuel  
12 seller's direct costs incurred after December 31, 2004, to adapt or add equipment to a facility,  
13 licensed under section 57-43.2-05, to enable the facility to sell diesel fuel containing at least  
14 two percent biodiesel fuel by volume. For purposes of this section, "biodiesel fuel" means fuel  
15 meeting the specifications adopted by the American society for testing and materials. The  
16 credit under this section may not exceed a taxpayer's liability as determined under this chapter  
17 for the taxable year and each year's unused credit amount may be carried forward for up to five  
18 taxable years. A biodiesel fuel seller is limited to fifty thousand dollars in the cumulative  
19 amount of credits under this section for all taxable years. A biodiesel fuel seller may not claim  
20 a credit under this section for any taxable year before the taxable year in which the facility  
21 begins selling biodiesel fuel containing at least two percent biodiesel fuel by volume, but eligible  
22 costs incurred before the taxable year sales begin may be claimed for purposes of the credit  
23 under this section for taxable years on or after the taxable year sales of biodiesel fuel begin.

24           A partnership, subchapter S corporation, limited partnership, limited liability company, or  
25 any other passthrough entity entitled to the credit under this section must be considered to be  
26 the taxpayer for purposes of this section, and the amount of the credit allowed must be  
27 determined at the passthrough entity level. The amount of the total credit determined at the  
28 entity level must be passed through to the partners, shareholders, or members in proportion to  
29 their respective interests in the passthrough entity.

30           **SECTION 18. AMENDMENT.** Section 57-38-01.24 of the North Dakota Century Code  
31 is amended and reenacted as follows:

1           **57-38-01.24. Internship employment tax credit.**

2           1. A taxpayer that is an employer within this state is entitled to a credit as determined  
3           under this section against state income tax liability under section ~~57-38-29~~,  
4           57-38-30; or 57-38-30.3 for qualified compensation paid to an intern employed in  
5           this state by the taxpayer. To qualify for the credit under this section, the  
6           internship program must meet the following qualifications:

- 7           a. The intern must be an enrolled student in an institution of higher education or  
8           vocational technical education program who is seeking a degree or a  
9           certification of completion in a major field of study closely related to the work  
10          experience performed for the taxpayer;  
11          b. The internship must be taken for academic credit or count toward the  
12          completion of a vocational technical education program;  
13          c. The intern must be supervised and evaluated by the taxpayer; and  
14          d. The internship position must be located in this state.

15          2. The amount of the credit to which a taxpayer is entitled is ten percent of the  
16          stipend or salary paid to a college intern employed by the taxpayer. A taxpayer  
17          may not receive more than three thousand dollars in total credits under this section  
18          for all taxable years combined.

- 19          a. The tax credit under this section applies to a stipend or salary for not more  
20          than five interns employed at the same time.  
21          b. A partnership, subchapter S corporation, or limited liability company that for  
22          tax purposes is treated like a partnership that is entitled to the credit under  
23          this section must be considered to be the taxpayer for purposes of calculating  
24          the credit. The amount of the allowable credit must be determined at the  
25          passthrough entity level. The total credit determined at the entity level must  
26          be passed through to the partners, shareholders, or members in proportion to  
27          their respective interests in the passthrough entity.

28           **SECTION 19. AMENDMENT.** Section 57-38-01.25 of the North Dakota Century Code  
29           is amended and reenacted as follows:

30           **57-38-01.25. Workforce recruitment credit for hard-to-fill employment positions.**

31           A taxpayer that is an employer in this state is entitled to a credit as determined under this

1 section against state income tax liability under section ~~57-38-29~~, 57-38-30; or 57-38-30.3 for  
2 costs the taxpayer incurred during the tax year to recruit and hire employees for hard-to-fill  
3 employment positions within this state for which the annual salary for the position meets or  
4 exceeds the state average wage.

5 1. The amount of the credit to which a taxpayer is entitled is five percent of the salary  
6 paid for the first twelve consecutive months to the employee hired for the  
7 hard-to-fill employment position. To qualify for the credit under this section, the  
8 employee must be employed by the taxpayer in the hard-to-fill employment  
9 position for twelve consecutive months.

10 2. For purposes of this section:

11 a. "Extraordinary recruitment methods" means using all of the following:

12 (1) A person with the exclusive business purpose of recruiting employees  
13 and for which a fee is charged by that recruiter.

14 (2) An advertisement in a professional trade journal, magazine, or other  
15 publication, the main emphasis of which is providing information to a  
16 particular trade or profession.

17 (3) A web site, the sole purpose of which is to recruit employees and for  
18 which a fee is charged by the web site.

19 (4) Payment of a signing bonus, moving expenses, or nontypical fringe  
20 benefits.

21 b. "Hard-to-fill employment position" means a job that requires the employer to  
22 use extraordinary recruitment methods and for which the employer's  
23 recruitment efforts for the specific position have been unsuccessful for six  
24 consecutive calendar months.

25 c. "State average wage" means one hundred twenty-five percent of the state  
26 average wage published annually by job service North Dakota and which is in  
27 effect at the time the employee is hired.

28 3. The taxpayer may claim the credit in the first tax year beginning after the employee  
29 hired for the hard-to-fill position has completed the employee's first twelve  
30 consecutive months of employment in the hard-to-fill position with the taxpayer.

- 1           4.    The credit under this section may not exceed a taxpayer's liability for the taxable  
2                    year as determined under this chapter. Any amount of unused credit may be  
3                    carried forward for up to four taxable years after the taxable year in which the  
4                    credit could initially be claimed.
- 5           5.    A partnership, subchapter S corporation, or limited liability company that for tax  
6                    purposes is treated like a partnership that is entitled to the credit under this section  
7                    must be considered to be the taxpayer for purposes of this section and the amount  
8                    of the credit allowed must be determined at the passthrough entity level. The  
9                    amount of the total credit determined at the passthrough entity level must be  
10                   allowed to the members in proportion to their respective interests in the  
11                    passthrough entity.

12           **SECTION 20. AMENDMENT.** Section 57-38-01.26 of the North Dakota Century Code  
13 is amended and reenacted as follows:

14           **57-38-01.26. Angel fund investment tax credit.** A taxpayer is entitled to a credit  
15 against state income tax liability under section ~~57-38-29~~, 57-38-30; or 57-38-30.3 for an  
16 investment made in an angel fund that is incorporated in this state. The angel fund must be in  
17 compliance with the securities laws of this state for the investment to qualify for the tax credit

- 20          f.   Increased by an amount equal to the losses that are passed through to a
- 21                   taxpayer in connection with an allocation and apportionment to North Dakota
- 22                   under chapter 57-35.3.
- 23          g.   Reduced by the amount received by the taxpayer as payment for services
- 24                   performed when mobilized under title 10 United States Code federal service
- 25                   as a member of the national guard or reserve member of the armed forces of
- 26                   the United States. This subdivision does not apply to federal service while
- 27                   attending annual training, basic military training, or professional military
- 28                   education.
- 29          h.   Reduced by income from a new and expanding business exempt from state
- 30                   income tax under section 40-57.1-04.
- 31          i.   Reduced by interest and income from bonds issued under chapter 11-37.

- 1           j.    Reduced by up to ten thousand dollars of qualified expenses that are related  
2                    to a donation by a taxpayer or a taxpayer's dependent, while living, of one or  
3                    more human organs to another human being for human organ  
4                    transplantation. A taxpayer may claim the reduction in this subdivision only  
5                    once for each instance of organ donation during the taxable year in which the  
6                    human organ donation and the human organ transplantation occurs but if  
7                    qualified expenses are incurred in more than one taxable year, the reduction  
8                    for those expenses must be claimed in the year in which the expenses are  
9                    incurred. For purposes of this subdivision:
- 10           (1)   "Human organ transplantation" means the medical procedure by which  
11                    transfer of a human organ is made from the body of one person to the  
12                    body of another person.

18                    income, whether or not the taxpayer itemizes federal income tax  
19                    deductions.
- 20           k.    Increased by the amount of the contribution upon which the credit under  
21                    section 57-38-01.21 is computed, but only to the extent that the contribution  
22                    reduced federal taxable income.
- 23           l.    Reduced by the amount of any payment received by a veteran or beneficiary  
24                    of a veteran under section 37-28-03 or 37-28-04.
- 25           m.    Reduced by the amount received by a taxpayer that was paid by an employer  
26                    under paragraph 4 of subdivision a of subsection 2 of section 57-38-01.25 to  
27                    hire the taxpayer for a hard-to-fill position under section 57-38-01.25, but only  
28                    to the extent the amount received by the taxpayer is included in federal  
29                    taxable income. The reduction applies only if the employer is entitled to the  
30                    credit under section 57-38-01.25. The taxpayer must attach a statement from  
31                    the employer in which the employer certifies that the employer is entitled to



- 1                   the credit under section 57-38-01.25 and which specifically identified the type  
2                   of payment and the amount of the exemption under this section.
- 3                   n.   Reduced by the amount up to a maximum of five thousand dollars, or ten  
4                   thousand dollars if a joint return is filed, for contributions made under a higher  
5                   education savings plan administered by the Bank of North Dakota, pursuant  
6                   to section 6-09-38.
- 7                   o.   Reduced by the amount of income of a taxpayer, who resides within the  
8                   boundaries of any reservation in this state and who is an enrolled member of  
9                   a federally recognized Indian tribe, from activities or sources within the  
10                  boundaries of any reservation in this state.
- 11                 3.   Married individuals filing a joint federal income tax return shall file a joint state  
12                  income tax return if the return is filed under this section. If separate federal income  
13                  tax returns are filed, one spouse's state income tax return may be filed under this  
14                  section and the other spouse's income tax return may be filed under the other  
15                  provisions of this chapter.
- 16                 4.   a.   A resident individual, estate, or trust is entitled to a credit against the tax  
17                  imposed under this section for the amount of income tax paid by the taxpayer  
18                  for the taxable year by another state or territory of the United States or the  
19                  District of Columbia on income derived from sources in those jurisdictions that  
20                  is also subject to tax under this section.
- 21                 b.   For an individual, estate, or trust that is a resident of this state for the entire  
22                  taxable year, the credit allowed under this subsection may not exceed an  
23                  amount equal to the tax imposed under this section multiplied by a ratio equal  
24                  to federal adjusted gross income derived from sources in the other jurisdiction  
25                  divided by federal adjusted gross income less the amounts under  
26                  subdivisions a and b of subsection 2.
- 27                 c.   For an individual, estate, or trust that is a resident of this state for only part of  
28                  the taxable year, the credit allowed under this subsection may not exceed the  
29                  lesser of the following:
- 30                 (1)   The tax imposed under this chapter multiplied by a ratio equal to  
31                  federal adjusted gross income derived from sources in the other

- 1 jurisdiction received while a resident of this state divided by federal  
2 adjusted gross income derived from North Dakota sources less the  
3 amounts under subdivisions a and b of subsection 2.
- 4 (2) The tax paid to the other jurisdiction multiplied by a ratio equal to  
5 federal adjusted gross income derived from sources in the other  
6 jurisdiction received while a resident of this state divided by federal  
7 adjusted gross income derived from sources in the other states.
- 8 d. The tax commissioner may require written proof of the tax paid to another  
9 state. The required proof must be provided in a form and manner as  
10 determined by the tax commissioner.
- 11 5. Individuals, estates, or trusts that file an amended federal income tax return  
12 changing their federal taxable income figure for a year for which an election to file  
13 state income tax returns has been made under this section shall file an amended  
14 state income tax return to reflect the changes on the federal income tax return.
- 15 6. The tax commissioner may prescribe procedures and guidelines to prevent  
16 requiring income that had been previously taxed under this chapter from becoming  
17 taxed again because of the provisions of this section and may prescribe  
18 procedures and guidelines to prevent any income from becoming exempt from  
19 taxation because of the provisions of this section if it would otherwise have been  
20 subject to taxation under the provisions of this chapter.
- 21 7. A taxpayer filing a return under this section is entitled to the following tax credits:
- 22 a. Family care tax credit under section 57-38-01.20.  
23 b. Renaissance zone tax credits under sections 40-63-04, 40-63-06, and  
24 40-63-07.  
25 c. Agricultural business investment tax credit under section 57-38.6-03.  
26 d. Seed capital investment tax credit under section 57-38.5-03.  
27 e. Planned gift tax credit under section 57-38-01.21.  
28 f. Biodiesel fuel tax credits under sections 57-38-01.22 and 57-38-01.23.  
29 g. Internship employment tax credit under section 57-38-01.24.  
30 h. Workforce recruitment credit under section 57-38-01.25.  
31 i. Angel fund investment tax credit under section 57-38-01.26.

- 1           j.    Microbusiness tax credit under section 57-38-01.27.
- 2           k.    Marriage penalty credit under section 57-38-01.28.
- 3           l.    Homestead income tax credit under section 57-38-01.29.
- 4           m.   Commercial property income tax credit under section 57-38-01.30.
- 5           n.    Research and experimental expenditures under section 57-38-30.5.
- 6        8.    A taxpayer filing a return under this section is entitled to the exemption provided
- 7           under section 40-63-04.
- 8        9.    a.    If an individual taxpayer engaged in a farming business elects to average
- 9           farm income under section 1301 of the Internal Revenue Code [26 U.S.C.
- 10          1301], the taxpayer may elect to compute tax under this subsection. If an
- 11         election to compute tax under this subsection is made, the tax imposed by
- 12         subsection 1 for the taxable year must be equal to the sum of the following:
- 13           (1)   The tax computed under subsection 1 on North Dakota taxable income
- 14           reduced by elected farm income.
- 15           (2)   The increase in tax imposed by subsection 1 which would result if North
- 16           Dakota taxable income for each of the three prior taxable years were
- 17           increased by an amount equal to one-third of the elected farm income.
- 18           However, if other provisions of this chapter other than this section were
- 19           used to compute the tax for any of the three prior years, the same
- 20           provisions in effect for that prior tax year must be used to compute the

- 29           claimed under subdivision d of subsection 2 that is attributable to a net
- 30           long-term capital gain included in elected farm income.

- 1           c.    The reduction in North Dakota taxable income under this subsection must be  
2                    taken into account for purposes of making an election under this subsection  
3                    for any subsequent taxable year.
- 4           d.    The tax commissioner may prescribe rules, procedures, or guidelines  
5                    necessary to administer this subsection.
- 6        10.   The tax commissioner may prescribe tax tables, to be used in computing the tax  
7                    according to subsection 1, if the amounts of the tax tables are based on the tax  
8                    rates set forth in subsection 1. If prescribed by the tax commissioner, the tables  
9                    must be followed by every individual, estate, or trust determining a tax under this  
10                  section.

11           **SECTION 27. AMENDMENT.** Section 57-38-30.5 of the North Dakota Century Code is  
12 amended and reenacted as follows:

13           **57-38-30.5. Income tax credit for research and experimental expenditures.** A  
14 taxpayer is allowed a credit against the tax imposed under section ~~57-38-29~~, 57-38-30; or  
15 57-38-30.3 for conducting qualified research in this state.

- 16        1.    The amount of the credit for taxpayers that earned or claimed a credit under this  
17                  section in taxable years beginning before January 1, 2007, is calculated as follows:
- 18           a.    For the first taxable year beginning after December 31, 2006, the credit is  
19                    equal to twenty-five percent of the first one hundred thousand dollars of the  
20                    qualified research expenses for the taxable year in excess of the base period  
21                    research expenses and equal to seven and one-half percent of all qualified  
22                    research expenses for the taxable year more than one hundred thousand  
23                    dollars in excess of the base period research expenses.
- 24           b.    For the second taxable year beginning after December 31, 2006, the credit is  
25                    equal to twenty-five percent of the first one hundred thousand dollars of the  
26                    qualified research expenses for the taxable year in excess of the base period  
27                    research expenses and equal to eleven percent of all qualified research  
28                    expenses for the taxable year more than one hundred thousand dollars in  
29                    excess of the base period research expenses.
- 30           c.    For the third taxable year beginning after December 31, 2006, the credit is  
31                    equal to twenty-five percent of the first one hundred thousand dollars of the

- 1 qualified research expenses for the taxable year in excess of the base period  
2 research expenses and equal to fourteen and one-half percent of all qualified  
3 research expenses for the taxable year more than one hundred thousand  
4 dollars in excess of the base period research expenses.
- 5 d. For the fourth through the tenth taxable years beginning after December 31,  
6 2006, the credit is equal to twenty-five percent of the first one hundred  
7 thousand dollars of the qualified research expenses for the taxable year in  
8 excess of the base period research expenses and equal to eighteen percent  
9 of all qualified research expenses for the taxable year more than one hundred  
10 thousand dollars in excess of the base period research expenses.
- 11 e. For the eleventh taxable year beginning after December 31, 2006, and for  
12 each subsequent taxable year in which the taxpayer conducts qualified  
13 research in this state, the credit is equal to twenty-five percent of the first one  
14 hundred thousand dollars of the qualified research expenses for the taxable  
15 year in excess of the base period research expenses and equal to eight  
16 percent of all qualified research expenses for the taxable year more than one  
17 hundred thousand dollars in excess of the base period research expenses.
- 18 f. The maximum annual credit a taxpayer may obtain under this section is two  
19 million dollars. Any credit amount earned in the taxable year in excess of two  
20 million dollars may not be carried back or forward as provided in subsection 7.
- 21 2. For taxpayers that have not earned or claimed a credit under this section in taxable  
22 years beginning before January 1, 2007, and which begin conducting qualified  
23 research in North Dakota in any of the first four taxable years beginning after  
24 December 31, 2006, the amount of the credit is equal to twenty-five percent of the  
25 first one hundred thousand dollars of the qualified research expenses for the  
26 taxable year in excess of the base period research expenses and equal to twenty  
27 percent of all qualified research expenses for the taxable year more than one  
28 hundred thousand dollars in excess of the base period research expenses.
- 29 a. This rate applies through the tenth taxable year beginning after December 31,  
30 2006.

- 1           b. For the eleventh taxable year beginning after December 31, 2006, and for  
2           each subsequent taxable year in which the taxpayer conducts qualified  
3           research in this state, the credit is equal to twenty-five percent of the first one  
4           hundred thousand dollars of the qualified research expenses for the taxable  
5           year in excess of the base period research expenses and equal to eight  
6           percent of all qualified research expenses for the taxable year more than one  
7           hundred thousand dollars in excess of the base period research expenses.
- 8           3. For taxpayers that have not earned or claimed a credit under this section in taxable  
9           years beginning before January 1, 2007, and which begin conducting qualified  
10          research in North Dakota in any taxable year following the fourth taxable year  
11          beginning after December 31, 2006, the amount of the credit is equal to twenty-five  
12          percent of the first one hundred thousand dollars of the qualified research  
13          expenses for the taxable year in excess of the base period research expenses and  
14          equal to eight percent of all qualified research expenses for the taxable year more  
15          than one hundred thousand dollars in excess of the base period research  
16          expenses.
- 17          4. For purposes of this section:
- 18           a. "Base period research expenses" means base period research expenses as  
19           defined in section 41(c) of the Internal Revenue Code [26 U.S.C. 41(c)],  
20           except it does not include research conducted outside the state of North  
21           Dakota.
- 22           b. "Director" means the director of the department of commerce division of  
23           economic development and finance.
- 24           c. "Primary sector business" means a qualified business that through the  
25           employment of knowledge or labor adds value to a product, process, or  
26           service.
- 27           d. "Qualified research" means qualified research as defined in section 41(d) of  
28           the Internal Revenue Code [26 U.S.C. 41(d)], except it does not include  
29           research conducted outside the state of North Dakota.
- 30           e. "Qualified research and development company" means a taxpayer that is a  
31           primary sector business with annual gross revenues of less than seven

- 1                   hundred fifty thousand dollars and which has not conducted new research  
2                   and development in North Dakota.
- 3                   f. "Qualified research expenses" means qualified research expenses as defined  
4                   in section 41(b) of the Internal Revenue Code [26 U.S.C. 41(b)], except it  
5                   does not include expenses incurred for basic research conducted outside the  
6                   state of North Dakota.
- 7                   5. The credit allowed under this section for the taxable year may not exceed the  
8                   liability for tax under this chapter.
- 9                   6. In the case of a taxpayer that is a partner in a partnership or a member in a limited  
10                  liability company, the credit allowed for the taxable year may not exceed an  
11                  amount separately computed with respect to the taxpayer's interest in the trade,  
12                  business, or entity equal to the amount of tax attributable to that portion of the  
13                  taxpayer's taxable income which is allocable or apportionable to the taxpayer's  
14                  interest in the trade, business, or entity.
- 15                 7. Except as provided in subsection 1, if the amount of the credit determined under  
16                 this section for any taxable year exceeds the limitation under subsection 5, the  
17                 excess may be used as a research credit carryback to each of the three preceding  
18                 taxable years and a research credit carryover to each of the fifteen succeeding  
19                 taxable years. The entire amount of the excess unused credit for the taxable year  
20                 must be carried first to the earliest of the taxable years to which the credit may be  
21                 carried and then to each successive year to which the credit may be carried and  
22                 the amount of the unused credit which may be added under this subsection may  
23                 not exceed the taxpayer's liability for tax less the research credit for the taxable  
24                 year.
- 25                 8. A taxpayer that is certified as a qualified research and development company by  
26                 the director may elect to sell, transfer, or assign all or part of the unused tax credit  
27                 earned under this section. The director shall certify whether a taxpayer that has  
28                 requested to become a qualified research and development company meets the  
29                 requirements of subsection 4. The director shall establish the necessary forms  
30                 and procedures for certifying qualifying research and development companies.  
31                 The director shall issue a certification letter to the taxpayer and the tax

- 1 commissioner. A tax credit can be sold, transferred, or assigned subject to the  
2 following:
- 3 a. A taxpayer's total credit assignment under this section may not exceed one  
4 hundred thousand dollars over any combination of taxable years.
- 5 b. If the taxpayer elects to assign or transfer an excess credit under this  
6 subsection, the tax credit transferor and the tax credit purchaser jointly shall  
7 file with the tax commissioner a copy of the purchase agreement and a  
8 statement containing the names, addresses, and taxpayer identification  
9 numbers of the parties to the transfer, the amount of the credit being  
10 transferred, the gross proceeds received by the transferor, and the taxable  
11 year or years for which the credit may be claimed. The taxpayer and the  
12 purchaser also shall file a document allowing the tax commissioner to  
13 disclose tax information to either party for the purpose of verifying the  
14 correctness of the transferred tax credit. The purchase agreement,  
15 supporting statement, and waiver must be filed within thirty days after the  
16 date the purchase agreement is fully executed.
- 17 c. The purchaser of the tax credit shall claim the credit beginning with the  
18 taxable year in which the credit purchase agreement was fully executed by  
19 the parties. A purchaser of a tax credit under this section has only such rights  
20 to claim and use the credit under the terms that would have applied to the tax  
21 credit transferor, except the credit purchaser may not carry back the credit as  
22 otherwise provided in this section. This subsection does not limit the ability of  
23 the tax credit purchaser to reduce the tax liability of the purchaser, regardless  
24 of the actual tax liability of the tax credit transferor.
- 25 d. The original purchaser of the tax credit may not sell, assign, or otherwise  
26 transfer the credit purchased under this section.
- 27 e. If the amount of the credit available under this section is changed as a result  
28 of an amended return filed by the transferor, or as the result of an audit  
29 conducted by the internal revenue service or the tax commissioner, the  
30 transferor shall report to the purchaser the adjusted credit amount within thirty  
31 days of the amended return or within thirty days of the final determination



1                   made by the internal revenue service or the tax commissioner. The tax credit  
2                   purchaser shall file amended returns reporting the additional tax due or  
3                   claiming a refund as provided in section 57-38-38 or 57-38-40, and the tax  
4                   commissioner may audit these returns and assess or issue refunds, even  
5                   though other time periods prescribed in these sections may have expired for  
6                   the purchaser.

7                   f. Gross proceeds received by the tax credit transferor must be assigned to  
8                   North Dakota. The amount assigned under this subsection cannot be  
9                   reduced by the taxpayer's income apportioned to North Dakota or any North  
10                  Dakota net operating loss of the taxpayer.

11                  g. The tax commissioner has four years after the date of the credit assignment  
12                  to audit the returns of the credit transferor and the purchaser to verify the  
13                  correctness of the amount of the transferred credit and if necessary assess  
14                  the credit purchaser if additional tax is found due. This subdivision does not  
15                  limit or restrict any other time period prescribed in this chapter for the  
16                  assessment of tax.

17                  h. The tax commissioner may adopt rules to permit verification of the validity and  
18                  timeliness of the transferred tax credit.

19                  9. If a taxpayer acquires or disposes of the major portion of a trade or business or the  
20                  major portion of a separate unit of a trade or business in a transaction with another  
21                  taxpayer, the taxpayer's qualified research expenses and base period must be  
22                  adjusted in the manner provided by section 41(f)(3) of the Internal Revenue Code  
23                  [26 U.S.C. 41(f)(3)].

24                  10. If a taxpayer entitled to the credit provided by this section is a member of a group  
25                  of corporations filing a North Dakota consolidated tax return using the combined  
26                  reporting method, the credit may be claimed against the aggregate North Dakota  
27                  tax liability of all the corporations included in the North Dakota consolidated return.  
28                  This section does not apply to tax credits received or purchased under  
29                  subsection 8.

- 1           11. An individual, estate, or trust that purchases a credit under this section is entitled  
2           to claim the credit against state income tax liability under section ~~57-38-29~~ or  
3           57-38-30.3.
- 4           12. A partnership, subchapter S corporation, limited partnership, limited liability  
5           company, or any other passthrough entity entitled to the credit under this section  
6           must be considered to be the taxpayer for purposes of calculating the credit. The  
7           amount of the allowable credit must be determined at the passthrough entity level.  
8           The total credit determined at the entity level must be passed through to the  
9           partners, shareholders, or members in proportion to their respective interests in the  
10          passthrough entity. An individual taxpayer may take the credit passed through  
11          under this subsection against the individual's state income tax liability under  
12          sections ~~57-38-29~~ and ~~57-38-30~~ section 57-38-30.3.

13           **SECTION 28. AMENDMENT.** Subdivision b of subsection 1 of section 57-38-40 of the  
14 North Dakota Century Code is amended and reenacted as follows:

- 15           b. An individual who filed a return of income as a resident of this state and is  
16           assessed tax by another state or territory of the United States or the District of  
17           Columbia on that income after the time for filing a claim has expired under  
18           this section is entitled to a credit or refund for the amount of tax paid to the  
19           other jurisdiction, not including penalty or interest, as provided under  
20           subsection ~~2 or 6 of section 57-38-04~~ 1 or ~~subsection 4 of section 57-38-30.3,~~  
21           notwithstanding the time limitations of this section. The claim for the credit or  
22           refund under this subdivision must be submitted to the commissioner within  
23           one year from the date the taxes were paid to the other jurisdiction. The  
24           taxpayer must submit sufficient proof to show entitlement to a credit or refund  
25           under this subdivision.

26           **SECTION 29. AMENDMENT.** Section 57-38.5-03 of the North Dakota Century Code is  
27 amended and reenacted as follows:

- 28           **57-38.5-03. Seed capital investment tax credit.** If a taxpayer makes a qualified  
29 investment in a qualified business, the taxpayer is entitled to a credit against state income tax  
30 liability under section ~~57-38-29~~, 57-38-30, or 57-38-30.3.

- 1           1.    The amount of the credit to which a taxpayer is entitled is forty-five percent of the  
2                    amount invested by the taxpayer in qualified businesses during the taxable year.
- 3           2.    The maximum annual credit a taxpayer may claim under this section is not more  
4                    than one hundred twelve thousand five hundred dollars. This subsection may not  
5                    be interpreted to limit additional investment by a taxpayer for which that taxpayer is  
6                    not applying for a credit.
- 7           3.    Any amount of credit under subsection 1 not allowed because of the limitation in  
8                    subsection 2 may be carried forward for up to four taxable years after the taxable  
9                    year in which the investment was made.
- 10          4.    A passthrough entity that invests in a qualified business must be considered to be  
11                    the taxpayer for purposes of the investment limitations in this section and the  
12                    amount of the credit allowed with respect to a passthrough entity's investment in a  
13                    qualified business must be determined at the passthrough entity level. The  
14                    amount of the total credit determined at the passthrough entity level must be  
15                    allowed to the members in proportion to their respective interests in the  
16                    passthrough entity.
- 17          5.    An investment made in a qualified business from the assets of a retirement plan is  
18                    deemed to be the retirement plan participant's investment for the purpose of this  
19                    chapter if a separate account is maintained for the plan participant and the  
20                    participant directly controls where the account assets are invested.
- 21          6.    The investment must be made on or after the certification effective date and must  
22                    be at risk in the business to be eligible for the tax credit under this section. An  
23                    investment for which a credit is received under this section must remain in the  
24                    business for at least three years. Investments placed in escrow do not qualify for  
25                    the credit.
- 26          7.    The entire amount of an investment for which a credit is claimed under this section  
27                    must be expended by the qualified business for plant, equipment, research and  
28                    development, marketing and sales activity, or working capital for the qualified  
29                    business.
- 30          8.    A taxpayer who owns a controlling interest in the qualified business or who  
31                    receives more than fifty percent of the taxpayer's gross annual income from the

1 qualified business is not entitled to a credit under this section. A member of the  
2 immediate family of a taxpayer disqualified by this subsection is not entitled to the  
3 credit under this section. For purposes of this subsection, "immediate family"  
4 means the taxpayer's spouse, parent, sibling, or child or the spouse of any such  
5 person.

6 9. The tax commissioner may disallow any credit otherwise allowed under this  
7 section if any representation by a business in the application for certification as a  
8 qualified business proves to be false or if the taxpayer or qualified business fails to  
9 satisfy any conditions under this section or any conditions consistent with this  
10 section otherwise determined by the tax commissioner. The commissioner has  
11 four years after the due date of the return or after the return was filed, whichever  
12 period expires later, to audit the credit and assess additional tax that may be found  
13 due to failure to comply with the provisions of this chapter. The amount of any  
14 credit disallowed by the tax commissioner that reduced the taxpayer's income tax  
15 liability for any or all applicable tax years, plus penalty and interest as provided  
16 under section 57-38-45, must be paid by the taxpayer.

17 10. An angel fund that invests in a qualified business must be considered to be the  
18 taxpayer for purposes of the investment limitations in this section. The amount of  
19 the credit allowed with respect to an angel fund's investment in a qualified  
20 business must be determined at the angel fund level. The amount of the total  
21 credit determined at the angel fund level must be allowed to the investors in the  
22 angel fund in proportion to the investor's respective interests in the fund. An angel  
23 fund that is subject to the tax imposed under chapter 57-38 is not eligible for the  
24 investment tax credit under this chapter.

25 **SECTION 30. AMENDMENT.** Section 57-38.6-03 of the North Dakota Century Code is  
26 amended and reenacted as follows:

27 **57-38.6-03. Agricultural business investment tax credit.** If a taxpayer makes a  
28 qualified investment in a qualified business, the taxpayer is entitled to a credit against state  
29 income tax liability as determined under section ~~57-38-29~~, 57-38-30, or 57-38-30.3.

30 1. The amount of the credit to which a taxpayer is entitled is thirty percent of the  
31 amount invested by the taxpayer in qualified businesses during the taxable year.

- 1           2.    The maximum annual credit a taxpayer may obtain under this section is fifty  
2                    thousand dollars and no taxpayer may obtain more than two hundred fifty  
3                    thousand dollars in credits under this section over any combination of taxable  
4                    years. This subsection may not be interpreted to limit additional investment by a  
5                    taxpayer for which that taxpayer is not applying for a credit.
- 6           3.    The credit under this section may not exceed the liability for tax under chapter  
7                    57-38. If the amount of credit under this section exceeds the liability for tax, the  
8                    excess may be carried forward for up to ten taxable years after the taxable year in  
9                    which the investment was made.
- 10          4.    A partnership, subchapter S corporation, limited liability company that for tax  
11                    purposes is treated like a partnership, or any other passthrough entity that invests  
12                    in a qualified business must be considered to be the taxpayer for purposes of the  
13                    investment limitations in this section and, except for the tax liability limitation under  
14                    subsection 2, the amount of the credit allowed with respect to the passthrough  
15                    entity's investment in a qualified business must be determined at the passthrough  
16                    entity level. The amount of the total credit determined at the passthrough entity  
17                    level must be allowed to the passthrough entity's owners, in proportion to their  
18                    respective ownership interests in the passthrough entity.
- 19          5.    An investment made in a qualified business from the assets of a retirement plan is  
20                    deemed to be the retirement plan participant's investment for the purposes of this  
21                    chapter if a separate account is maintained for the plan participant and the  
22                    participant directly controls where the account assets are invested.
- 23          6.    The investment must be made on or after the certification effective date and must  
24                    be at risk in the business to be eligible for the tax credit under this section. A  
25                    qualified investment must be in the form of a purchase of ownership interests or  
26                    the right to receive payment of dividends from the business. An investment for  
27                    which a credit is received under this section must remain in the business for at  
28                    least three years. An investment placed in escrow does not qualify for the credit.
- 29          7.    The entire amount of an investment for which a credit is claimed under this section  
30                    must be expended by the qualified business for plant, equipment, research and  
31                    development, marketing and sales activity, or working capital for the qualified

- 1 business. Real property that qualifies as an investment must be used in, and be  
2 an integral part of, the qualified business's North Dakota business operations.
- 3 8. If the investment is a contribution of real property:
- 4 a. The value of the contribution may not exceed the appraised value as  
5 established by a licensed or certified appraiser licensed or certified under the  
6 requirements of sections 43-23.3-04, 43-23.3-04.1, 43-23.3-05, 43-23.3-06,  
7 43-23.3-07, 43-23.3-08, 43-23.3-09, 43-23.3-10, 43-23.3-11, and 43-23.3-12.
- 8 b. The value of the contribution must be approved by the governing body of the  
9 qualified business applying the valuation standards set forth in subsection 3  
10 of section 10-19.1-63.
- 11 c. The qualified business receiving the contribution of real property shall provide  
12 to the tax commissioner a copy of the appraised valuation, a copy of the  
13 governing body's resolution approving the value of the contribution, and a  
14 copy of the statement of full consideration within thirty days after the  
15 instrument transferring title to the real property is recorded with the register of  
16 deeds as provided in chapter 47-19.
- 17 d. A taxpayer making a contribution of real property is entitled to the tax credit in  
18 the taxable year in which the instrument transferring title to the real property is  
19 recorded with the register of deeds as provided in chapter 47-19.
- 20 9. The tax commissioner may disallow any credit otherwise allowed under this  
21 section if any representation by a business in the application for certification as a  
22 qualified business proves to be false or if the taxpayer or qualified business fails to  
23 satisfy any conditions under this section or any conditions consistent with this  
24 section otherwise determined by the tax commissioner. The amount of any credit  
25 disallowed by the tax commissioner that reduced the taxpayer's income tax liability  
26 for any or all applicable tax years, plus penalty and interest provided under section  
27 57-38-45, must be paid by the taxpayer.

28 **SECTION 31. REPEAL.** Sections 57-38-01.2, 57-38-01.18, 57-38-02, 57-38-06.1,  
29 57-38-29, 57-38-29.2, 57-38-30.4, 57-38-67, 57-38-68, 57-38-69, and 57-38-70 of the North  
30 Dakota Century Code are repealed.

1           **SECTION 32. EFFECTIVE DATE - EXPIRATION DATE - APPLICATION.** This Act is  
2 effective for taxable years beginning after December 31, 2009. Section 26 of this Act is  
3 effective for the first two taxable years beginning after December 31, 2009, and is thereafter  
4 ineffective. The income amounts shown in the tax brackets in the amendment to section  
5 57-38-30.3 in this Act are the income amounts as indexed for taxable year 2009. The tax  
6 commissioner shall apply appropriate indexing factors, as determined under subdivision g of  
7 subsection 1 of section 57-38-30.3, to the dollar amounts of the brackets to update those  
8 amounts for taxable years after 2009.
