HOUSE BILL NO. 1124

(At the request of the State Board of Higher Education and State Forester)

1 A BILL for an Act to create and enact a new chapter to title 18 of the North Dakota Century
2 Code, relating to approval of a compact with other states to promote effective prevention and
3 control of forest fires.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1.** A new chapter to title 18 of the North Dakota Century Code is created and
6 enacted as follows:

7 Interstate compact for the prevention and control of wildland fires. This compact
8 for the prevention and control of wildland fires is entered into and enacted into law. The
9 governor may execute a compact on behalf of the state with any one or more states who may
10 by their legislative bodies, authorize a compact, in form substantially as follows:

11 ARTICLE I

12 The purpose of this compact is to promote effective prevention and control of forest fires
13 in the great plains region of the United States by the maintenance of adequate forest fire
14 fighting services by the member states, and by providing for reciprocal aid in fighting forest fires
15 among the compacting states of the region, including South Dakota, North Dakota, Wyoming,
16 Colorado, and any adjoining state of a current member state.

17 ARTICLE II

18 This compact is operative immediately as to those states ratifying it if any two or more
19 of the member states have ratified it.

20 ARTICLE III

21 In each state, the state forester or officer holding the equivalent position who is
22 responsible for forest fire control may act as compact administrator for that state and may
23 consult with like officials of the other member states and may implement cooperation between
24 the states in forest fire prevention and control. The compact administrators of the member

1 states may organize to coordinate the services of the member states and provide administrative
2 integration in carrying out the purpose of this compact. Each member state may formulate and
3 put in effect a forest fire plan for that state.

4 ARTICLE IV

5 If the state forest fire control agency of a member state requests aid from the state
6 forest fire control agency of any other member state in combating, controlling, or preventing
7 forest fires, the state forest fire control agency of that state may render all possible aid to the
8 requesting agency, consonant with the maintenance of protection at home.

9 ARTICLE V

10 If the forces of any member state are rendering outside aid pursuant to the request of
11 another member state under this compact, the employees of the state shall, under the direction
12 of the officers of the state to which they are rendering aid, have the same powers (except the
13 power of arrest), duties, rights, privileges, and immunities as comparable employees of the
14 state to which they are rendering aid.

15 No member state or its officers or employees rendering outside aid pursuant to this
16 compact is liable on account of any act or omission on the part of such forces while so
17 engaged, or on account of the maintenance or use of any equipment or supplies in connection
18 with rendering the outside aid.

19 All liability, except as otherwise provided in this compact, that may arise either under
20 the laws of the requesting state or under the laws of the aiding state or under the laws of a third
21 state on account of or in connection with a request for aid, shall be assumed and borne by the
22 requesting state.

23 Any member state rendering outside aid pursuant to this compact shall be reimbursed
24 by the member state receiving the aid for any loss or damage to, or expense incurred in the
25 operation of any equipment answering a request for aid, and for the cost of all materials,
26 transportation, wages, salaries, and maintenance of employees and equipment incurred in
27 connection with such request. However, nothing in this compact prevents any assisting
28 member state from assuming such loss, damage, expense, or other cost or from loaning such
29 equipment or from donating such services to the receiving member state without charge or
30 cost.

ARTICLE IX

This compact shall continue in force and remain binding on each state ratifying it until the legislature or the governor of the state takes action to withdraw from the compact. Such action is not effective until six months after notice of the withdrawal has been sent by the chief executive of the state desiring to withdraw to the chief executives of all states then parties to the compact.
