1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;
2 and to amend and reenact section 54-11-13 of the North Dakota Century Code, relating to the
3 salary of the state treasurer.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
6 as may be necessary, are appropriated out of any moneys in the general fund in the state
7 treasury not otherwise appropriated, to the state treasurer for the purpose of defraying the
8 expenses of that agency, for the biennium beginning July 1, 2011, and ending June 30, 2013, as
9 follows:

5 The 2011-13 one-time funding amounts are not a part of the entity's base budget for the
6 2013-15 biennium. The state treasurer shall report to the appropriations committees of the
7 sixty-third legislative assembly on the use of this one-time funding for the biennium beginning
8 July 1, 2011, and ending June 30, 2013.

9 **SECTION 3. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-11-13. Salary of state treasurer.**

12 The annual salary of the state treasurer is ~~seventy-eight~~eighty-five thousand ~~ninethree~~
13 hundred ~~thirty~~ dollars through June 30, ~~2010~~2012, and ~~eighty-two~~eighty-seven thousand eight
14 hundred ~~forty-five~~ninety dollars thereafter.
