**ENGROSSED HOUSE BILL NO. 1005**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the Indian affairs  
2 commission.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, to the Indian affairs commission for the purpose of  
7 defraying the expenses of that agency, for the biennium beginning July 1, 2011, and ending  
8 June 30, 2013, as follows:

22 **SECTION 3. LEGISLATIVE INTENT - SUICIDE PREVENTION PROGRAM - REPORT TO**  
23 **SIXTY-THIRD LEGISLATIVE ASSEMBLY.** It is the intent of the sixty-second legislative  
24 assembly that the Indian affairs commission work in conjunction with the state department of

1 health to develop a suicide prevention program, including outreach, education, administration,  
2 and implementation of grants for suicide prevention activities for the biennium beginning July 1,  
3 2011, and ending June 30, 2013. The Indian affairs commission shall report to the  
4 appropriations committees of the sixty-third legislative assembly on the use of the funding  
5 provided for this program in the operating expenses line item in section 1 of this Act, including  
6 statistics on the effectiveness of the program, for the biennium beginning July 1, 2011, and  
7 ending June 30, 2013.
