2		will be produced under this section. The advisory group shall advise the division of
3		tourism on the production of films under this section. The advisory group consists of
4		the director of the state historical society, a representative of the Bank of North
5		Dakota, the chairman of the North Dakota humanities council, one senator appointed
6		by the majority leader of the senate of the legislative assembly, and one representative
7		appointed by the majority leader of the house of representatives of the legislative
8		assembly.
9	SEC	CTION 2. TRANSFER - TOBACCO PREVENTION AND CONTROL FUND - ROUGH
