1 A BILL for an Act to provide an appropriation for defraying the expenses of the comprehensive
2 tobacco control advisory committee; and to provide for a legislative management study.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the tobacco prevention and control
6 trust fund, not otherwise appropriated, to the comprehensive tobacco control advisory
7 committee for the purpose of defraying the expenses of the committee, for the biennium
8 beginning July 1, 2013, and ending June 30, 2015, as follows:

18 **SECTION 2. LEGISLATIVE MANAGEMENT STUDY - COMPREHENSIVE STATEWIDE**
19 **TOBACCO PREVENTION AND CONTROL PLAN.**

- 20 1. During the 2013-14 interim, the legislative management shall consider studying the
- 21 comprehensive statewide tobacco prevention and control plan used in this state.
- 22 2. As part of the study, the tobacco prevention and control executive committee and state
- 23 department of health shall work together to create a single assessment of programs in
- 24 both agencies including funding sources for the programs, service providers, areas

1 and populations served by the programs, and effectiveness of the programs on
2 improving the health and policy environment in the state. The tobacco prevention and
3 control executive committee and state department of health shall present this
4 assessment to the legislative management.

5 3. The study may include:

- 6 a. A review of the service delivery system for the comprehensive statewide tobacco
7 prevention and control programs provided by the two agencies, whether the
8 delivery system is fiscally efficient, and how the delivery system is consistent with
9 the centers for disease control's best practices for comprehensive tobacco
10 control programs;
- 11 b. A review of the effectiveness of the comprehensive statewide tobacco prevention
12 and control programs provided in the state and ways to improve the health and
13 policy outcomes of the programs; and
- 14 c. A review of how the comprehensive statewide tobacco prevention and control
15 programs provided by the two agencies address the Native American population
16 on the Indian reservations.

17 4. The legislative management shall report its findings and recommendations, together
18 with any legislation required to implement the recommendations, to the sixty-fourth
19 legislative assembly.
