**ENGROSSED SENATE BILL NO. 2052**

Introduced by

(Judiciary Committee)

1 A BILL for an Act to create and enact a new section to chapter 27-20, a new section to chapter  
2 39-08, and a new section to chapter 54-12 of the North Dakota Century Code, relating to  
3 participation in the twenty-four seven sobriety program and the use of drug court for driving  
4 under the influence offenders; to amend and reenact sections 27-20-10, 27-20-31, 39-06-03,  
5 subdivision h of subsection 2 of section 39-06-49, section 39-08-01, subsection 2 of section  
6 39-16-03.1, section 39-20-01, subsection 2 of section 39-20-04, subsections 2 and 3 of section  
7 39-20-05, and section 39-20-15 of the North Dakota Century Code, relating to driving under the  
8 influence offenses and participation in the twenty-four seven sobriety and drug court programs;  
9 and to provide for retroactive application.

10 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

11 **SECTION 1. AMENDMENT.** Section 27-20-10 of the North Dakota Century Code is  
12 amended and reenacted as follows:

13 **27-20-10. Informal adjustment.**

- 14 1. Before a petition is filed, the director of juvenile court or other officer of the court  
15 designated by it, subject to its direction, may give counsel and advice to the parties  
16 and impose conditions for the conduct and control of the child with a view to an  
17 informal adjustment if it appears:
- 18 a. The admitted facts bring the case within the jurisdiction of the court;
  - 19 b. Counsel, advice, and conditions, if any, for the conduct and control of the child  
20 without an adjudication would be in the best interest of the public and the child;
  - 21 and
  - 22 c. The child and the child's parents, guardian, or other custodian consent thereto  
23 with knowledge that consent is not obligatory.

- 1           2.    The giving of counsel and advice and any conditions imposed for the conduct and  
2                    control of the child cannot extend beyond nine months from the day commenced  
3                    unless extended by the court for an additional period not to exceed six months and  
4                    does not authorize the detention of the child if not otherwise permitted by this chapter.  
5                    If the child admits to driving or being in actual physical control of a vehicle in violation  
6                    of section 39-08-01 or an equivalent ordinance, the child may be required to pay a fine  
7                    as a condition imposed under this section.
- 8           3.    An incriminating statement made by a participant to the person giving counsel or  
9                    advice and in the discussions or conferences incident thereto may not be used against  
10                   the declarant over objection in any hearing except in a hearing on disposition in a  
11                   juvenile court proceeding or in a criminal proceeding against the declarant after  
12                   conviction for the purpose of a presentence investigation.
- 13          4.    ~~If a child is subject to informal adjustment for a violation of section 39-08-01 or~~  
14                   ~~equivalent ordinance, or if a child is found to have an alcohol concentration of at least~~  
15                   ~~two one hundredths of one percent by weight at the time of performance of a test~~  
16                   ~~within two hours after driving or being in physical control of a motor vehicle, the~~  
17                   ~~juvenile court shall require the child to participate in the twenty-four seven sobriety~~  
18                   ~~program under chapter 54-12 for up to nine months.~~

19           **SECTION 2. AMENDMENT.** Section 27-20-31 of the North Dakota Century Code is  
20 amended and reenacted as follows:

21           **27-20-31. Disposition of delinquent child.**

22           If the child is found to be a delinquent child, the court may make any of the following orders  
23 of disposition best suited to the child's treatment, rehabilitation, and welfare:

- 24           1.    Any order authorized by section 27-20-30 for the disposition of a deprived child;
- 25           2.    Placing the child on probation under the supervision of the director, probation officer,  
26                    or other appropriate officer of the court or of the court of another state as provided in  
27                    section 27-20-41 or the director of the county social service board under conditions  
28                    and limitations the court prescribes;
- 29           3.    Ordering the child to pay a fine if the delinquent act committed by the child constitutes  
30                    manslaughter resulting from the operation of a motor vehicle in violation of section  
31                    12.1-16-02; negligent homicide in violation of section 12.1-16-03; or driving or being in

1 actual physical control of a vehicle in violation of section 39-08-01, or an equivalent  
2 ordinance. The court may suspend the imposition of a fine imposed pursuant to this  
3 subsection upon such terms and conditions as the court may determine. Fines  
4 collected pursuant to this subsection must be paid into the county treasury for  
5 disposition pursuant to section 29-27-02.1;

- 6 4. Committing the child to the division of juvenile services or to another state department  
7 to which commitment of delinquent or unruly children may be made. When necessary,  
8 the commitment order may provide that the child initially be placed in a secure facility;
- 9 5. Ordering the child to make monetary restitution to the victim of the offense or to  
10 complete a specified number of hours of community service as determined by the  
11 court, or both;
- 12 6. Ordering the periodic testing for the use of illicit drugs or alcohol pursuant to rules or  
13 policies adopted by the supreme court; or
- 14 7. Ordering the child's participation in a juvenile drug court program.
- 15 ~~8. If a child is adjudicated delinquent for a violation of section 39-08-01 or equivalent  
16 ordinance, or if a child is found to have an alcohol concentration of at least two  
17 one-hundredths of one percent by weight at the time of performance of a test within  
18 two hours after driving or being in physical control of a motor vehicle, the juvenile court  
19 shall require the child to participate in the twenty-four seven sobriety program under  
20 chapter 54-12.~~

21 **SECTION 3.** A new section to chapter 27-20 of the North Dakota Century Code is created  
22 and enacted as follows:

23 **Twenty-four seven sobriety program - Participation.**

- 24 1. If a child is subject to informal adjustment under section 27-20-10, is found to be  
25 delinquent under section 27-20-31, or is found to be unruly under section 27-20-32,  
26 the juvenile court may, for a first violation or occurrence, and shall, for a second or  
27 subsequent violation or occurrence, require the child to participate in the twenty-four  
28 seven sobriety program under chapter 54-12:
  - 29 a. If the child is found to have violated section 39-08-01 or equivalent ordinance; or

1           b. If a child is found to have an alcohol concentration of at least two one-hundredths  
2           of one percent by weight at the time of performance of a test within two hours  
3           after driving or being in physical control of a motor vehicle.

4           2. If a child is subject to informal adjustment under section 27-20-10 and is required to  
5           participate in the twenty-four seven sobriety program, the period of participation may  
6           not exceed nine months.

7           3. If a child required to participate in the twenty-four seven sobriety program under this  
8           section fails to comply with program requirements without being excused, the testing  
9           site shall notify the juvenile court and refer the child to the juvenile court for further  
10           disposition. The child may not be detained or otherwise taken into custody without  
11           authorization from the juvenile court.

12           **SECTION 4. AMENDMENT.** Section 39-06-03 of the North Dakota Century Code is  
13 amended and reenacted as follows:

14           **39-06-03. No operator's license to certain individuals.**

15           The director may not issue an operator's license:

- 16           1. To an individual who is under the age of sixteen years, except that the director may  
17           issue an instructional permit under section 39-06-04, a restricted permit under section  
18           39-06-05, or a license under section 39-06-17.
- 19           2. To an individual whose license has been suspended or revoked in this state or in any  
20           other state during the suspension, except under section 39-06.1-03 or 39-06.1-11, or  
21           to any person whose license has been revoked, except under sections 39-06-35,  
22           39-06-36, and 39-06.1-11.
- 23           3. ~~To an individual who is a habitual drunkard, is a habitual user of narcotic drugs, or is a~~  
24           ~~habitual user of any other drug to a degree that renders the individual incapable of~~  
25           ~~safely operating a motor vehicle. The director has good cause to believe that an~~  
26           ~~individual is a habitual drunkard or drug user if the individual has three or more~~  
27           ~~convictions for violating section 39-08-01, or equivalent ordinance, or three or more~~  
28           ~~administrative suspensions under chapter 39-20 within a five-year period. An individual~~  
29           ~~who is a habitual drunkard or user may provide the director with adequate proof of the~~  
30           ~~removal of the habit which may include satisfactory completion of a licensed alcohol or~~  
31           ~~drug treatment program.~~

- 1           4. To an individual who has previously been adjudged to be afflicted with or suffering  
2           from any mental disability or disease and who has not at the time of application been  
3           restored to competency by the methods provided by law.
- 4           ~~5.4.~~ To an individual who is required by this chapter to take an examination, unless the  
5           individual has successfully passed such examination.
- 6           ~~6.5.~~ To an individual who is required under the laws of this state to deposit security or file  
7           proof of financial responsibility and who has not deposited the security or filed the  
8           proof.
- 9           ~~7.6.~~ To an individual if the director has good cause to believe that the individual by reason  
10          of physical or mental disability would not be able to operate a motor vehicle with safety  
11          .
- 12          ~~8.7.~~ To an individual when the director has good cause to believe that the operation of a  
13          motor vehicle on the highways by that individual would be inimical to public safety or  
14          welfare.

15           **SECTION 5. AMENDMENT.** Subdivision h of subsection 2 of section 39-06-49 of the North  
16   Dakota Century Code is amended and reenacted as follows:

- 17           h. Reinstatement after suspension is fifty dollars unless the suspension was the  
18           result of a suspension under subsection ~~4, 5, or 73, 4, or 6~~ of section 39-06-03 or  
19           subdivision b of subsection 1 of section 39-06-32, then the fee is twenty-five  
20           dollars, or unless the suspension was a result of a violation under section  
21           39-08-01 or chapter 39-20, then the fee is one hundred dollars.

22           **SECTION 6. AMENDMENT.** Section 39-08-01 of the North Dakota Century Code is  
23   amended and reenacted as follows:

24           **39-08-01. Persons under the influence of intoxicating liquor or any other drugs or**  
25   **substances not to operate vehicle - Penalty.**

- 26           1. A person may not drive or be in actual physical control of any vehicle upon a highway  
27           or upon public or private areas to which the public has a right of access for vehicular  
28           use in this state if any of the following apply:
- 29           a. That person has an alcohol concentration of at least eight one-hundredths of one  
30           percent by weight at the time of the performance of a chemical test within two  
31           hours after the driving or being in actual physical control of a vehicle.

- 1           b. That person is under the influence of intoxicating liquor.
- 2           c. That person is under the influence of any drug or substance or combination of
- 3           drugs or substances to a degree which renders that person incapable of safely
- 4           driving.
- 5           d. That person is under the combined influence of alcohol and any other drugs or
- 6           substances to a degree which renders that person incapable of safely driving.
- 7           e. That individual refuses to submit to any of the following:
- 8           (1) A chemical test, or tests, of the individual's blood, breath, or urine to
- 9           determine the alcohol concentration or presence of other drugs, or
- 10          combination thereof, in the individual's blood, breath, or urine, at the
- 11          direction of a law enforcement officer under section 39-06.2-10.2 if the
- 12          individual is driving or is in actual physical control of a commercial motor
- 13          vehicle; or
- 14          (2) A chemical test, or tests, of the individual's blood, breath, or urine to
- 15          determine the alcohol concentration or presence of other drugs, or
- 16          combination thereof, in the individual's blood, breath, or urine, at the
- 17          direction of a law enforcement officer under section 39-20-01; or
- 18          (3) An onsite screening test, or tests, of the individual's breath for the purpose
- 19          of estimating the alcohol concentration in the individual's breath upon the
- 20          request of a law enforcement officer under section 39-20-14.

21          The fact that any person charged with violating this section is or has been legally

22          entitled to use alcohol or other drugs or substances is not a defense against any

23          charge for violating this section, unless a drug which predominately caused

24          impairment was used only as directed or cautioned by a practitioner who legally

25          prescribed or dispensed the drug to that person. If the individual violated subdivisions

26          a, b, c, or d of this subsection and subdivision e of this subsection and the violations

27          arose from the same incident, for purposes of suspension or revocation of an

28          operator's license, the violations are deemed a single violation and the court shall

29          forward to the department of transportation only the conviction for driving under the

30          influence or actual physical control.

- 1           2.   a.   An individual who operates a motor vehicle on a highway or on public or private  
2                    areas to which the public has a right of access for vehicular use in this state who  
3                    refuses to submit to a chemical test, or tests, required under section  
4                    39-06.2-10.2, 39-20-01, or 39-20-14, is guilty of an offense under this section.
- 5           b.   An individual is not subject to an offense under this section for refusal to submit  
6                    to an onsite screening test under section 39-20-14 if the person submits to a  
7                    chemical test under section 39-20-01 or 39-06.2-10.2 for the same incident. Upon  
8                    the individual's refusal to submit to an onsite screening test, the police officer  
9                    shall inform the individual that the individual may remedy the refusal if the  
10                   individual takes a chemical test under section 39-20-01 or 39-06.2-10.2 for the  
11                    same incident.
- 12          3.   An individual violating this section or equivalent ordinance is guilty of a class B  
13                    misdemeanor for the first or second offense in a seven-year period, of a class A  
14                    misdemeanor for a third offense in a seven-year period, and of a class C felony for any  
15                    fourth or subsequent offense ~~regardless of the length of time since the previous~~  
16                    ~~offense~~within a fifteen-year period. The minimum penalty for violating this section is as  
17                    provided in subsection 5. The court shall take judicial notice of the fact that an offense  
18                    would be a subsequent offense if indicated by the records of the director or may make  
19                    a subsequent offense finding based on other evidence.
- 20          4.   Upon conviction of a second or subsequent offense within seven years under this  
21                    section or equivalent ordinance, the court may order the motor vehicle number plates  
22                    of all of the motor vehicles owned and operated by the offender at the time of the  
23                    offense to be destroyed by the office of the police officer that made the arrest. The  
24                    offender shall deliver the number plates to the court without delay at a time certain as  
25                    ordered by the court following the conviction. The court shall deliver the number plates  
26                    to the office and notify the department of the order. An offender who does not provide  
27                    the number plates to the court at the appropriate time is subject to revocation of  
28                    probation. The court may make an exception to this subsection, on an individual basis,  
29                    to avoid undue hardship to an individual who is completely dependent on the motor  
30                    vehicle for the necessities of life, including a family member of the convicted individual

1 and a coowner of the motor vehicle, or if the offender is participating in the twenty-four  
2 seven sobriety program.

3 5. A person convicted of violating this section, or an equivalent ordinance, must be  
4 sentenced in accordance with this subsection. ~~For purposes of this subsection, unless~~  
5 ~~the context otherwise requires, "drug court program" means a district court supervised~~  
6 ~~treatment program approved by the supreme court which combines judicial~~  
7 ~~supervision with alcohol and drug testing and chemical addiction treatment in a~~  
8 ~~licensed treatment program. The supreme court may adopt rules, including rules of~~  
9 ~~procedure, for drug courts and the drug court program.~~

10 a. (1) For a first offense, the sentence must include both a fine of at least five  
11 hundred dollars and an order for addiction evaluation by an appropriate  
12 licensed addiction treatment program.

13 (2) In addition, for a first offense when the convicted person has an alcohol  
14 concentration of at least sixteen one-hundredths of one percent by weight,  
15 the offense is an aggravated first offense and the sentence must include a  
16 fine of at least seven hundred fifty dollars and at least two days'  
17 imprisonment.

18 b. For a second offense within seven years, the sentence must include at least ten  
19 days' imprisonment, of which forty-eight hours must be served consecutively; a  
20 fine of one thousand five hundred dollars; an order for addiction evaluation by an  
21 appropriate licensed addiction treatment program; and at least ~~twelve~~  
22 ~~months~~three hundred sixty days' participation in the twenty-four seven sobriety  
23 program under chapter 54-12 as a mandatory condition of probation.

24 c. For a third offense within seven years, the sentence must include at least one  
25 hundred twenty days' imprisonment; a fine of at least two thousand dollars; an  
26 order for addiction evaluation by an appropriate licensed addiction treatment  
27 program; at least ~~one year~~three hundred sixty days' supervised probation; and  
28 at least three hundred sixty days' participation in the twenty-four seven sobriety  
29 program under chapter 54-12 as a mandatory condition of probation.

30 d. For a fourth or subsequent offense within fifteen years, the sentence must include  
31 at least one year and one day's imprisonment; a fine of at least two thousand



1           dollars; an order for addiction evaluation by an appropriate licensed treatment  
2           program; at least two years' supervised probation; and participation in the twenty-  
3           four seven sobriety program under chapter 54-12 as a mandatory condition of  
4           probation.

- 5           e. The imposition of sentence under this section may not be deferred under  
6           subsection 4 of section 12.1-32-02 for an offense subject to this section.
- 7           f. If the offense is subject to subdivision a or b, a municipal court or district court  
8           may not suspend a sentence, but may convert each day of a term of  
9           imprisonment to ten hours of community service for an offense subject to  
10          paragraph 2 of subdivision a. If the offense is subject to subdivision c, the district  
11          court may suspend a sentence, except for sixty days' imprisonment, under  
12          subsection 3 of section 12.1-32-02 on the condition that the defendant first  
13          undergo and complete an evaluation for alcohol and substance abuse treatment  
14          and rehabilitation and upon completion of the twenty-four seven sobriety  
15          program. If the offense is subject to subdivision d, the district court may suspend  
16          a sentence, except for one year's imprisonment, under subsection 3 of section  
17          12.1-32-02 on the condition that the defendant first undergo and complete an  
18          evaluation for alcohol and substance abuse treatment and rehabilitation. If the  
19          defendant is found to be in need of alcohol and substance abuse treatment and  
20          rehabilitation, the district court may order the defendant placed under the  
21          supervision and management of the department of corrections and rehabilitation  
22          and is subject to the conditions of probation under section 12.1-32-07. The district  
23          court may require the defendant to complete alcohol and substance abuse  
24          treatment and rehabilitation under the direction of the drug court program as a  
25          condition of probation in accordance with rules adopted by the supreme court. If  
26          the district court finds that a defendant has failed to undergo an evaluation or  
27          complete treatment or has violated any condition of probation, the district court  
28          shall revoke the defendant's probation and shall sentence the defendant in  
29          accordance with this subsection.
- 30          g. For purposes of this section, conviction of an offense under a law or ordinance of  
31          another state which is equivalent to this section must be considered a prior

- 1 offense if such offense was committed within the time limitations specified in this  
2 section.
- 3 h. If the penalty mandated by this section includes imprisonment or placement upon  
4 conviction of a violation of this section or equivalent ordinance, and if an  
5 addiction evaluation has indicated that the defendant needs treatment, the court  
6 may order the defendant to undergo treatment at an appropriate licensed  
7 addiction treatment program under subdivision g of subsection 1 of section  
8 12.1-32-02 and the time spent by the defendant in the treatment must be credited  
9 as a portion of a sentence of imprisonment or placement under this section. A  
10 court may not order the department of corrections and rehabilitation to be  
11 responsible for the costs of treatment in a private treatment facility.
- 12 i. If the court sentences an individual to the legal and physical custody of the  
13 department of corrections and rehabilitation, the department may place the  
14 individual in an alcohol treatment program designated by the department. Upon  
15 the individual's successful completion of the alcohol treatment program, the  
16 department shall release the individual from imprisonment to serve the remainder  
17 of the sentence of imprisonment on probation, which may include placement in  
18 another facility or treatment program. If an individual is placed in another facility  
19 or treatment program after release from imprisonment, the remainder of the  
20 individual's sentence of imprisonment must be considered time spent in custody.
- 21 j. If the individual has participated in the twenty-four seven sobriety program as a  
22 condition of pretrial release or for the purpose of receiving a temporary restricted  
23 operator's license under section 39-06.1-11, the sentencing court may give credit  
24 for the time the individual has already served on the twenty-four seven sobriety  
25 program when determining the amount of time the individual must serve on the  
26 twenty-four seven sobriety program for the purposes of probation, if that  
27 individual has not violated the twenty-four seven sobriety program before  
28 sentencing.
- 29 6. As used in subdivisions b and c of subsection 5, the term "imprisonment" includes  
30 house arrest. As a condition of house arrest, a defendant may not consume alcoholic  
31 beverages. The house arrest must include a program of electronic home detention and

1 the defendant shall participate in the twenty-four seven sobriety program. The  
2 defendant shall defray all costs associated with the electronic home detention. For an  
3 offense under subdivision b or c of subsection 5, no more than ninety percent of the  
4 sentence may be house arrest.

5 7. As used in this title, participation in the twenty-four seven sobriety program under  
6 chapter 54-12 means compliance with sections 54-12-27 through 54-12-31, and  
7 requires sobriety breath testing twice per day seven days per week or electronic  
8 alcohol monitoring, urine testing, or drug patch testing. The offender is responsible for  
9 all twenty-four seven sobriety program fees and the court may not waive the fees. For  
10 purposes of this section, the twenty-four seven sobriety program is a condition of  
11 probation and a court may not order participation in the program as part of the  
12 sentence.

13 **SECTION 7.** A new section to chapter 39-08 of the North Dakota Century Code is created  
14 and enacted as follows:

15 **Partial suspension of sentence for drug court completion.**

- 16 1. Notwithstanding section 39-08-01, all but ten days of the minimum mandatory  
17 sentence required for a defendant charged with a third or subsequent violation of  
18 section 39-08-01 may be suspended on the condition the defendant successfully  
19 completes a drug court program approved by the supreme court.
- 20 2. For purposes of this section, unless the context otherwise requires, "drug court  
21 program" means a district court-supervised treatment program approved by the  
22 supreme court which combines judicial supervision with alcohol and drug testing and  
23 chemical addiction treatment in a licensed treatment program. The supreme court may  
24 adopt rules, including rules of procedure, for drug courts and the drug court program.

25 **SECTION 8. AMENDMENT.** Subsection 2 of section 39-16-03.1 of the North Dakota  
26 Century Code is amended and reenacted as follows:

- 27 2. After the period of suspension ceases, an entry concerning a suspension under  
28 subsection ~~4, 5, 6, or 7~~ 3, 4, 5, or 6 of section 39-06-03 or subsection 2, 5, or 6 of  
29 section 39-06-32.

30 **SECTION 9. AMENDMENT.** Section 39-20-01 of the North Dakota Century Code is  
31 amended and reenacted as follows:

1           **39-20-01. Implied consent to determine alcohol concentration and presence of drugs.**

2           1. Any individual who operates a motor vehicle on a highway or on public or private  
3           areas to which the public has a right of access for vehicular use in this state is deemed  
4           to have given consent, and shall consent, subject to the provisions of this chapter, to a  
5           chemical test, or tests, of the blood, breath, or urine for the purpose of determining the  
6           alcohol concentration or presence of other drugs, or combination thereof, in the  
7           individual's blood, breath, or urine. As used in this chapter, the word "drug" means any  
8           drug or substance or combination of drugs or substances which renders an individual  
9           incapable of safely driving, and the words "chemical test" or "chemical analysis" mean  
10          any test to determine the alcohol concentration or presence of other drugs, or  
11          combination thereof, in the individual's blood, breath, or urine, approved by the  
12          director of the state crime laboratory or the director's designee under this chapter.

13          2. The test or tests must be administered at the direction of a law enforcement officer  
14          only after placing the individual, except individuals mentioned in section 39-20-03,  
15          under arrest and informing that individual that the individual is or will be charged with  
16          the offense of driving or being in actual physical control of a vehicle upon the public  
17          highways while under the influence of intoxicating liquor, drugs, or a combination  
18          thereof. For the purposes of this chapter, the taking into custody of a child under  
19          section 27-20-13 or an individual under twenty-one years of age satisfies the  
20          requirement of an arrest. The law enforcement officer shall determine which of the  
21          tests is to be used.

22          3. a. The law enforcement officer shall inform the individual charged that North Dakota  
23          law requires the individual to take the test to determine whether the individual is  
24          under the influence of alcohol or drugs; that refusal to take the test directed by  
25          the law enforcement officer is a crime punishable in the same manner as driving  
26          under the influence; and that refusal of the individual to submit to the test directed  
27          by the law enforcement officer may result in a revocation for a minimum of one  
28          hundred eighty days and up to three years of the individual's driving privileges.  
29          ~~The law enforcement officer shall determine which of the tests is to be used.~~

30          b. A test administered under this section is not admissible in any criminal or  
31          administrative proceeding to determine a violation of section 39-08-01 or this

1                   chapter if the law enforcement officer fails to inform the individual charged as  
2                   required under subdivision a.

- 3           4.   When an individual under the age of eighteen years is taken into custody for violating  
4           section 39-08-01 or an equivalent ordinance, the law enforcement officer shall attempt  
5           to contact the individual's parent or legal guardian to explain the cause for the custody.  
6           Neither the law enforcement officer's efforts to contact, nor any consultation with, a  
7           parent or legal guardian may be permitted to interfere with the administration of  
8           chemical testing requirements under this chapter. The law enforcement officer shall  
9           mail a notice to the parent or legal guardian of the minor within ten days after the test  
10          results are received or within ten days after the minor is taken into custody if the minor  
11          refuses to submit to testing. The notice must contain a statement of the test performed  
12          and the results of that test; or if the minor refuses to submit to the testing, a statement  
13          notifying of that fact. The attempt to contact or the contacting or notification of a parent  
14          or legal guardian is not a precondition to the admissibility of chemical test results or  
15          the finding of a consent to, or refusal of, chemical testing by the individual in custody.

16           **SECTION 10. AMENDMENT.** Subsection 2 of section 39-20-04 of the North Dakota  
17   Century Code is amended and reenacted as follows:

- 18          2.   A person's driving privileges are not subject to revocation ~~under subdivision a of~~  
19          ~~subsection 4~~ if all of the following criteria are met:
- 20           a.   An administrative hearing is not held under section 39-20-05;
- 21           b.   The person mails an affidavit to the director within twenty-five days after the  
22           temporary operator's permit is issued. The affidavit must state that the person:
- 23           (1)   Intends to voluntarily plead guilty to violating section 39-08-01 or equivalent  
24           ordinance within twenty-five days after the temporary operator's permit is  
25           issued;
- 26           (2)   Agrees that the person's driving privileges must be suspended as provided  
27           under section 39-06.1-10;
- 28           (3)   Acknowledges the right to a section 39-20-05 administrative hearing and  
29           section 39-20-06 judicial review and voluntarily and knowingly waives these  
30           rights; and

- 1           (4) Agrees that the person's driving privileges must be revoked as provided  
2           under this section without an administrative hearing or judicial review, if the  
3           person does not plead guilty within twenty-five days after the temporary  
4           operator's permit is issued, or the court does not accept the guilty plea, or  
5           the guilty plea is withdrawn;
- 6           c. The person pleads guilty to violating section 39-08-01 or equivalent ordinance  
7           within twenty-five days after the temporary operator's permit is issued;
- 8           d. The court accepts the person's guilty plea and a notice of that fact is mailed to  
9           the director within twenty-five days after the temporary operator's permit is  
10          issued; and
- 11          e. A copy of the final order or judgment of conviction evidencing the acceptance of  
12          the person's guilty plea is received by the director prior to the return or  
13          reinstatement of the person's driving privileges.

14          **SECTION 11. AMENDMENT.** Subsections 2 and 3 of section 39-20-05 of the North Dakota  
15 Century Code are amended and reenacted as follows:

- 16          2. If the issue to be determined by the hearing concerns license suspension for operating  
17          a motor vehicle while having an alcohol concentration of at least eight one-hundredths  
18          of one percent by weight or, with respect to an individual under twenty-one years of  
19          age, an alcohol concentration of at least two one-hundredths of one percent by weight,  
20          the hearing must be before a hearing officer assigned by the director and at a time and  
21          place designated by the director. The hearing must be recorded and its scope may  
22          cover only the issues of whether the arresting officer had reasonable grounds to  
23          believe the individual had been driving or was in actual physical control of a vehicle in  
24          violation of section 39-08-01 or equivalent ordinance or, with respect to an individual  
25          under twenty-one years of age, the individual had been driving or was in actual  
26          physical control of a vehicle while having an alcohol concentration of at least two  
27          one-hundredths of one percent by weight; whether the individual was placed under  
28          arrest, unless the individual was under twenty-one years of age and the alcohol  
29          concentration was less than eight one-hundredths of one percent by weight, then  
30          arrest is not required and is not an issue under any provision of this chapter; whether  
31          the individual was tested in accordance with section 39-20-01 or 39-20-03 and, if

1 applicable, section 39-20-02; and whether the test results show the individual had an  
2 alcohol concentration of at least eight one-hundredths of one percent by weight or,  
3 with respect to an individual under twenty-one years of age, an alcohol concentration  
4 of at least two one-hundredths of one percent by weight. For purposes of this section,  
5 a copy of a certified copy of an analytical report of a blood or urine sample from the  
6 director of the state crime laboratory or the director's designee, or electronically posted  
7 by the director of the state crime laboratory or the director's designee on the crime  
8 laboratory information management system and certified by a law enforcement officer  
9 or individual who has authorized access to the crime laboratory management system  
10 through the criminal justice data information sharing system or a certified copy of the  
11 checklist and test records from a certified breath test operator, and a copy of a certified  
12 copy of a certificate of the director of the state crime laboratory designating the  
13 director's designees, establish prima facie the alcohol concentration or the presence of  
14 drugs, or a combination thereof, shown therein. ~~Whether the individual was informed~~  
15 ~~that the privilege to drive might be suspended based on the results of the test is not an~~

- 17 3. If the issue to be determined by the hearing concerns license revocation for refusing to  
18 submit to a test under section 39-20-01 or 39-20-14, the hearing must be before a  
19 hearing officer assigned by the director at a time and place designated by the director.  
20 The hearing must be recorded. The scope of a hearing for refusing to submit to a test  
21 under section 39-20-01 may cover only the issues of whether a law enforcement  
22 officer had reasonable grounds to believe the person had been driving or was in actual  
23 physical control of a vehicle in violation of section 39-08-01 or equivalent ordinance or,  
24 with respect to a person under twenty-one years of age, the person had been driving  
25 or was in actual physical control of a vehicle while having an alcohol concentration of  
26 at least two one-hundredths of one percent by weight; whether the person was placed  
27 under arrest; and whether that person refused to submit to the test or tests. The scope  
28 of a hearing for refusing to submit to a test under section 39-20-14 may cover only the  
29 issues of whether the law enforcement officer had reason to believe the person  
30 committed a moving traffic violation or was involved in a traffic accident as a driver,  
31 whether in conjunction with the violation or the accident the officer has, through the

1 officer's observations, formulated an opinion that the person's body contains alcohol  
2 and, whether the person refused to submit to the onsite screening test. ~~Whether the~~  
3 ~~person was informed that the privilege to drive would be revoked or denied for refusal~~  
4 ~~to submit to the test or tests is not an issue.~~

5 **SECTION 12. AMENDMENT.** Section 39-20-15 of the North Dakota Century Code is amended  
6 and reenacted as follows:

7 **39-20-15. Restricted license upon twenty-four seven sobriety program participation.**

8 Any driver suspended under this chapter may elect to participate in the twenty-four seven  
9 sobriety program under chapter 54-12. The director may issue a temporary restricted license  
10 that takes effect after ~~fifteen~~fourteen days of the suspension have been served provided that the  
11 driver is not subject to any unrelated suspension. Notwithstanding any other provision of law, an  
12 individual may not receive a temporary restricted operator's license until after fourteen days  
13 after the administrative hearing on the offense under this chapter has been waived or held, or  
14 after fourteen days of the final appeal, whichever is longer.

15 **SECTION 13.** A new section to chapter 54-12 of the North Dakota Century Code is created  
16 and enacted as follows:

17 **Law enforcement acceptance of department of transportation action.**

18 A law enforcement agency shall accept, the same as if ordered by the court, an individual  
19 as part of the twenty-four seven program if the individual provides documentation that the  
20 individual will be issued a temporary restricted license by the department of transportation  
21 which is conditioned on participation in the twenty-four seven program.

22 **SECTION 14. RETROACTIVE APPLICATION.** Subsection 1 of section 39-01-08, as  
23 amended by section 6 of this Act, applies retroactively to violations of subdivision a, b, c, or d of  
24 subsection 1 of section 39-08-01 and subdivision e of subsection 1 of section 39-08-01 which  
25 arose from the same incident and which occurred on or after June 30, 2013.
