1 A BILL for an Act to provide an appropriation for defraying the expenses of the various divisions  
2 under the supervision of the director of the office of management and budget; to provide an  
3 exemption; and to provide a statement of legislative intent.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated out of any moneys in the general fund in the state  
7 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
8 other income, to the office of management and budget for the purpose of defraying the  
9 expenses of the office of management and budget, for the biennium beginning July 1, 2017,  
10 and ending June 30, 2019, as follows:

16       **SECTION 3. EXEMPTION.** The amount appropriated for the fiscal management division, as  
17 contained in section 1 of chapter 49 of the 2015 Session Laws is not subject to the provisions of  
18 section 54-44.1-11. Any unexpended funds from this appropriation are available for continued  
19 development and operating costs of the statewide systems, including accounting, management,  
20 and payroll, during the biennium beginning July 1, 2017, and ending June 30, 2019.

21       **SECTION 4. ESTIMATED INCOME - CAPITOL BUILDING FUND.** The estimated income  
22 line item in section 1 of this Act includes \$1,710,000 from the capitol building fund for repairs  
23 and projects in the capitol building.

24       **SECTION 5. INTENT.** Within the authority included in section 1 of this Act are the following  
25 grants and special items:
