1 A BILL for an Act to provide an appropriation for defraying the expenses of workforce safety and  
2 insurance.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated from special funds derived from the workforce safety  
6 and insurance fund in the state treasury, not otherwise appropriated, to workforce safety and  
7 insurance, for the biennium beginning July 1, 2017, and ending June 30, 2019, as follows:

17 **SECTION 2. HEALTH INSURANCE INCREASE.** The appropriation in Section 1 of this Act  
18 includes the sum of ~~\$775,925~~\$719,707 for increases in employee health insurance premiums  
19 from \$1,130 to ~~\$1,249~~\$1,241 per month.

20 **SECTION 3. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**  
21 **SIXTY-SIXTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding
