

SENATE BILL NO. 2013

1 A BILL for an Act to provide an appropriation for defraying the expenses of the commissioner of
2 university and school lands; to provide for transfers; and to provide for distributions from
3 permanent funds.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
6 as may be necessary, are appropriated from special funds derived from the state lands
7 maintenance fund, and the oil and gas impact grant fund in the state treasury, to the
8 commissioner of university and school lands for the purpose of defraying the expenses of the
9 commissioner of university and school lands, for the biennium beginning July 1, 2017, and
10 ending June 30, 2019, as follows:

20 **SECTION 2. ONE-TIME FUNDING.** The following amounts reflect the one-time funding
21 items approved by the sixty-fourth legislative assembly for the 2015-17 biennium:

1 **SECTION 3. APPROPRIATION LINE ITEM TRANSFERS.** Upon approval of the board of
2 university and school lands, the commissioner of university and school lands may transfer
3 between the various line items in section 1 of this Act, including transfers from the contingencies
4 line item to all other line items. The commissioner shall notify the office of management and
5 budget of each transfer made pursuant to this section.

6 **SECTION 4. DISTRIBUTIONS TO STATE INSTITUTIONS.** Pursuant to section 1 of
7 article IX of the Constitution of North Dakota, the board of university and school lands shall
8 distribute during the biennium beginning July 1, 2017, and ending June 30, 2019, the following
9 amounts, from the permanent funds managed for the benefit of the following entities:
