## ENGROSSED SENATE BILL NO. 2019

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state board for  
2 career and technical education.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the state board for career and technical education for the purpose of defraying  
8 the expenses of the state board for career and technical education, for the biennium beginning  
9 July 1, 2017, and ending June 30, 2019, as follows:

8       **SECTION 2. HEALTH INSURANCE INCREASE.** The salaries and wages line item in  
9 section 1 of this Act includes the sum of \$61,059 from the general fund for increases in  
10 employee health insurance premiums from \$1,130 to \$1,241 per month.

11       **SECTION 3. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**  
12 **SIXTY-SIXTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
13 items approved by the sixty-fourth legislative assembly for the 2015-17 biennium and the  
14 2017-19 one-time funding items included in the appropriation in section 1 of this Act:

23 The 2017-19 one-time funding amounts are not a part of the entity's base budget for the  
24 2019-21 biennium. The department of career and technical education shall report to the  
25 appropriations committees of the sixty-sixth legislative assembly on the use of this one-time  
26 funding for the biennium beginning July 1, 2017, and ending June 30, 2019.

27       **SECTION 4. ESTIMATED INCOME - FOUNDATION AID STABILIZATION FUND.** The  
28 estimated income line item in section 1 of this Act includes \$2,477,000 from the foundation aid  
29 stabilization fund for providing grants to school districts and area centers. Of this amount,  
30 \$50,000 is for the marketplace for kids program.

1 |       **SECTION 5. WORKFORCE TRAINING.** The workforce training line item in section 1 of this  
2 Act includes \$2 million from the general fund for the purpose of providing workforce training  
3 grants for the biennium beginning July 1, 2017, and ending June 30, 2019. Of this amount,  
4 \$1 million is to be distributed equally to Bismarck state college, lake region state college,  
5 Williston state college, and the North Dakota state college of science. The department of career  
6 and technical education shall award the remaining \$1 million of workforce training grants based  
7 on job training needs throughout North Dakota and may consider applications from tribally  
8 controlled community colleges when determining these grant awards. Tribally controlled  
9 community colleges must collaborate with at least one of the four higher education institutions  
10 listed in this section when submitting applications for workforce training grants.
