

**SECOND ENGROSSMENT  
with House Amendments  
REENGROSSED SENATE BILL NO. 2025**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of  
2 veterans' affairs.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the department of veterans' affairs for the purpose of defraying the expenses of  
8 the department of veterans' affairs, for the biennium beginning July 1, 2017, and ending  
9 June 30, 2019, as follows:

21 **SECTION 2. HEALTH INSURANCE INCREASES.** The salaries and wages line item in  
22 section 1 of this Act includes the sum of \$18,581, of which \$15,431 is from the general fund, for  
23 increases in employee health insurance premiums from \$1,130 to \$1,241 per month.

1       **SECTION 3. ONE-TIME FUNDING.** The following amounts reflect the one-time funding  
2 items approved by the sixty-fourth legislative assembly for the 2015-17 biennium:

8 The 2017-19 one-time funding amounts are not a part of the entity's base budget for the  
9 2019-21 biennium. The department of veterans' affairs shall report to the appropriations  
10 committees of the sixty-sixth legislative assembly on the use of this one-time funding for the  
11 biennium beginning July 1, 2017, and ending June 30, 2019.

12       **SECTION 4. APPROPRIATION - SERVICE DOGS.** There is appropriated out of any  
13 moneys in the general fund in the state treasury, not otherwise appropriated, the sum of  
14 \$25,000, or so much of the sum as may be necessary, to the department of veterans' affairs for  
15 the purpose of training up to two service dogs to assist North Dakota veterans with post  
16 traumatic stress disorder, for the biennium beginning July 1, 2017, and ending June 30, 2019.
