Senate Bill 2194 requires the board of each school district to provide or contract for the provision of an approved early childhood program beginning with the 2017-18 school year.

The bill adds a .50 factor for full-time equivalent students enrolled in an early childhood education program for purposes of determining state aid payments to school districts.  
 The assumptions used in this fiscal note are based on current year funding generated for kindergarten in the state school aid formula. Kindergarten grades are at roughly 9,000 students in ADM with an effective payment rate (after applying formula weights) of \$10,450.  
 If 9,000 full-time equivalent students participate, the cost for one year is \$47,000,000 or \$94,000,000 for a biennium.

The cost will vary directly with changes in student enrollment and changes to the state school aid formula.
