**SB 2341:** A BILL for an Act to create and enact a new section to chapter 39-21 of the North Dakota Century Code, relating to requiring mud flaps on certain vehicles; to amend and reenact section 39-06.1-09 of the North Dakota Century Code, relating to moving violations; and to provide a penalty.

disclosure statements; to repeal sections 16.1-08.1-02, 16.1-08.1-03, 16.1-08.1-03.1, 16.1-08.1-03.8, 16.1-08.1-03.9, 16.1-08.1-03.10, 16.1-08.1-03.11, 16.1-08.1-03.12, 16.1-08.1-03.13, and 16.1-08.1-04 of the North Dakota Century Code, relating to campaign disclosure statements; and to provide a penalty.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

#### **FIRST READING OF SENATE CONCURRENT RESOLUTIONS**

**SCR 4004:** A concurrent resolution to urge Congress to allow and support the use of thorium reactors in this state for the creation of energy and medical isotopes.

Was read the first time and referred to the **Energy and Natural Resources Committee**.

**SCR 4008:** A concurrent resolution urging the federal government to refrain from enacting regulations that threaten the reliability and affordability of electric power in North Dakota and to increase its support for research, development, and deployment for next generation carbon-based energy generation.

Was read the first time and referred to the **Energy and Natural Resources Committee**.
