- 1 A BILL for an Act to amend and reenact section 12.1-20-12.1, subsection 2 of section
- 2 12.1-20-12.2, and subsection 4 of section 12.1-27.2-01 of the North Dakota Century Code,
- 3 relating to indecent exposure toward minors, surreptitious intrusion, and sexual performances
- 4 by children; and to provide a penalty.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1. AMENDMENT.** Section 12.1-20-12.1 of the North Dakota Century Code is 7 amended and reenacted as follows:
- 8 **12.1-20-12.1. Indecent exposure.**

- 9 1. A person, with intent to arouse, appeal to, or gratify that person's lust, passions, or sexual desires, is quilty of a class A misdemeanor if that person:
 - a. Masturbates in a public place or in the presence of a minor; or
- b. Exposes one's penis, vulva, or anus in a public place or to a minor in a public or private place:
 - c. Exposes one's penis, vulva, or anus by unsolicited electronic means; or
- d. Exposes one's penis, vulva, or anus by any electronic means to a minor.
- A person is guilty of a class C felony if the person violates subsection 1 after a
 previous conviction for violating subsection 1, after a previous conviction for violating
 section 12.1-20-12.2, or after being required to register under section 12.1-32-15.
- 3. A person who commits a violation of <u>subdivision a or b of</u> subsection 1 within fifty feet [15.24 meters] of or on the real property comprising a public or nonpublic elementary, middle, or high school is guilty of a class C felony. A person who commits a violation of subsection 2 within fifty feet [15.24 meters] of or on the real property comprising a public or nonpublic elementary, middle, or high school is guilty of a class B felony.
 - 4. The act of a woman discreetly breastfeeding her child is not a violation of this section.
