

**FIRST ENGROSSMENT  
with Senate Amendments  
ENGROSSED HOUSE BILL NO. 1021**

1 A BILL for an Act to provide an appropriation for defraying the expenses of workforce safety and  
2 insurance.

**3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated from special funds derived from the workforce safety  
6 and insurance fund in the state treasury, not otherwise appropriated, to workforce safety and  
7 insurance, for the biennium beginning July 1, 2017, and ending June 30, 2019, as follows:

14 **SECTION 2. HEALTH INSURANCE INCREASE.** The appropriation in Section 1 of this Act  
15 includes the sum of \$719,707 for increases in employee health insurance premiums from  
16 \$1,130 to \$1,241 per month.

**17 SECTION 3. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**

18 **SIXTY-SIXTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
19 items approved by the sixty-fourth legislative assembly for the 2015-17 biennium and the  
20 2017-19 one-time funding items included in the appropriation in section 1 of this Act:

3 The 2017-19 one-time funding amounts are not a part of the entity's base budget for the  
4 2019-21 biennium. Workforce safety and insurance shall report to the appropriations  
5 committees of the sixty-sixth legislative assembly on the use of this one-time funding for the  
6 biennium beginning July 1, 2017, and ending June 30, 2019.
