- 1 A BILL for an Act to amend and reenact subsection 13 of section 14-15-01 and sections
- 2 14-15.1-01 and 14-15.1-04 of the North Dakota Century Code, relating to the investigation and
- 3 report by a child-placing agency and the definition of relative.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Subsection 13 of section 14-15-01 of the North Dakota
- 6 Century Code is amended and reenacted as follows:
- 7 13. "Relative" means any individual having the following relationship to the minor by
- 8 marriage, blood, or adoption: brother, sister, stepbrother, stepsister, first cousin, uncle,
- 9 aunt, or grandparent.
- 10 **SECTION 2. AMENDMENT.** Section 14-15.1-01 of the North Dakota Century Code is
- 11 amended and reenacted as follows:
- 12 **14-15.1-01. Definitions.**
- As used in this chapter, unless the context otherwise requires:
- "Birth parent" means the woman who gave birth to a child, any man alleged by that
- woman to be the biological father of that child, or any man presumed by law or
- judicially determined to be the biological father of that child.
- 17 2. "Child-placing agency" means an agency licensed under chapter 50-12.
- 18 3. "Court" means the district court of this state.
- 19 4. "Department" means the department of human services.
- 5. "Identified adoptive parent" means the person or persons eligible under section
- 21 14-15-03 to adopt a child and who has been selected by a birth parent to adopt a
- specific child.
