- 1 A BILL for an Act to create and enact a new section to chapter 54-52.1 of the North Dakota
- 2 Century Code, relating to public employee health benefits transparency; and to provide an
- 3 exemption.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 SECTION 1. A new section to chapter 54-52.1 of the North Dakota Century Code is created
 6 and enacted as follows:
- 7 <u>Health insurance benefits coverage Prescription drug coverage Transparency -</u>

8 Audits - Confidentiality.

- 9 <u>1.</u> If the prescription drug coverage component of the health insurance benefits coverage
- 10 <u>utilizes the services of a pharmacy benefits manager, the insurer's contract with the</u>
 11 <u>board must include the following terms:</u>
- 12a.The insurer shall provide the board with a copy of the insurer's current contract13with the pharmacy benefit management company and if the contract is revised or
- 14 <u>a new contract is entered, within thirty days of the change the insurer shall</u>
- 15 provide the board with the revision or new contract.
- 16 b. The health insurer or pharmacy benefit manager shall provide with each invoice
 17 statement and for each annual audit a complete set of electronic prescription
 18 coverage claims data reflecting all submitted claims, including information fields
 19 identified by the board.
- 20 <u>c.</u> The health insurer shall provide the board a list of all programs that will be
 21 implemented or modified, including prior authorization programs, step therapy
- 22 programs, quality limit programs, and mandatory generic programs. The list must
- 23 include the drugs in each program and the specifics about each drug.

1		<u>d.</u>	<u>(1)</u>	The board may retain an auditor of the board's choice which is not a
2				competitor of the pharmacy benefit manager, a pharmaceutical
3				manufacturer representative, or any retail, mail, or specialty drug pharmacy
4				representative or vendor.
5			<u>(2)</u>	The board may conduct annual audits to verify the pharmacy benefit
6				manager is satisfying the terms of its contract with the health insurer;
7				assess the costs resulting from the health insurer's contract with the
8				pharmacy benefit manager and make recommendations as to amendments
9				in that contract which would decrease costs; and assess the programs
10				being implemented and make recommendations as to improvements in
11				those programs which would decrease cost or improve plan beneficiaries'
12				health care treatment.
