1 A BILL for an Act to amend and reenact sections 2-05-11 and 2-05-11.3 of the North Dakota
2 Century Code, relating to aircraft registration.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 2-05-11 of the North Dakota Century Code is amended
5 and reenacted as follows:

6 **2-05-11. Aircraft registration - Fees.**

7 ~~The following procedures governing fees and registration apply:~~

8 1. Except as provided in section 2-05-11.3, every aircraft or ultralight vehicle operating
9 within this state for more than thirty days must be registered with the aeronautics
10 commission for each calendar year in which the aircraft or ultralight vehicle is operated
11 within this state, subject to rules adopted by the commission. The commission shall
12 charge a fee for each ~~such~~annual registration. The following fees apply:

12 ~~The fees must be reduced ten percent each year after the initial registration, or if the~~
13 ~~aircraft is one year old or older and being registered for the first time, the fees must be~~
14 ~~reduced ten percent for each year after the year of manufacture of the aircraft, until~~
15 ~~the fee reaches a figure equal to fifty percent of the original registration fee, which is~~
16 ~~the fee each year thereafter.~~ For aircraft that become based in the state after June
17 thirtieth of a calendar year, the registration fee is one-half the annual fee.

- 18 2. All weights must be based upon the maximum permissible take-off weight, except that
19 the weights must be empty weights for all ultralight vehicles which are not certificated
20 for maximum permissible take-off weight.
- 21 3. The aeronautics commission may charge a reasonable cost of service fee for
22 registration of aircraft operated by state agencies, political subdivisions, aviation
23 schools operated by state institutions of higher education, or the civil air patrol in lieu
24 of the regular registration fee.
- 25 4. All fees received under this section must be deposited in the aeronautics commission
26 special fund.

27 **SECTION 2. AMENDMENT.** Section 2-05-11.3 of the North Dakota Century Code is
28 amended and reenacted as follows:

1 **2-05-11.3. Fee for a permanent registration - Issuance of registration decal -**

2 **Disposition of fee.**

3 The fee for a permanent registration under section 2-05-11.2 is ~~eighty-five~~one hundred
4 twenty-five dollars. The commission shall prepare a distinctive decal denoting permanent
5 registration under section 2-05-11.2. The fee must be deposited in the aeronautics commission
6 special fund.
