- 1 A BILL for an Act to amend and reenact section 23-01-39 of the North Dakota Century Code,
- 2 relating to the immunization program.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 23-01-39 of the North Dakota Century Code is

5 amended and reenacted as follows:

6 23-01-39. Immunization program - Provider choice - Purchasing.

- 7 1. As used in this section:
- 8 a. "Department" means the state department of health.
- b. "North Dakota immunization advisory committee" means the group of private
 health care providers, local public health units, department staff, and other
 applicable individuals which makes immunization and vaccine selection
 recommendations to the North Dakota immunization program.
- c. "North Dakota immunization program" means the program administered by the
 department to provide vaccinations to North Dakota children consistent with state
 and federal law.
- d. "Program-eligible child" means any child, who is under nineteen years of age,
 whose custodial parent or legal guardian resides in this state.
- e. "Vaccine" means any vaccine recommended by the federal advisory committee
 on immunization practices of the centers for disease control and prevention.
- f. "Vaccines for children program" is a federally funded program that provides
 vaccines at no cost to eligible children pursuant to section 1928 of the Social
 Security Act [42 U.S.C. 1396s].
- 23 2. As part of the North Dakota immunization program:

1	a.	The	department shall implement a provider choice system as part of the state's
2		imple	ementation of the vaccines for children program. This provider choice system
3		must	provide a health care provider participating in the state's vaccines for
4		child	ren program or in any other immunization program for children, adolescents,
5		or ad	lults which is administered through the state using federal or state funds,
6		may	select any licensed vaccine, including combination vaccines, and any
7		dosa	ge forms that have in effect a recommendation from the federal advisory
8		comr	mittee on immunization practices. This subsection does not apply in the
9		even	t of a <u>shortage or delay in vaccine availability,</u> disaster, public health
10		emer	rgency, terrorist attack, hostile military or paramilitary action, or extraordinary
11		law e	enforcement emergency.
12	b.	The	department shallmay establish a program through which the department
13		purcl	hases vaccines through the federal vaccine purchasing contract.
14		(1)	The department shall supply public health units with the purchased
15			vaccines. A public health unit that receives vaccines under this subdivision
16			shall administer the vaccines to program-eligible children.
17		(2)	A public health unit that receives vaccines under this purchasing program
18			may not bill an insurer for the cost of the vaccine but may charge an
19			administration fee.
20		(3)	The department shall fund this purchasing program through participation in
21			the vaccines for children program, the federal section 317 vaccine program,
22			and state funds appropriated for this purpose. If it appears there will be
23			inadequate funds to fund this purchasing program, the department shall
24			petition the emergency commission for a transfer from the state contingency
25			fund. The emergency commission may grant the transfer request, or so
26			much thereof as may be necessary, to fund this purchasing program.
