- 1 A BILL for an Act to create and enact subsection 8 to section 57-01-02.1 of the North Dakota
- 2 Century Code, relating to city and county sales and use tax refunds.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1.** Subsection 8 to section 57-01-02.1 of the North Dakota Century Code is created and enacted as follows:
 - 8. a. For purchases made after June 30, 2017, a claim for credit or refund of tax paid over the city or county cap or threshold under this section must be filed with the tax commissioner within twenty-four months from the date of the invoice, cash register receipt, or other sales documentation indicating the date of purchase.
 - <u>b.</u> A person required to file a return under chapter 57-39.2 or 57-40.2 may claim a credit for tax paid over the city or county cap or threshold under subsection 5.
 The credit must be taken against any tax due on a timely filed return which is due within twenty-four months from the date of the invoice, cash register receipt, or other sales documentation indicating the date of purchase.
 - c. For purchases made before July 1, 2017, a claim for credit or refund of tax paid over the city or county cap or threshold under subsection 5 must be filed with the tax commissioner no later than June 30, 2019.
 - d. If the tax commissioner determines a refund is due under this section, the tax commissioner shall certify the amount of the refund and the name of the payee to the office of management and budget, who then shall draw a warrant on the general fund in the amount specified payable to the named payee.
