## ENGROSSED HOUSE BILL NO. 1011

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the highway patrol;  
2 to create and enact section 39-03-09.1 of the North Dakota Century Code, relating to job  
3 shadowing with the highway patrol; to provide for a transfer; and to provide an exemption.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated out of any moneys in the general fund in the state  
7 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
8 other income, to the highway patrol for the purpose of defraying the expenses of the  
9 highway patrol, for the biennium beginning July 1, 2019, and ending June 30, 2021, as  
10 follows:

16 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO SIXTY-**  
17 **SEVENTH LEGISLATIVE ASSEMBLY.** The following amounts reflect one-time funding items  
18 approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the one-time  
19 funding items included in the appropriation in section 1 of this Act:

8       The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget  
9 for the 2021-23 biennium. The highway patrol shall report to the appropriations committees of  
10 the sixty-seventh legislative assembly on the use of this one-time funding for the biennium  
11 beginning July 1, 2019, and ending June 30, 2021.

12       **SECTION 3.** Section 39-03-09.1 of the North Dakota Century Code is created and enacted  
13 as follows:

14       **39-03-09.1. Job shadowing.**

15       For purposes of education and community outreach, and to promote public trust, the  
16 superintendent may permit a nonmember of the highway patrol to participate in job shadowing  
17 activities, including:

- 18       1. Participating in a ride-along program with a member of the highway patrol while on  
19       duty;
- 20       2. Operating a highway patrol motor vehicle on a closed course under the supervision of  
21       a member of the highway patrol; and
- 22       3. Discharging a firearm owned and used by the highway patrol while at a training facility  
23       and under the supervision of a member of the highway patrol.

24       **SECTION 4. SPECIAL FUNDS TRANSFER - HIGHWAY TAX DISTRIBUTION FUND.** The  
25 estimated income line item in section 1 of this Act includes the sum of \$7,089,982, or so much  
26 of the sum as may be necessary, from the state highway tax distribution fund which may be  
27 transferred at the direction of the superintendent of the highway patrol for the purpose of  
28 defraying the expenses of the highway patrol during the biennium beginning July 1, 2019, and  
29 ending June 30, 2021.

30       **SECTION 5. MOTOR CARRIER ELECTRONIC PERMIT TRANSACTION FUND.** The  
31 estimated income line item in section 1 of this Act includes \$3,349,489 from the motor carrier

1 electronic permit transaction fund for the purpose of defraying various expenses associated with  
2 the issuance of permits and other nonenforcement motor carrier and administrative activities,  
3 including the purchase of equipment and the construction of an addition to the indoor shooting  
4 range, during the biennium beginning July 1, 2019, and ending June 30, 2021.

5 **SECTION 6. EXEMPTION.** The amount of \$28,171 appropriated for an aircraft engine  
6 overhaul in the special funds line item in section 2 of chapter 23 of the 2017 Session Laws is  
7 not subject to section 54-44.1-11 and may be continued into the biennium beginning July 1,  
8 2019, and ending June 30, 2021.

9 **SECTION 7. PAYMENTS TO HIGHWAY PATROL OFFICERS.** Each patrol officer of the  
10 state highway patrol is entitled to receive from funds appropriated in section 1 of this Act an  
11 amount not to exceed \$200 per month for the biennium beginning July 1, 2019, and  
12 ending June 30, 2021. The payments are in lieu of reimbursement for meals and other  
13 expenses, except lodging, while in travel status within the state of North Dakota or while at the  
14 patrol officers' respective home stations. The amounts must be paid at the time and in the  
15 same manner as salaries are paid to members of the highway patrol and may be paid without  
16 the presentation of receipts or other memorandums.
