1 A BILL for an Act to provide an appropriation for defraying the expenses of the insurance  
2 commissioner; and to provide an appropriation for the distribution of funds from the insurance  
3 tax distribution fund.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated from special funds derived from federal funds and other  
7 income, to the insurance commissioner for the purpose of defraying the expenses of the  
8 insurance commissioner, for the biennium beginning July 1, 2019, and ending June 30, 2021,  
9 as follows:

16 **SECTION 2. APPROPRIATION.** There is appropriated out of any moneys in the insurance  
17 tax distribution fund in the state treasury, not otherwise appropriated, the sum of \$15,064,086 or  
18 so much of the sum as may be necessary, to the insurance commissioner for the purpose of  
19 providing payments, in accordance with provisions of section 18-04-05, to North Dakota fire  
20 departments in the amount of \$14,235,561 and payments to the North Dakota firefighter's  
21 association in the amount of \$828,525 for the biennium beginning July 1, 2019, and ending  
22 June 30, 2021.

1       **SECTION 3. BONDING FUND.** Section 1 of this Act includes \$52,004 from the state  
2 bonding fund to pay bonding fund administrative expenses for the biennium beginning July 1,  
3 2019, and ending June 30, 2021.

4       **SECTION 4. FIRE AND TORNADO FUND.** Section 1 of this Act includes \$1,797,218 from  
5 the state fire and tornado fund to pay fire and tornado fund administrative expenses, for the  
6 biennium beginning July 1, 2019, and ending June 30, 2021.

7       **SECTION 5. UNSATISFIED JUDGMENT FUND.** Section 1 of this Act includes \$29,703  
8 from the state unsatisfied judgment fund to pay unsatisfied judgment fund administrative  
9 expenses for the biennium beginning July 1, 2019, and ending June 30, 2021.

10       **SECTION 6. PETROLEUM RELEASE COMPENSATION FUND.** Section 1 of this Act  
11 includes \$119,472 from the petroleum release compensation fund to pay petroleum release  
12 compensation fund administrative expenses for the biennium beginning July 1, 2019, and  
13 ending June 30, 2021.
