## ENGROSSED SENATE BILL NO. 2018

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state historical  
2 society; and to provide for a report to the legislative assembly.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the state historical society for the purpose of defraying the expenses of the  
8 state historical society, for the biennium beginning July 1, 2019, and ending June 30, 2021, as  
9 follows:

22 **SECTION 2. ONE-TIME FUNDING - REPORT.** The following amounts reflect the one-time  
23 funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the  
24 2019-21 biennium one-time funding items included in the appropriation in section 1 of this Act:

10 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget  
11 for the 2019-21 biennium. The state historical society shall report to the appropriations  
12 committees of the sixty-seventh legislative assembly on the use of this one-time funding for the  
13 biennium beginning July 1, 2019, and ending June 30, 2021.

14 **SECTION 3. REVOLVING FUND - APPROPRIATION.** All fees collected by the state  
15 historical society and deposited in the revolving fund established pursuant to section 55-03-04  
16 are appropriated to the state historical society for the purposes provided in chapter 55-03, for  
17 the biennium beginning July 1, 2019, and ending June 30, 2021.

18 **SECTION 4. GIFTS, GRANTS, AND BEQUESTS - APPROPRIATION.** All gifts, grants,  
19 devises, bequests, donations, and assignments received by the state historical society and  
20 deposited with the state treasurer pursuant to section 55-01-04 are appropriated to the state  
21 historical society for the purposes provided in section 55-01-04, for the biennium beginning  
22 July 1, 2019, and ending June 30, 2021.

23 **SECTION 5. WHITESTONE HILL NATIVE MEMORIAL - MATCHING FUNDS.** Of the funds  
24 appropriated in the capital assets line item in section 1 of this Act, \$200,000 from the general  
25 fund and \$200,000 from other funds is for the Whitestone hill native memorial. The state  
26 historical society may spend \$25,000 of the general fund appropriation after June 30, 2019, for  
27 the planning and design of a Whitestone hill native memorial and the state historical society  
28 may spend, on a dollar-for-dollar matching basis from other nonstate funds, the remaining  
29 \$175,000 from the general fund for the biennium beginning July 1, 2019, and ending June 30,  
30 2021.
