1 A BILL ~~for an Act to amend and reenact section 39-10-51 of the North Dakota Century Code,~~  
2 ~~relating to unattended motor vehicles; and to provide a penalty~~ for an Act to amend and reenact  
3 section 39-06.1-08 of the North Dakota Century Code, relating to nonmoving violations; and to  
4 repeal section 39-10-51 of the North Dakota Century Code, relating to unattended motor  
5 vehicles.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 ~~— **SECTION 1. AMENDMENT.** Section 39-10-51 of the North Dakota Century Code is-~~  
8 ~~amended and reenacted as follows:~~

9 ~~— **39-10-51. Unattended motor vehicle.**~~

10 ~~— No person~~ An individual ~~driving or in charge of a motor vehicle may not permit it~~ the vehicle  
11 ~~to stand unattended without first stopping the engine, effectively setting the brake thereon~~ on the  
12 ~~vehicle, and, when standing upon any grade, turning the front wheels of the vehicle must be~~  
13 ~~turned to the curb or side of the highway or street.~~

14 **SECTION 1. AMENDMENT.** Section 39-06.1-08 of the North Dakota Century Code is  
15 amended and reenacted as follows:

16 **39-06.1-08. Nonmoving violation defined.**

17 For the purposes of section 39-06.1-06, a "nonmoving violation" means:

- 18 1. A violation of section 39-04-11, subsection 1 of section 39-04-37 by an individual by  
19 becoming a resident of this state, subsection 4 of section 39-06-17, and section  
20 39-06-44, 39-06-45, 39-10-47, 39-10-49, 39-10-50, ~~39-10-51~~, 39-10-54.1, 39-21-08,  
21 39-21-10, 39-21-11, or 39-21-14, or a violation of any municipal ordinance equivalent  
22 to the foregoing sections.

1        2. A violation, discovered at a time when the vehicle is not actually being operated, of  
2        section 39-21-03, 39-21-05, 39-21-13, 39-21-19, 39-21-32, 39-21-37, 39-21-39, or  
3        39-21-44.2, or a violation of any municipal ordinance equivalent to the foregoing  
4        sections.

5        **SECTION 2. REPEAL.** Section 39-10-51 of the North Dakota Century Code is repealed.
