3 ~~43-09-16, 43-09-18, 43-09-20, 43-09-21, 43-09-22, 43-09-23, and 43-09-25 of the North Dakota~~  
4 ~~Century Code, relating to the regulation of electricians and power-limited technicians; and to~~  
5 ~~provide a penalty~~ to provide for a legislative management study of the scope of practice and  
6 regulation of electricians.

7 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

8 ~~— **SECTION 1. AMENDMENT.** Section 43-09-01 of the North Dakota Century Code is~~  
9 ~~amended and reenacted as follows:~~

10 ~~— **43-09-01. Definitions.**~~

11 ~~— In this chapter, unless the context or subject matter otherwise requires:~~

12 ~~— 1. "Apprentice" means an apprentice electrician or power limited technician apprentice~~  
13 ~~registered by the board.~~

14 ~~— 2. "Apprentice electrician" means a person an individual learning the trade under the~~  
15 ~~personal supervision of a state-licensed electrician.~~

16 ~~— 2.3. "Board" means the state electrical board.~~

17 ~~— 3.4. "Class B electrician" means a person having an individual with the necessary~~  
18 ~~qualifications, training, and technical knowledge to wire, install, and repair electrical~~  
19 ~~apparatus and equipment in accordance with the standard rules and regulations~~  
20 ~~governing such work, and shall have having eighteen months' experience in farmstead~~  
21 ~~or residential wiring, and shall have having passed an examination before the state~~  
22 ~~electrical board based upon the national electrical code as it applies to farmstead or~~  
23 ~~residential wiring.~~

1 ~~4.5.~~ "Journeyman electrician" means a person having an individual with the necessary  
2 qualifications, training, and technical knowledge to wire, install, and repair electrical  
3 apparatus and equipment and power limited systems in accordance with the standard  
4 rules and regulations governing such work.

5 ~~5.6.~~ "Licensee" means an individual who holds a valid license issued by the board.

6 ~~7.~~ "Master electrician" means a person having an individual with the necessary  
7 qualifications, training, experience, and technical knowledge to plan, lay out, and  
8 supervise the installation and repair of electrical wiring apparatus, and equipment for  
9 electric light, heat, and power, and power limited systems, in accordance with the  
10 standard rules and regulations governing such work.

11 ~~8.~~ "Power limited technician contractor" means an individual with the necessary  
12 qualifications, training, experience, and technical knowledge to plan, lay out, and  
13 supervise the installation and repair of power limited systems in accordance with the  
14 standard rules and regulations governing such work.

15 ~~9.~~ "Power limited technician" means an individual with the necessary qualifications,  
16 training, experience, and technical knowledge to wire, install, and repair power limited  
17 systems apparatus and equipment in accordance with the standard rules and  
18 regulations governing such work.

19 ~~10.~~ "Power limited technician apprentice" means an individual learning the trade under the  
20 personal supervision of a state licensed power limited technician.

21 ~~**SECTION 2. AMENDMENT.**~~ Section 43-09-05 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 ~~**43-09-05. Powers and duties of state electrical board – Biennial report.**~~

24 ~~The board shall adopt a seal and may adopt reasonable rules to carry out this chapter. The~~  
25 ~~board may submit a biennial report to the governor and the secretary of state in accordance~~  
26 ~~with section 54-06-04. The board shall appoint qualified inspectors. Upon receipt of notice of~~  
27 ~~completion of any electrical wiring installation involving a value of five hundred dollars or more,~~  
28 ~~the inspectors shall inspect the electrical or power limited systems installation and approve or~~  
29 ~~condemn that installation. The inspector shall make a report of the inspection on forms~~  
30 ~~prescribed by the board.~~

1 ~~SECTION 3. AMENDMENT.~~ Section 43-09-09 of the North Dakota Century Code is

8 ~~in the installation of wiring, apparatus, or equipment for electric light, heat, or power,~~  
9 ~~shall apply to the board for a license and power limited systems, unless licensed by the~~

11 ~~2. The board shall examine the an applicant for licensure and if, upon a technical and~~  
12 ~~practical examination, the applicant is found to possess the required knowledge and~~  
13 ~~skill and to be versed in the laws of electricity, the applicant board shall be issued issue~~  
14 ~~to the applicant a license in the class for which the applicant was examined. The~~  
15 ~~license shall must be signed by the president and the secretary of the board and~~  
16 ~~attested by the seal of the board.~~

17 ~~3. Each licensee or permitholder shall report that person's individual's licensing or~~  
18 ~~renewals to the electrical inspector, if there is one, in the municipality in which that~~

25 ~~power limited systems services without being licensed as or being associated with a~~  
26 ~~class B or, master electrician, or power limited technician contractor unless that person~~  
27 ~~intends to contract the electrical these services with a licensed electrical or power~~  
28 ~~limited technician contractor.~~

29 ~~2. If a person associates with a class B or, master electrician, or power limited technician~~  
30 ~~contractor under subsection 1 and that association ends, that person is jointly and~~

1           ~~severally liable for any electrical or power limited systems services contracts entered~~  
2           ~~under that association.~~

3     ~~3. a. A person violating this section is guilty of a class B misdemeanor for a first~~  
4           ~~conviction, but no fine in excess of one hundred dollars and no term of~~

30           ~~wiring, apparatus, and equipment, which This experience may not be obtained in~~  
31           ~~less than three years.~~

1 ~~\_\_\_\_\_ b. Effective for an applicant who registered with the board as an apprentice after~~  
2 ~~January 31, 2008, completed at least one of the following:~~

3 ~~\_\_\_\_\_ (1) Successfully completed apprenticeship training approved by the federal~~  
4 ~~bureau of apprenticeship and training and completed eight thousand hours'~~  
5 ~~experience in installing and repairing electrical wiring, apparatus, and~~  
6 ~~equipment.~~

7 ~~\_\_\_\_\_ (2) Successfully completed an appropriate course of study, which may not be~~  
8 ~~less than two years or the equivalent of two years, at a board-approved~~  
9 ~~institution of higher education and completed eight thousand hours'~~  
10 ~~experience in installing and repairing electrical wiring, apparatus, and~~  
11 ~~equipment. The board may determine equivalent hours of education that~~

20 ~~systems wiring, apparatus, and equipment. This experience may not be obtained~~

22 ~~\_\_\_\_\_ b. Successfully completed an appropriate course of study, which may not be less~~  
23 ~~than one year or the equivalent training as provided by the industry in experience~~  
24 ~~in installing and repairing power limited systems wiring, apparatus, and~~  
25 ~~equipment. The board may determine equivalent hours of education that may be~~  
26 ~~applied as a credit against the six thousand hours' experience requirement under~~  
27 ~~this subsection.~~

5 ~~company applies for a license, an officer or manager thereof shall make the~~  
6 ~~application and take the oath and submit evidence as to experience.~~

7 ~~— 2. If an applicant for a power limited technician contractor license is a company that is~~  
8 ~~currently installing power limited systems as of July 31, 2020, and one individual~~  
9 ~~related to the company meets the requirements of subdivision a of subsection 5 of~~  
10 ~~section 43-09-11, the board shall issue the license without requiring passage of an~~  
11 ~~examination administered by the board.~~

15 ~~— Examination and annual license fees required to be paid for an electrician's or power limited~~

20 ~~— An apprentice electrician shall register with the state electrical board within the first six~~  
21 ~~months of employment and shall pay an annual registration fee in an amount set by the board.~~  
22 ~~An apprentice electrician may work on installations only under the personal supervision of a~~  
23 ~~licensed electrician as provided in section 43-09-18.~~

5 one year, but may be renewed without examination upon the payment of the proper  
6 fee. If the licensee fails to renew the license for a period of three consecutive years or  
7 more, the licensee is required to appear for re-examination. The state electrical board  
8 may deny, suspend, revoke, or refuse to renew any license issued or applied for under  
9 the provisions of this chapter for any of the following reasons:

10 ~~1.a.~~ Failure or refusal to maintain or adhere to the minimum standards set forth in the  
11 electrical code referred to in section 43-09-21.

12 ~~2.b.~~ Any cause for which the issuance of the license could have been refused had  
13 it the cause then existed and been known to the board.

14 ~~3.c.~~ Commitment of any act of gross negligence, incompetency, or misconduct in the  
15 practice of a master or journeyman electrician or the business of an electrical  
16 contractor the profession regulated under this chapter.

17 ~~4.d.~~ Material misstatement, misrepresentation, or fraud in obtaining the license.

18 ~~5.e.~~ After due notice, failed or refused to correct, within the specified time, any  
19 electrical installation not in compliance with the provisions of this chapter.

20 ~~6.f.~~ Failure or refusal to make deposit or acquire public liability insurance as required  
21 by sections 43-09-14 and 43-09-20.

22 ~~7.g.~~ Failure to repay or enter into a written contract for repayment, under a payment  
23 schedule acceptable to the board, of money disbursed from the fund as provided  
24 under section 43-09-14, or failure to make timely payments under a payment  
25 contract entered into under the board's policy for administering the undertaking

7 ~~After March 31, 1990, each An applicant for renewal of an electrician's or power limited~~  
8 ~~technician's license pursuant to section 43-09-15 must have successfully completed prior~~  
9 ~~thereto at least four hours, and thereafter eight hours each biennium, of continuing education~~  
10 ~~relating to the standards set forth in section 43-09-21 or as otherwise prescribed by the board.~~  
11 ~~The board may not require more than sixteen hours of continuing education in each biennium.~~  
12 ~~The board shall conduct education sessions for licensees each year at not less fewer than six~~  
13 ~~locations throughout the state. Attendance at such sessions, or attendance at other education~~  
14 ~~sessions certified by the board as approved, fulfills the educational requirements of this section.~~  
15 ~~The board may charge a fee to licensees for attendance at the education sessions at an~~

25 ~~distribution of electrical energy. This exemption terminates at the first point of service~~  
26 ~~attachment, except for the installing or testing of electric meters and measuring~~  
27 ~~devices and the maintenance of their service of electric meters and measuring~~  
28 ~~devices.~~

29 ~~2. Employees of a company public utility that operates or installs telephone and radio~~  
30 ~~communication systems when while engaged in work pertaining directly to the~~  
31 ~~installation of telephone and radio communication conductors on premises where the~~



1 installations are made for use exclusively for the transmission of telephone and radio-  
2 signals.

3 ~~3. Employees of dealers in household appliances, such as room air conditioners, clothes-~~  
4 ~~dryers, dishwashers, freezers, garbage disposals, refrigerators, stoves, washing~~  
5 ~~machines, water heaters, and similar appliances when while such employees are~~  
6 ~~installing and connecting such appliances to an existing electrical receptacle.~~

7 ~~4. A representative of a manufacturing firm that is installing or modifying controls of~~  
8 ~~wiring solely on industrial machinery that is for use by the firm itself, and performed by~~  
9 ~~or under the direction of a registered professional engineer who issues a~~  
10 ~~state-accepted evaluation, which is to be maintained with the equipment.~~

28 ~~2. A class B electrician, as herein defined, is authorized to may enter into a contract,~~

9 ~~of the existence of public liability insurance with a licensed insurance carrier, with~~

12 ~~hundred thousand dollars for a master electrician,; and~~

13 ~~b. For a class B electrician, at least two hundred fifty thousand dollars for a class B-~~

17 ~~**43-09-21. Standards for electrical wiring and equipment.**~~

18 ~~All electrical and power limited systems wiring, apparatus, or equipment must comply with~~  
19 ~~the rules of the board made under authority of the laws of this state and in conformity with the~~  
20 ~~approved methods of construction for safety to life and property. The regulations in the national~~  
21 ~~electrical code and the national electrical safety code, as approved by the American national~~  
22 ~~standards institute, are prima facie evidence of these approved methods. Any municipality may~~  
23 ~~make more stringent requirements. An electrical or power limited systems installation may not~~  
24 ~~be connected for use until proof has been furnished to the person, firm, corporation, or limited~~  
25 ~~liability company supplying electrical energy that there is compliance with the applicable~~  
26 ~~regulations. The manufacturer of a new manufactured building or modular unit shall make any~~  
27 ~~changes required for the proof within fourteen days from the notice that the building or unit does~~  
28 ~~not comply with the applicable regulations. This section does not apply to the movement of a~~  
29 ~~new manufactured building or modular unit into or within this state before the process of being~~  
30 ~~connected for use.~~

1 — **SECTION 17. AMENDMENT.** Section 43-09-22 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3 — **43-09-22. Inspection of installation – Condemnation.**

4 — The board has jurisdiction over and shall provide inspection for all electrical and power  
5 limited systems installations. Inspectors authorized by the board may condemn installations  
6 hazardous to life and property or may order specific corrections to be made. Inspectors may  
7 order service thereto to such installations discontinued after notice to the owner of the property.  
8 The order is subject to the owner's right of appeal to the board. No Δ condemned installation  
9 may not be reconnected for service until proof has been furnished that the installation has been  
10 brought up to the required standards. The board may charge the master electrician or power  
11 limited technician contractor responsible for the installation a fee to cover the cost of inspection.  
12 Cities A city may make provisions for inspection of all electrical and power limited systems work  
13 done within their the corporate limits of the city. City inspectors shall register their the names of  
14 the inspectors with the board within ten days after their appointment.

15 — **SECTION 18. AMENDMENT.** Section 43-09-23 of the North Dakota Century Code is  
16 amended and reenacted as follows:

17 — **43-09-23. Criminal penalty – Civil proceedings.**

18 — Any person who that violates any of the provisions of this chapter is guilty of a class B-  
19 misdemeanor. In addition to criminal proceedings, the board may commence administrative or  
20 civil court proceedings as follows:

21 — 1. — The board may issue a cease and desist order against a person allegedly making or  
22 offering to make electrical or power limited systems installations in violation of section  
23 43-09-09 or 43-09-09.2 based upon information provided to the board by its the board's  
24 electrical inspectors or other persons, by investigation reports, affidavits, complaints of  
25 witnesses, or oral testimony given to the board at a regular or special board meeting.  
26 Violation of the cease and desist order may be considered by the court in issuing a  
27 temporary or permanent restraining order and in ordering the payment of costs and  
28 attorney's fees in proceedings authorized under this section.

29 — 2. — The board may apply to the district court in the county in which the violations have  
30 occurred for a temporary or permanent injunction under chapter 32-06, enjoining  
31 persons from performing, advertising, or contracting for making electrical or power

1 ~~limited systems~~ installations without a valid license issued by the board in violation of  
2 section 43-09-09 or 43-09-09.2. The court may not require a written undertaking,  
3 security, or bond as a basis for issuing any temporary or permanent restraining order  
4 under this section unless the court specifically orders and states the basis for requiring  
5 the security. Upon a determination that a violation of section 43-09-09 or 43-09-09.2  
6 has occurred, the court may assess against the defendants the actual costs incurred  
7 and reasonable attorney's fees necessary for the investigation and court proceedings  
8 against the unlicensed person.

9 ~~3.~~ After an administrative hearing has been conducted by the board under chapter 28-32,  
10 an appeal from an order of the board or from the assessment of costs and attorney's  
11 fees may be taken to the district court under chapter 28-32.

15 ~~To the extent that other states which that provide for the licensing of electricians and power~~  
16 ~~limited technicians provide for similar action, the state electrical board may grant licenses of the~~  
17 ~~same grade or class to electricians and power limited technicians licensed by other states, upon~~  
18 ~~payment by the applicant of the required fee, after being furnished with proof that the~~

21 **SECTION 1. LEGISLATIVE MANAGEMENT STUDY - REGULATION OF AND SCOPE OF**  
22 **PRACTICE OF ELECTRICIANS.** During the 2019-20 interim, the legislative management shall  
23 consider studying the regulation of and scope of practice of electricians. The study must include  
24 consideration of scope of practice and regulation as they relate to power limited systems and  
25 must include receipt of information from stakeholders, including trade groups. The legislative  
26 management shall report its findings and recommendations, together with any legislation  
27 necessary to implement the recommendations, to the sixty-seventh legislative assembly.
