

**HOUSE BILL NO. 1355**

1 A BILL for an Act to amend and reenact sections 23-09.3-01.1 and 23-16-01.1 of the North  
2 Dakota Century Code, relating to the moratorium on basic care and nursing facility bed capacity.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 23-09.3-01.1 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **23-09.3-01.1. Moratorium on expansion of basic care bed capacity.**

- 7 1. Basic care beds may not be added to the state's licensed bed capacity during the  
8 period between August 1, ~~2017~~2019, and July 31, ~~2019~~2021, except ~~when~~if:
- 9 a. A nursing facility converts nursing facility beds to basic care;
  - 10 b. An entity licenses bed capacity transferred as basic care bed capacity under  
11 section 23-16-01.1;
  - 12 c. An entity demonstrates to the state department of health and the department of  
13 human services that basic care services are not readily available within a  
14 designated area of the state or that existing basic care beds within a fifty-mile  
15 [80.47-kilometer] radius have been occupied at ninety percent or more for the  
16 previous twelve months. In determining whether basic care services will be  
17 readily available if an additional license is issued, preference may be given to an  
18 entity that agrees to any participation program established by the department of  
19 human services for individuals eligible for services under the medical assistance  
20 program under title XIX of the Social Security Act [42 U.S.C. 1396 et seq.]; or
  - 21 d. The state department of health and the department of human services grant  
22 approval of new basic care beds to an entity. The approved entity shall license  
23 the beds within forty-eight months from the date of approval.

- 1           2.   Transfers of basic care beds from one basic care facility to another entity is permitted.  
2           Transferred basic care beds must become licensed within ~~forty-eight~~seventy-two  
3           months of transfer. The entity receiving the transferred beds or any new facility may  
4           seek to participate in the basic care assistance program. If the entity can demonstrate  
5           that individuals can be cared for at a more independent level and that this service will  
6           delay entry into the nursing facility, the entity may be approved for basic care  
7           assistance funds.
- 8           3.   If an Indian tribe acquires basic care beds, the tribal facility must meet state licensing  
9           requirements for those beds within ~~forty-eight~~seventy-two months of acquisition. A  
10          tribal facility may seek to participate in the basic care assistance program. Basic care  
11          assistance payments may only be made to a tribal facility that agrees to participate  
12          and adhere to all federal and state requirements of the basic care assistance program  
13          including participation, screening, ratesetting, and licensing requirements.

14          **SECTION 2. AMENDMENT.** Section 23-16-01.1 of the North Dakota Century Code is  
15          amended and reenacted as follows:

16          **23-16-01.1. Moratorium on expansion of long-term care bed capacity.**

- 17          1.   Notwithstanding sections 23-16-06 and 23-16-10, except when a facility reverts basic  
18          care beds to nursing facility beds or relicenses nursing facility beds delicensed after  
19          July 31, 2011, nursing facility beds may not be added to the state's licensed bed  
20          capacity during the period between August 1, ~~2017~~2019, and July 31, ~~2019~~2021. A  
21          nursing facility may not delicense nursing facility bed capacity, relicense nursing facility  
22          bed capacity, convert licensed nursing bed capacity to basic care bed capacity, revert  
23          licensed basic care bed capacity back to nursing facility bed capacity, or otherwise  
24          reconfigure licensed nursing facility bed capacity more than one time in a  
25          twelve-month period.
- 26          2.   Transfer of licensed nursing facility bed capacity from a nursing facility to another  
27          entity is permitted. The nursing facility may transfer the bed capacity either as nursing  
28          facility bed capacity or basic care bed capacity. Transferred bed capacity must  
29          become licensed by an entity within ~~forty-eight~~seventy-two months of transfer. Bed  
30          capacity transferred as basic care bed capacity may not be reverted to nursing facility  
31          bed capacity at any time. A receiving entity may transfer the received bed capacity to

- 1 another entity within the ~~forty-eight-month~~seventy-two-month period originally  
2 established at the time the nursing facility first transferred the licensed nursing facility  
3 bed capacity. The subsequent receiving entity must license the received bed capacity  
4 within the forty-eight-month period originally established at the time of the first transfer.
- 5 3. A nursing facility may convert licensed nursing facility bed capacity to basic care. If the  
6 converted beds remain in the same facility and are not transferred, the beds may  
7 revert to nursing facility status after one year of licensure as basic care beds.
- 8 4. Nursing facility beds that are converted to basic care may be transferred as basic care  
9 beds. However, upon the transfer, the basic care beds may not be relicensed as  
10 nursing facility beds.
- 11 5. If an Indian tribe acquires nursing facility beds, the tribal facility must meet state  
12 licensing requirements for those beds within ~~forty-eight~~seventy-two months of  
13 acquisition. A tribal facility may seek to participate in the medical assistance programs.  
14 Medical assistance payments may only be made to a Medicaid certified tribal facility  
15 that agrees to participate and adhere to all federal and state requirements of the  
16 medical assistance program, including participation, screening, ratesetting, and  
17 licensing requirements.
- 18 6. A nursing facility, upon prior written notice to the state department of health, may  
19 delicense a maximum of twenty-five percent of its licensed nursing facility bed capacity  
20 and have the delicensed nursing facility held for a period of ~~twenty-four~~forty-eight  
21 months. The total delicensed nursing facility bed capacity that may be held for a  
22 nursing facility at no time may be greater than fifty percent of the number of currently  
23 licensed beds in the nursing facility. Delicensed nursing facility bed capacity in excess  
24 of fifty percent of the nursing facility's licensed capacity may not be held and is not  
25 eligible for the provisions of subsection 7. Delicensed bed capacity not sold or  
26 relicensed at the conclusion of the twenty-four-month holding period ceases to exist.
- 27 7. During the ~~twenty-four-month~~forty-eight-month holding period established at the time  
28 of delicensure, delicensed nursing facility bed capacity that is being held for the  
29 nursing facility may be:
- 30 a. Relicensed by the nursing facility. Relicensing of nursing facility bed capacity may  
31 not occur for twelve months from the time of delicensure.

- 1           b. Transferred to another entity as nursing facility bed capacity or basic care bed  
2           capacity. The receiving entity must license the transferred bed capacity as the  
3           type of bed capacity transferred within ~~the forty-eight-month~~ a seventy-two-month  
4           period ~~originally~~ established at the time of ~~delicensure~~ transfer. Bed capacity  
5           transferred as basic care bed capacity may not be reverted to nursing facility bed  
6           capacity at any time. A receiving entity may transfer the received bed capacity to  
7           another entity within the ~~forty-eight-month~~ seventy-two-month period ~~originally~~-  
8           established at the time of ~~delicensure~~ transfer. The subsequent receiving entity  
9           must license the received bed capacity within the ~~forty-eight-month~~ seventy-two-  
10          month period ~~originally~~ established at the time of ~~delicensure~~ transfer.
- 11          c. Licensed as basic care beds by the same facility. If the licensed basic care beds  
12          remain in the same facility and are not transferred, the beds may be reverted to  
13          licensed nursing facility bed capacity after twelve months.
- 14          8. Notwithstanding any other provision of this section, a nursing facility bed transferred  
15          before July 1, 2019, must be relicensed by the receiving entity within a seventy-two-  
16          month period established at the time of transfer.
