- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the commissioner of
- 2 university and school lands; to repeal section 57-51-15.1 of the North Dakota Century Code,
- 3 relating to the energy impact fund; to provide for transfers; to provide for distributions from
- 4 permanent funds; to provide an exemption; to provide a report; and to provide an effective date.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds as may be necessary, are appropriated from special funds derived from the state lands maintenance fund and the oil and gas impact grant fund in the state treasury to the commissioner of university and school lands for the purpose of defraying the expenses of the 10 commissioner of university and school lands, for the biennium beginning July 1, 2019, and ending June 30, 2021, as follows:

SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE SIXTY-SEVENTH LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the 2019-21 biennium one-time funding items included in the appropriation in section 1 of this Act:

10	appropriations committees of the sixty-seventh legislative assembly on the use of this one-time		
11	funding for the biennium beginning July 1, 2019, and ending June 30, 2021.		
12	SECTION 3. DISTRIBUTIONS TO STATE INSTITUTIONS. Pursuant to article IX of the		
13	Constitution of North Dakota, the board of university and school lands shall distribute during the		
14	biennium beginning July 1, 2019, and ending June 30, 2021, the following amounts, from the		
15	permanent funds managed for the benefit of the fo	ollowing entities:

1	SECTION 4. TRANSFER - STRATEGIC INVESTMENT AND IMPROVEMENTS FUND TO
2	OIL AND GAS IMPACT GRANT FUND. The office of management and budget shall transfer
3	the sum of \$4,000,000 from the strategic investment and improvements fund to the oil and gas
4	impact grant fund during the biennium beginning July 1, 2019, and ending June 30, 2021.
5	SECTION 5. TRANSFER - ENERGY IMPACT FUND TO OIL AND GAS IMPACT GRANT
6	FUND. The commissioner of university and school lands shall transfer any unexpended funds
7	remaining in the energy impact fund when the fund is repealed on June 30, 2021, to the oil and
8	gas impact grant fund.
9	SECTION 6. REPEAL. Section 57-51-15.1 of the North Dakota Century Code is repealed.
10	SECTION 7. OIL AND GAS IMPACT GRANT FUND. The grants line item and the total
11	special funds line item in section 1 of this Act include the sum of \$4,000,000 from the oil and
12	gas impact grant fund for grants to political subdivisions impacted by oil and gas development
13	activities.
14	SECTION 8. EXEMPTION - OIL AND GAS IMPACT GRANT FUND. The amounts
15	previously appropriated from the oil and gas impact grant fund and identified in section 10 of
16	chapter 38 of the 2017 Session Laws related to the oil and gas impact grant fund, including
17	grant awards returned to the fund, are not subject to section 54-44.1-11. Any unexpended funds
18	are available for grants and administrative costs associated with the fund during the biennium
19	beginning July 1, 2019, and ending June 30, 2021.
20	SECTION 9. EXEMPTION - INFORMATION TECHNOLOGY PROJECT - REPORT TO
21	INFORMATION TECHNOLOGY COMMITTEE. The \$3,600,000 appropriated from the state
22	lands maintenance fund and identified in sections 1 and 12 of chapter 38 of the 2017 Session
23	Laws is not subject to section 54-44.1-11, and any unexpended funds are available to complete
24	the information technology project during the biennium beginning July 1, 2019, and ending
25	June 30, 2021. During the 2019-20 interim, the commissioner of university and school lands
26	shall provide at least one report to the interim information technology committee regarding the
27	status of the information technology project.
28	SECTION 10. EFFECTIVE DATE. Section 6 of this Act becomes effective on June 30,
29	2021.
