REENGROSSED SENATE BILL NO. 2003

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the attorney general;
2 to amend and reenact sections 53-12.1-09 and 54-12-11 of the North Dakota Century Code,
3 relating to transfers from the lottery operating fund to the multijurisdictional drug task force grant
4 fund and the salary of the attorney general; to provide an exemption; and to provide for a report.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
7 as may be necessary, are appropriated out of any moneys in the general fund in the state
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and
9 other income, to the attorney general for the purpose of defraying the expenses of the attorney
10 general, for the biennium beginning July 1, 2019, and ending June 30, 2021, as follows:

SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

SIXTY-SEVENTH LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the one-time funding items included in the appropriation in section 1 of this Act:

The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget for the 2021-23 biennium. The attorney general shall report to the appropriations committees of the sixty-seventh legislative assembly on the use of this one-time funding for the biennium beginning July 1, 2019, and ending June 30, 2021.

1 **SECTION 3. EXEMPTION - ATTORNEY GENERAL REFUND FUND.** Notwithstanding
2 section 54-12-18, the attorney general may retain the balance in the attorney general refund
3 fund which would otherwise be transferred to the general fund on June 30, 2019.

4 **SECTION 4. AMENDMENT.** Section 53-12.1-09 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **53-12.1-09. Operating fund - Continuing appropriation - Authorization of**
7 **disbursements - Report - Net proceeds.**

8 There is established within the state treasury the lottery operating fund into which must be
9 deposited all revenue from the sale of tickets, interest received on money in the fund, and all
10 other fees and moneys collected, less a prize on a lottery promotion, prize on a winning ticket
11 paid by a retailer, and a retailer's commission. Except for moneys in the lottery operating fund
12 appropriated by the legislative assembly for administrative and operating costs of the lottery
13 under section 53-12.1-10, all other money in the fund is continuously appropriated for the
14 purposes specified in this section. During each regular session, the attorney general shall
15 present a report to the appropriations committee of each house of the legislative assembly on
16 the actual and estimated operating revenue and expenditures for the current biennium and
17 projected operating revenue and expenditures for the subsequent biennium authorized by this
18 section. A payment of a prize or expense or transfer of net proceeds by the lottery may be made
19 only against the fund or money collected from a retailer on the sale of a ticket. A disbursement
20 from the fund must be for the following purposes:

- 21 1. Payment of a prize as the director deems appropriate to the owner of a valid, winning
22 ticket;
- 23 2. Notwithstanding section 53-12.1-10, payment of a marketing expense that is directly
24 offset by cosponsorship funds collected;
- 25 3. Payment of a gaming system or related service expense, retailer record and credit
26 check fees, game group dues, and retailer commissions; and
- 27 4. Transfer of net proceeds:
 - 28 a. Eighty thousand dollars must be transferred to the state treasurer each quarter
29 for deposit in the gambling disorder prevention and treatment fund;
 - 30 b. An amount for the lottery's share of a game's prize reserve pool must be
31 transferred to the multistate lottery association;

- 1 c. Starting July 1, ~~2007~~2019, ~~one~~two hundred five thousand six hundred twenty-five-
- 2 dollars must be transferred to the state treasurer each quarter for deposit in the
- 3 attorney general multijurisdictional drug task force grant fund; and
- 4 d. The balance of the net proceeds, less holdback of any reserve funds the director
- 5 may need for continuing operations, must be transferred to the state treasurer on
- 6 at least an annual basis for deposit in the state general fund.

7 **SECTION 5. AMENDMENT.** Section 54-12-11 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **54-12-11. Salary of attorney general.**

10 The annual salary of the attorney general is ~~one hundred fifty-two thousand four hundred-~~
11 ~~thirty-six dollars through June 30, 2016~~one hundred sixty thousand one hundred forty-nine
12 dollars through June 30, 2020, and ~~one hundred fifty-seven thousand nine dollars~~one hundred
13 sixty-four thousand nine hundred fifty-four dollars thereafter.

14 **SECTION 6. ADDITIONAL INCOME - APPROPRIATION - REPORT.** In addition to the
15 amounts appropriated to the attorney general in section 1 of this Act, there is appropriated from
16 federal or other funds, the sum of \$250,000, or so much of the sum as may be necessary, to the
17 attorney general for the purposes of defraying the expenses of the office, for the biennium
18 beginning July 1, 2019, and ending June 30, 2021. The attorney general shall notify the office of
19 management and budget and the legislative council of any funding made available pursuant to
20 this section.

21 **SECTION 7. CRIMINAL HISTORY RECORD CHECKS - FEES.** Any individual or entity
22 requesting a criminal history record check from the bureau of criminal investigation, as a result
23 of legislation enacted by the sixty-sixth legislative assembly, shall pay a reasonable fee
24 established by the attorney general to the attorney general to be deposited in the state's general
25 fund for the biennium beginning July 1, 2019, and ending June 30, 2021.

26 **SECTION 8. EXEMPTION - STATEWIDE AUTOMATED VICTIM INFORMATION AND**
27 **NOTIFICATION PROGRAM.** The \$815,000 from the general fund appropriated to the attorney
28 general for the statewide automated victim information and notification system as contained in
29 sections 1 and 8 of chapter 3 of the 2017 Session Laws, is not subject to the provisions of
30 section 54-44.1-11. Any unexpended funds from this appropriation are available to the attorney

1 general for the statewide automated victim information and notification program, during the
2 biennium beginning July 1, 2019, and ending June 30, 2021.

3 **SECTION 9. HUMAN TRAFFICKING VICTIMS GRANT PROGRAM - REQUIREMENTS -**
4 **REPORTS.** The human trafficking victims grants line item in section 1 of this Act includes
5 \$1,625,000 from the general fund for the purpose of providing grants to organizations involved
6 in providing prevention and treatment services related to human trafficking victims for the
7 biennium beginning July 1, 2019, and ending June 30, 2021. The attorney general may provide
8 grants for the development and implementation of direct care emergency or long-term crisis
9 services, residential care, training for law enforcement, support of advocacy services, and
10 programs promoting positive outcomes for victims. Any organization that receives a grant under
11 this section shall report to the attorney general and the appropriations committees of the
12 sixty-seventh legislative assembly on the use of the funds received and the outcomes of its
13 program. The attorney general shall report to the legislative management during the 2019-20
14 interim on the status and results of the grant program.

15 **SECTION 10. FORENSIC NURSE EXAMINERS GRANT PROGRAM - REPORTS.** The
16 forensic nurse examiners grants line item in section 1 of this Act includes \$250,000 from the
17 general fund for the purpose of providing forensic nurse examiner program grants for
18 community-based or hospital-based sexual assault examiner programs, for the biennium
19 beginning July 1, 2019, and ending June 30, 2021. Any organization that receives a grant under
20 this section shall report to the attorney general and the appropriations committees of the
21 sixty-seventh legislative assembly on the use of the funds received and the outcomes of its
22 programs. The attorney general shall report to the appropriations committees of the
23 sixty-seventh legislative assembly on the number of nurses trained, the number and location of
24 nurses providing services related to sexual assault nurse examiner programs, and
25 documentation of collaborative efforts to assist victims which includes nurses, the hospital or
26 clinic, law enforcement, and state's attorneys.

27 **SECTION 11. ESTIMATED INCOME - CHARITABLE GAMING TECHNOLOGY SYSTEM -**
28 **EXEMPTION - GAMING TAX ALLOCATION.** The estimated income line item in section 1 of
29 this Act includes \$400,000 from the attorney general operating fund for the purpose of
30 purchasing equipment and software for a charitable gaming technology system.
31 Notwithstanding the provisions of section 53-06.1-12, from the deposits designated for deposit

1 in the general fund under subsection 3 of section 53-06.1-12 in fiscal year 2020, the attorney
2 general shall deposit \$400,000 into the attorney general operating fund during the biennium
3 beginning July 1, 2019, and ending June 30, 2021.

4 **SECTION 12. EXEMPTION - CONCEALED WEAPON REWRITE PROJECT.** The amount
5 appropriated to the attorney general from the general fund for a concealed weapon rewrite
6 project as contained in section 1 of chapter 37 of the 2015 Session Laws and continued into the
7 2017-19 biennium, is not subject to the provisions of section 54-44.1-11. Any unexpended funds
8 from this appropriation are available to the attorney general for the concealed weapon rewrite
9 project, during the biennium beginning July 1, 2019, and ending June 30, 2021.
