

**FIRST ENGROSSMENT  
with Conference Committee Amendments  
ENGROSSED SENATE BILL NO. 2005**

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;  
2 to amend and reenact section 54-11-13 of the North Dakota Century Code, relating to the salary  
3 of the state treasurer; and to provide for a report.

**4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated out of any moneys in the general fund in the state  
7 treasury, not otherwise appropriated, and from special funds derived from the strategic  
8 investment and improvements fund to the state treasurer for the purpose of defraying the  
9 expenses of the state treasurer, for the biennium beginning July 1, 2019, and ending June 30,  
10 2021, as follows:

20 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**  
21 **SIXTY-SEVENTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time  
22 funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the  
23 2019-21 biennium one-time funding items included in the appropriation in section 1 of this Act:

4 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget  
5 for the 2021-23 biennium. The state treasurer shall report to the appropriations committees of  
6 the sixty-seventh legislative assembly on the use of this one-time funding for the biennium  
7 beginning July 1, 2019, and ending June 30, 2021.

8 **SECTION 3. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS**  
9 **FUND.** The operating expenses line item and the estimated income line item in section 1 of this  
10 Act include \$35,000 from the strategic investment and improvements fund for information  
11 technology costs.

12 **SECTION 4. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is  
13 amended and reenacted as follows:

14 **54-11-13. Salary of state treasurer.**

15 The annual salary of the state treasurer is ~~ninety-six thousand nine hundred seventy-two~~  
16 ~~dollars through June 30, 2016, and ninety-nine thousand eight hundred eighty-one dollars~~  
17 ~~thereafter~~ one hundred seven thousand eight hundred eighty-five dollars through June 30, 2020,  
18 and one hundred ten thousand five hundred eighty-two dollars thereafter.
