

**SENATE BILL NO. 2014**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the committee on  
2 protection and advocacy; and to provide a report to the legislative assembly.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the committee on protection and advocacy for the purpose of defraying the  
8 expenses of the committee on protection and advocacy, for the biennium beginning July 1,  
9 2019, and ending June 30, 2021, as follows:
