ENGROSSED HOUSE BILL NO. 1001

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 governor; to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota Century
3 Code, relating to the salaries of the governor and lieutenant governor; to provide an exemption;
4 to provide for a report; and to declare an emergency.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
7 as may be necessary, are appropriated out of any moneys in the general fund in the state
8 treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying
9 the expenses of the office of the governor, for the biennium beginning July 1, 2021, and ending
10 June 30, 2023, as follows:

20 **SECTION 2. ONE-TIME FUNDING.** The following amounts reflect the one-time funding
21 items approved by the sixty-sixth legislative assembly for the 2019-21 biennium:

3 **SECTION 3. ADDITIONAL INCOME - APPROPRIATION - GOVERNOR'S OFFICE -**

4 **BUDGET SECTION REPORT.** In addition to the amounts appropriated in section 1 of this Act,
5 there is appropriated to the governor's office, any additional income from federal or other funds
6 which may become available to the governor's office, for the biennium beginning July 1, 2021,
7 and ending June 30, 2023. Any funds received under this section must be used for the specific
8 purpose intended for the funds or transferred to the appropriate state agency or institution.

9 Upon the receipt of funds under this section, the governor's office shall provide a report to the
10 budget section regarding the source, amount, and purpose of the funds received.

11 **SECTION 4. AMENDMENT.** Section 54-07-04 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **54-07-04. Salary of governor.**

14 The annual salary of the governor is one hundred ~~thirty-five~~forty thousand ~~three~~eight
15 hundred ~~sixty-four~~twenty-nine dollars through June 30, ~~2020~~2022, and one hundred ~~thirty-~~
16 ~~eight~~forty-two thousand ~~seven~~nine hundred ~~forty-eight~~forty-one dollars thereafter.

17 **SECTION 5. AMENDMENT.** Section 54-08-03 of the North Dakota Century Code is
18 amended and reenacted as follows:

19 **54-08-03. Salary of lieutenant governor.**

20 The annual salary of the lieutenant governor is one hundred ~~five~~nine thousand ~~two~~five
21 hundred ~~eighty-five~~thirty-six dollars through June 30, ~~2020~~2022, and one hundred ~~seven~~eleven
22 thousand ~~nine~~one hundred ~~seventeen~~seventy-nine dollars thereafter.

23 **SECTION 6. EXEMPTION - LINE ITEM TRANSFERS - 2019-21 BIENNIUM.**

24 Notwithstanding section 54-16-04, the office of management and budget may transfer up to
25 \$64,242 of appropriation authority from the operating expenses line item to the salaries and
26 wages line item in section 1 of chapter 26 of the 2019 session laws as requested by the
27 governor.

28 **SECTION 7. EXEMPTION.** The funding appropriated in the rough rider awards line item in
29 section 1 of chapter 26 of the 2019 session laws is not subject to the provisions of section
30 54-44.1-11 and may be continued into the biennium beginning July 1, 2021, and ending
31 June 30, 2023.

1 **SECTION 8. EMERGENCY.** Section 6 of this Act is declared to be an emergency measure.
