## ENGROSSED HOUSE BILL NO. 1447

1 A BILL for an Act to create and enact a new section to chapter 15-10 of the North Dakota  
2 Century Code, relating to higher education student voting documents; and to amend and  
3 reenact section 16.1-01-04.1 of the North Dakota Century Code, relating to acceptable forms of  
4 identification for purposes of voting.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1.** A new section to chapter 15-10 of the North Dakota Century Code is created  
7 and enacted as follows:

8 **Student voting documents.**

9 An institution of higher education under the control of the state board of higher education  
10 may issue students enrolled at the institution a printable document containing the institution's  
11 letterhead or seal using a self-service process. The document must contain the student's legal  
12 name, current residential address in the state, the date the residential address was established,  
13 and date of birth. When issuing the document to students, an institution of higher education  
14 under the control of the state board of higher education shall provide each student with  
15 information regarding voter eligibility requirements.

16 **SECTION 2. AMENDMENT.** Section 16.1-01-04.1 of the North Dakota Century Code is  
17 amended and reenacted as follows:

18 **16.1-01-04.1. Identification verifying eligibility as an elector.**

- 19 1. A qualified elector shall provide a valid form of identification to the proper election  
20 official before receiving a ballot for voting.
- 21 2. The identification must provide the following information regarding the elector:
- 22 a. Legal name;
- 23 b. Current residential street address in North Dakota; and
- 24 c. Date of birth.

- 1           3.   a.   A valid form of identification is:
- 2                   (1)   A driver's license or nondriver's identification card issued by the North
- 3                               Dakota department of transportation; or
- 4                   (2)   An official form of identification issued by a tribal government to a tribal
- 5                               member residing in this state.
- 6           b.   If an individual's valid form of identification does not include all the information
- 7                   required under subsection 2 or the information on the identification is not current,
- 8                   the identification must be supplemented by presenting any of the following issued
- 9                   to the individual which provides the missing or outdated information:
- 10                   (1)   A current utility bill;
- 11                   (2)   A current bank statement;
- 12                   (3)   A check issued by a federal, state, or local government;
- 13                   (4)   A paycheck; or
- 14                   (5)   A document issued by a federal, state, or local government; or
- 15                   (6)   A printed document containing all of the information required by
- 16                               subsection 2 issued by an institution of higher education for an enrolled
- 17                               student residing in the state and containing the institution's letterhead or
- 18                               seal, along with a student photo identification card issued by the institution
- 19                               and containing the student's photograph and legal name.
- 20           4.   The following forms of identification are valid for the specified individuals living under
- 21                   special circumstances who do not possess a valid form of identification under
- 22                   subsection 3.
- 23           a.   For an individual living in a long-term care facility, a long-term care certificate
- 24                   prescribed by the secretary of state and issued by a long-term care facility in this
- 25                   state;
- 26           b.   For a uniformed service member or immediate family member temporarily
- 27                   stationed away from the individual's residence in this state, or a resident of the
- 28                   state temporarily living outside the country, a current military identification card or
- 29                   passport; and
- 30           c.   For an individual living with a disability that prevents the individual from traveling
- 31                   away from the individual's home, the signature on an absentee or mail ballot

1 application from another qualified elector who, by signing, certifies the applicant  
2 is a qualified elector.

- 3 5. If an individual is not able to show a valid form of identification but asserts  
4 qualifications as an elector in the precinct in which the individual desires to vote, the  
5 individual may mark a ballot that must be securely set aside in a sealed envelope  
6 designed by the secretary of state. After the ballot is set aside, the individual may  
7 show a valid form of identification to either a polling place election board member if the  
8 individual returns to the polling place before the polls close, or to an employee of the  
9 office of the election official responsible for the administration of the election before the  
10 meeting of the canvassing board occurring on the sixth day after the election. Each  
11 ballot set aside under this subsection must be presented to the members of the  
12 canvassing board for proper inclusion or exclusion from the tally.
- 13 6. The secretary of state shall develop uniform procedures for the requirements of  
14 subsection 5 which must be followed by the election official responsible for the  
15 administration of the election.
