HB 1169 enacts a new section to 49-02 requiring the Commission, upon petition, to determine if government is in competition with a private enterprise and may direct an agency to terminate activity or set a fee.

The fiscal impacts are unknown due to the inability to forecast how often the new section would be and the subsequent results. Fiscal impacts may result from legal and due process requirements for processing a case by the Commission. This could include publication costs, costs of hearing officers, administrative law judges, appeals, and notices. If the commission finds an agency or institution is in competition with private business and directs cessation of activity, that agency likely would be fiscally impacted. If this section is used extensively, there may be a large fiscal impact. The bill could also have a fiscal impact on any agency or institution the commission permits to continue in competition with private business, if the commission assesses a fee for that activity or if they are order to cease operations.
