The bill will allow the DOT to implement an electronic driver license to be used for identification and for law enforcement purposes and to provide written Class D knowledge tests online.

Section 1 would require NDDOT to develop an electronic driver’s license with one-time costs estimated to be \$1,000,000 for development and on-going maintenance costs estimated at \$100,000 in subsequent biennia. Section 2 would require NDDOT to develop an on-line written test feature with on-going testing software costs estimated to be \$390,000 per biennium.

For the electronic driver's license (Section 1), the estimated one-time development costs are \$1 million based on research from other state implementations. Also, there will be on-going maintenance costs of \$100,000 per biennium.

For the on-line testing provision (Section 2), NDDOT would incur an estimated \$390,000 per biennium for testing software costs. Currently, DOT conducts 26,000 Class D knowledge tests per year; if 75% of those tests were conducted online this would result in 19,500 online tests per year. The cost per test is approximately \$10. This fee consists of the software hosting, maintenance, security, fraud prevention and any customization. These costs would result in approximately \$390,000 per biennium.
