- 1 A BILL for an Act to amend and reenact section 43-58-08 of the North Dakota Century Code,
- 2 relating to the scope of practice of a naturopath.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 SECTION 1. AMENDMENT. Section 43-58-08 of the North Dakota Century Code is 5 amended and reenacted as follows:
- 6 43-58-08. Practice of naturopathic health care.
- A naturopath may practice naturopathic medicine as a limited practice of the healing 8 arts as exempted under section 43-17-02. A naturopath may not:
  - Prescribe Except as authorized under subsection 3, prescribe, dispense, or administer any prescription drug:
  - Administer ionizing radioactive substances for therapeutic purposes; b.
- 12 Perform a surgical procedure; or C.
  - d. Claim to practice any licensed health care profession or system of treatment other than naturopathic medicine unless holding a separate license in that profession. A naturopath may not hold out to the public that the naturopath is a primary care provider.
  - A naturopath may prescribe and administer for preventive and therapeutic purposes a 2. prescriptive device and the following nonprescriptive natural therapeutic substances, drugs, and therapies:
- 20 a. Food, vitamins, minerals, dietary supplements, enzymes, botanical medicines, 21 and homeopathic preparations;
- 22 Topical drugs, health care counseling, nutritional counseling and dietary therapy, b. 23 naturopathic physical applications, and therapeutic devices; and
  - Barrier devices for contraception.

6			including home health care, hospice, and physical and occupational therapy.
7		<u>C.</u>	May not prescribe and or dispense schedule III through V substances as
8			designated by the federal drug enforcement administration except for
9			testosterone and may prescribe and dispense all other legend drugs.
0		<u>d.</u>	May not dispense a drug, unless pharmacy services are not reasonably
11			available, dispensing is in the best interest of the patient, or an emergency exists
2		<u>e.</u>	May request, receive, and sign for a professional sample and may distribute a
3			professional sample to a patient.
4		<u>f.</u>	If prescribing or dispensing a controlled substance, shall register with the federal
5			drug enforcement administration and shall comply with appropriate state and
6			federal laws.
7	<u>4.</u>	A na	aturopath may perform or order for diagnostic purposes a physical or orificial
8		exa	mination, ultrasound, phlebotomy, clinical laboratory test or examination,
9		phy	siological function test, and any other noninvasive diagnostic procedure commonly
20		use	d by physicians in general practice and as authorized by the board.
