HOUSE RESOLUTION NO. 5001

1	A resolution calling for the expulsion of Representative Luke Simons, District 36, as a member
2	of the Legislative Assembly for conduct unbecoming of a legislator.
3	WHEREAS, Joint Rule 1001 of the 2021 Legislative Rules provides the Legislative
4	Assembly "seeks a high reputation for progressive accomplishment where its members are
5	public officers of integrity and dedication, maintaining high standards of ethical conduct" and
6	"[e]thical conduct is expected of all who participate in the legislative process"; and
7	WHEREAS, Joint Rule 1001 further provides "[i]f public confidence is to be maintainedit is
8	not enough that members avoid acts of misconduct" but also "must avoid acts that may create
9	an appearance of misconduct"; and
10	WHEREAS, Joint Rule 1002 provides the Legislative Assembly should define ethical
11	standards "to chart the areas of real or apparent impropriety" and "in striving to maintain ethical
12	standards, each member should recognize the importance of[c]omplying with all other rules
13	relating to ethics, including Joint Rule 901 regarding workplace harassment"; and
14	WHEREAS, Joint Rule 901 provides "the Legislative Assembly is committed to providing a
15	healthy and appropriate work environment for legislators, legislative employees, and other state
16	employees which is free from workplace harassment" and "harassment in any manner will not
17	be tolerated"; and
18	WHEREAS, Section 561(1) of Mason's Manual of Legislative Procedure provides "[a]
19	legislative body has the right to regulate the conduct of its members and may discipline a
20	member as it deems appropriate, including reprimand, censure or expulsion"; and
21	WHEREAS, Representative Simons has exhibited a history of hostile, threatening, and
22	inappropriate behavior, most frequently toward women; and
23	WHEREAS, in an article published by the Fargo Forum on February 25, 2021,
24	Representative Simons is quoted as stating "I guess that was sexual harassment" in regard to a

1 previous encounter Representative Simons had with a member of the Legislative Council staff; 2 and 3 WHEREAS, in a recording produced by Representative Simons, Representative Simons 4 admits making a heated statement containing multiple expletives directed at a female member 5 of the House of Representatives, in the plain view of the public, in a crowded area on the 6 Capitol grounds while the Legislative Assembly was convened for the 2021 legislative session; 7 and 8 WHEREAS, numerous other reports of inappropriate behavior from Representative Simons 9 have been publicized which demonstrate a concerning pattern of behavior that corrupts the 10 integrity of the legislative branch; and 11 WHEREAS, it is the responsibility of the House of Representatives to ensure a safe working 12 environment; 13 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF 14 **NORTH DAKOTA:** 15 That condoning such hostile, threatening, and inappropriate behavior from a member of the 16 House of Representatives undermines the integrity of the House of Representatives and the 17 Legislative Assembly as a whole; and 18 BE IT FURTHER RESOLVED, that pursuant to Section 12 of Article IV of the Constitution of 19 North Dakota, either house may punish its members for disorderly behavior and expel a 20 member with the concurrence of two-thirds of its elected members; and 21 BE IT FURTHER RESOLVED, that Representative Simons be expelled as a member of the

BE IT FURTHER RESOLVED, that this resolution be entered in the journal and the
