## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the secretary of state for the purpose of defraying the expenses of the secretary of state and public printing, for the biennium beginning July 1, 2023, and ending June 30, 2025, as follows:

23	SECTION 3. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS						
24	FUND. The estimated income line item in subdivision 1 of section 1 of this Act includes the sum						
25	of \$1,500,000 from the strategic investment and improvements fund for a new campaign						
26	system, contracted website redesign, and information technology system enhancements for the						
27	secretary of state.						
28	SECTION 4. AMENDMENT. Section 54-09-05 of the North Dakota Century Code is						
29	amended and reenacted as follows:						

- 1 54-09-05. Salary of secretary of state.
- 2 The annual salary of the secretary of state is one hundred twelve thousand two hundred
- 3 forty-one one hundred thirty thousand dollars through June 30, 20222024, and one hundred-
- 4 fourteen thousand four hundred eighty-sixone hundred thirty-five thousand two hundred dollars
- 5 thereafter.
- 6 SECTION 5. EXEMPTION LINE ITEM TRANSFERS. Notwithstanding section 54-16-04,
- 7 the office of management and budget may transfer up to \$100,000 of appropriation authority
- 8 between line items in subdivision 1 of section 1 of this Act, as requested by the secretary of
- 9 state, during the biennium beginning July 1, 2023, and ending June 30, 2025.
