Runge, No.

Representative Klein, I don't like it when we start mandating things.

<u>Runge</u>, Public employees feel they cant be in the legislature and don't want to loose their jobs. Some of the fields, like teachers can do it, but the rank and file person really doesn't have the ability to do it. Teachers is a local control issue, each district.

<u>Representative Grande</u>, Why should government employees be guaranteed versus employees in the private sector? The leave of absence is without pay?

<u>Runge</u>, The difference is we can't just go to our supervisors like in the private sector. The leave of absence is without pay.

Repesentative Cleary, Do you feel that the position might be cut?

<u>Runge</u>, It has always been a concern. It limits the ability for people to get involved and wish there was a middle ground we could reach.

<u>Representative Devlin</u>, With local government, I see a real problem. Say a snowplow operator for an example. We can't have or know how to fill a persons position who is highly skilled. If they are gone for 3 months. Besides, its not only the legislative session, there's campaigning and all the other things that go into an election.

<u>Representative Kroeber</u>, In teaching, the substitute has to be certified to be able to fill in. Maybe a possible amendment is in order. One that states with adequate replacement.

Nancy Sand, ND Education Association supports the bill and stated that a teacher does not get time off to campaign.

Jim Gomstead, ND League of Cities appeared before the committee as neutral on the bill. Were OK with it as long as the person is being covered for by a qualified person. We do see a potential problem if you start mandating it and we would oppose that.

Testimony in Opposition:

Bev Nelson, ND School Board Association. This infringes on local school board policy. To

mandate this would be going to far.

<u>Representative Winrich</u>, At present time there is no question that a school board as the authority to establish policy in these areas.

<u>Nelson</u>, I don't think there is. If your going to have a policy to do this, make sure they do not get into a bind. Actually we would advise flexibility.

Minutes: CHAIRMAN KREBSBACH opened the hearing on HB 1300 which relates to governmental employers to allow public employees a leave of absence for service in the legislative assembly. Appearing before the committee to offer testimony in support of the bill was REPRESENTATIVE SALLY SANDVIG, District 21, Fargo, primary sponsor of the bill. She indicated to the committee she introduced this bill because of the difficulties districts are having with finding people to run for the legislature, that means both parties, not just one. She indicated that she has a couple of friends who had lost their jobs in the private sector and I couldn't do anything about that so I thought well, let's try the public sector instead. SENATOR DEMERS, Is this a, political subdivisions, at least our political subdivisions in Grand Forks have given leave of absence for this and I know higher ed does, so is this a problem basically with the state? REPRESENTATIVE SANDVIG, I'm not really sure. there too. SENATOR STENEHJEM, it seems to me that the house with their amendment really drastically changed the bill. REPRESENTATIVE SANDVIG, they changed that to go along with the rules that the national guard has for letting people off to for service from the guard and they changed the may to make it more palatable. SENATOR STENEHJEM, is it your position now that the state may not grant a leave of absence for a person to serve in the state legislature? CHRIS RUNGE, Executive Director, North Dakota Public Employees Association, appeared before the committee in support of HB 1300. A copy of Ms. Runge's testimony is attached. SENATOR DEMERS, when we were recruiting candidates last fall there was somebody from the human services center that wanted to run and they were told that it was a policy just that they couldn't. Are you aware of that? MS. RUNGE, I do believe that has to do with the combination of receiving federal funds and the Hatch Act. SENATOR THANE, Have agency heads said publicly what you say in your testimony, or are they saying it privately, because I think this is an awful poor rationale on their part. That if you can do without them for four months, that you can get rid of them permanently. I have a problem with that. MS. RUNGE, Having worked in state agencies for most of my life, that really actually is the case that there is concern out there that if you take time off that will be looked at a little closer. I'm not meaning this negatively toward state agencies because I think they really try to be employee oriented. But I think they worry about phantom positions and losing positions in a time of resource allocations being what they may, but they don't want to raise any red flags. So, they are not going to rock the boat. That is the sad reality of it. NANCY SAND, representing the North Dakota Education Association appeared before the committee indicating that her organization supports the bill. Questions and


