BILL DESCRIPTION: Mental-Mental Coverage

BILL NO: HB 1402

SUMMARY OF ACTUARIAL INFORMATION: North Dakota Workers Compensation, together with its actuary, Glenn Evans of Pacific Actuarial Consultants, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The proposed bill will expand coverage to include "A mental injury arising from a mental stimulus that occurs to an emergency medical service provider, a firefighter, or a law enforcement officer if the injury occurred in the course of employment and if the injury meets the criteria of critical incident, as defined by the bureau."

FISCAL IMPACT: We do not anticipate that this revision will materially increase rates for the state as a whole since premiums associated with the classifications affected by the expanded coverage comprise only about 7% of the statewide total. However, rates for the specific classes may increase over time due to the changes implemented under the proposed legislation. We did not attempt to derive an estimate of the likely

impact of the proposed change on rate and reserve levels for those classes because we do not have access to an appropriate base of historical experience to use in deriving the estimates.
