

Minutes: HB 1129-Relating to the allowance for state officers and employees for meals outside the continental United States. 13 members present, 1 absent

**Chairman Haas:** We will open the hearing on HB 1129.

**Laura Glatt-Vice Chancellor for Administrative Affairs with NDSU-For-Attached Testimony.**

**Rep. Grande:** When we received the fiscal note from OMB, that is no way to determine, since this coming from NDUS, could we have you go back and find out for us who can have a handle on what we are dealing with for cost. Previous biennium and what it cost for that travel and what it would cost if we would have had this in place.

**Laura:** We can certainly provide you with an estimate of what the impact would be, I am not sure that we will be able to go back and tell you exactly how much was spent the previous biennium and goes back to the previous conversation about how travel expenses are accounted for there isn't necessarily a separate cost center for travel outside the United States versus travel

in the United States. We can provide you with a good estimate of the information, at least for the University system.

**Rep. Grande:** Along those lines, as you were speaking you talked about a lot of the research that is going on Federal Grants, why isn't the Federal Government picking up all of the costs, why is there incurring costs with Federal travel?

**Laura:** Perhaps I wasn't clear, the Federal Grant does pick up the cost, but the ironic thing is, because they are still considered State Employees they are held to the State Statute which limits the reimbursement, so Federal funds pay for it, but they are not reimbursed at the Federal rate, they are reimbursed at the rate in State Statute, because they are still considered State employees.

**Rep. Grande:** If that is the case as a State employee they are not incurring extra costs with their travel, they are still being reimbursed for everything they do.

**Laura:** No, they are only reimbursed up to the maximum rate that are allowed in State Statute, either the 1 and half times or the 2 times, depending on location of travel, **they** may in many instances incur more costs, then they are absorbing on their own and just like if you and I were traveling in State and we couldn't find a hotel that honored State rates, which happens fairly routinely, I as individual employee then would pick up the difference, between what the State would reimburse me the 45 dollars and the actual cost of the hotel, so that is part of the reason for our proposing the change, is that we are finding the costs of these employees is more than what is currently provided in State Statutes and the Federal reimbursement is more closely aligned with the actual costs.

**Rep. Sitte:** If a teacher is taking a group of students to France for three weeks, is that usually a separate contract or with the tour company for instances or would that all fall under it to.

**Laura:** That is a good question and I am sorry I don't know the answer, but I can find out for you.

**Rep. Sitte:** OK thanks.

**Rep. Klemin:** The United States per diem committee, do they evaluate them on a continuing basis, the difference between the value of a dollar versus the other currencies, these other countries that we are looking at to determine these increases.

**Laura:** I am not certain how they evaluate and the reason for the changes in their rates, but they do update their rates regularly.

**Rep. Klemin:** How do we become aware of those rates?

**Laura:** I have a partial copy here, if you print the file it is really long, but they have a web site and I can certainly provide you the reference if you would like and at least a partial copy of and its long, as you can see this only a partial copy, it lists every country, but I can certainly provide you with some reference and the web site reference where you can look up those rates.

**Rep. Haas:** We would like to have a copy and at least have access to the web site. Is there a difference between the rates that are established by the United States per diem committee and the Department of State?

**Laura:** No, actually the U.S. per diem committee falls under the government of the U.S. Dept. of State.

**Chairman Haas:** So why in the bill do we refer to the per diem committee and the Dept. of State, would it not be a little clearer, if we simply referred to the per diem committee in both of those paragraphs?

**Laura:** Section for and Section 5, I will seek clarification on that from NDSU, but that is my understanding that they are one in the same, but I will seek clarification.

**Rep. Conrad:** This will not cost us any money, since the Federal Government will reimburse at their own rate.

**Laura:** Certainly it would it would cost the grant money.

**Chairman Haas:** Thank you very much. Any more questions?

Good morning, I am Laura Glatt, Vice Chancellor for Administrative Affairs with the NDUS. I am here today in support of HB1129, which was introduced at the request of the State Board of Higher Education.

The proposed changes will provide a meal allowance outside the United States at the appropriate rate for each location consistent with the rates provided for federal employees, which are established by the United States Per Diem Committee. This is consistent with meal allowance provisions currently in place for meal reimbursement within the continental United States, which was adopted by the Legislative Assembly in 1995.

Currently, state employees traveling in Canada, Alaska, and Hawaii are provided a meal allowance not to exceed one and one-half times the current continental US standard rate for federal employees. The current maximum rate for each of these areas is currently \$46.50.

The current allowance for meals outside the non-continental US may not exceed two times the current continental US standard rate for federal employees. All international travel, except Canada, is currently reimbursed at \$62.00.

The proposed change would instead require per diem meal allowance to be at the established rate for federal employees based on area of travel. The new rate for selected locations would be as follows:

Canada	\$ 99.00 standard (range \$59 - \$120)
Winnipeg	\$80.00
Edmonton	\$67.00
Alaska	\$ 55.00 standard (range \$47 - \$89)
Juneau	\$84.00
Fairbanks	\$88.00 summer rate
Hawaii	\$ 61.00 standard (range \$61 - \$148)
Honolulu	\$91.00
Brazil	\$ 56.00 standard (range \$41 - \$82)
China	\$ 63.00 standard (range \$52 - \$118)
Germany	\$ 72.00 standard (range \$72 - \$135)
France	\$ 81.00 standard (range \$63 - \$140)
India	\$ 65.00 standard (range \$ 61 - \$97)
New Dehli	\$61 (summer rate)
England	\$109.00 standard (range \$109- \$137)
Russia	\$ 88.00 standard (range \$88 - \$109)

This change would impact a limited number of NDUS employees, but it does represent an important equity and fairness issue to these employees. For example, at NDSU approximately 50 -100 employees per year would be impacted. Thus, the overall fiscal impact would be minimal. Most of the employees impacted are engaged in research or other projects funded by federal funds. The new proposed rates more closely align the actual costs incurred by employees while in travel outside the US.

Representative Haas and Members of the Committee:

First, let me apologize for the lateness of my response. Much of the follow-up information you requested needed to come from the campus level. Campus personnel are currently a bit overwhelmed with the implementation of the new administrative software system, ConnectND, along with their regular day-to-day tasks. I hope this delay has not significantly impacted the work of your committee.

During the Committee hearing on HB1129, which changes the provisions for foreign travel meal allowance, you and your committee members asked some very good questions, which I was not able to immediately respond to. I will outline those questions along with our response:

- 1.) Are faculty members, who are involved in hosting student tour groups subject to these same provisions for meal allowance? Yes, they would be reimbursed according to the provisions of this state statute, like any other employee.
- 2.) Are the US Per Diem Committee rates referenced in Section 4 of the bill and the rates established by the US Department of State referenced in Section 5 the same? No, they are two different rate schedules and entities and should remain in the bill as originally proposed. It is our understanding that the US Per Diem Committee is the oversight committee charged with ensuring uniform regulations between domestic and foreign travel for federal employees. The purpose of the Committee is to "ensure that uniform travel and transportation regulations are issued pursuant to Title 37, United States Code, other applicable laws, and decisions of the Comptroller General of the United States, for members of the seven Uniformed Services. In connection with civilian employees of the Department of Defense, the primary purpose of the Committee is to issue uniform regulations implementing the Federal Travel Regulations (FTR), Statutory requirements, Executive orders, and decisions of the Comptroller General of the United States." - 3.) Are rates adjusted to reflect changes in the value of the dollar by location? 37 USC Sec.411, TITLE 37, PAY AND ALLOWANCES OF THE UNIFORMED SERVICES directs that the Per Diem Committee "consider the current economic data on the cost of subsistence."



4. When patients are permitted to smoke in the hospital's buildings, they smoke only under the following circumstance(s):
  - In designated locations environmentally separate from care, treatment, and service areas\*
  - After the hospital has taken measures to minimize fire risks
5. Patients who do smoke in the hospital's buildings are provided education, including information about options for smoking cessation.
