Minutes:

Chairman Weisz opened the hearing on HB 1087. Rep. Delmore was absent.

HB 1087 relates to inclusion of vehicles of the state forester as authorized emergency vehicles.

David Geier Of the State Forest Service, on behalf of **Larry Kotchman**, spoke in support of the bill. See attached testimony from Larry Kotchman.

Rep. Weisz: What are you doing now?

David: We have been using hazardous emergency lights and a small anchor light on top of the engines. Currently speaking these are not lights that are easily seen or visible in the event of an emergency.

Rep. Gruchalla: You want to put red fire lights on the striped vehicles?

David: That is correct.

Rep. Gruchalla: If you also want to use the state forester's vehicle, the other vehicles that respond to fires, are they going to be Class A emergency vehicles also?

David: What we are looking at right now is the fire engines and the command vehicles. We are not looking at any other vehicles.

Rep. Ruby: Under Class C, it includes volunteer firefighters. Why weren't you seeking inclusion in the Class C rather than Class A?

David: That would probably better explained by the person from the North Dakota Fireman's Association. I believe that falls under their personal vehicles trying to get to the scene.

Rep. Thorpe: Usually there is something that has come up in the past as far as working the fires and such that brings something out, that makes this bill surface, where is the background?

David: In the past we've only had small authority to respond to fires. Currently speaking, we have been working with this bill since 2002. We have been noticing when we are out on fires some of the public vehicles come by us and we have no way to try to slow them down or let them know that we are a fire vehicle. We would like to be more visible so that people can see us better.

Rep. Thorpe: Would you be on state radio so that these vehicles can hear you and you can communicate with the other responders?

David: We are on state radio. We have already responded to many fires last year alone we had over thirty-three people involved in fires throughout the state.

Rep. Price: Would there be any objection if we included language that is used under number 7 if it's in the case of an emergency if that would make some people feel better?

David: The state forester would have to address that.

Larry Kotchman, state forester of North Dakota, spoke to the committee.

Kotchman: If I understand you correct, you wanted to insert something like "in case of emergency", basically what we are looking for is to make sure that vehicles that are used in emergency firefighting are covered under the statute as Class A vehicles. These are a fleet of

striped engines that we just developed and they are equivalent to a Class A vehicle, except you don't have the authority to put the red lights on it.

(Kotchman continued)

We have been giving additional assistance to wild fires in the state and these requests come from the division of emergency management from the county emergency managers. This past season, these vehicles have been very busy and as we develop these vehicles, we identify this is an area where we need to come into compliance to make sure that they are Class A vehicles. From public safety and firefighter stand point, there are very important that they be recognized as any other fire fighting vehicle.

Rose Hartman, Executive Director of the North Dakota Fire Fighters Assoc spoke in support of the bill.

Rose: We are here today in support of the bill. We feel that not only for the forest service, but for the rural fire protection and firefighters who are on the scene, for their safety.

There were no questions from the committee. There was no further support for the bill.

There was no opposition to the bill. The hearing was closed. No action was taken at this time.

Minutes:

Chairman Weisz allowed committee discussion on HB 1087. Rep. Delmore was absent. HB 1087 relates to inclusion of vehicles of the state forester as authorized emergency vehicles.

Chairman Weisz: What are the committee's wishes?

Rep. Owens: I would like to get an amendment for this to read, instead of "vehicles operated by the state forestry", to read "firefighting stripe teams and command vehicles operated by or under the control of state forestry, in case of emergencies". Because right now vehicles operated by or under the control of state, well, that's any vehicle they've got. So now if they happen to pull over the side of the road, they become a Class A, we are forcing people to recognize that is an emergency vehicle. Which in our current law requires to move over to the other lane, or if it's unsafe to do so, slow down to twenty miles per hour, and if the car is broke down, there is no stipulation right now that it has to be during a case of emergency.

Rep. Ruby: Initially I shared those same concerns and then I look further up in the bill and it is discussed above. The forestry service wants to put red lights and warning lights on these vehicles and I'm sure cost wise, they aren't going to put them on every vehicle they own whether it's a pickup or whatever. I am assuming they are only going to put them on the ones

they need this classification then they need those types of lights and as we try to change it and try to be consistent with each group, I don't have a problem with how it is worded, as long as we don't find some abuse.

Rep. Gruchalla: If you put red lights on the vehicle, it already becomes a Class A vehicle, and therefore, it has to be used for emergency.

Rep. Price: To be Class A, they have to have certain equipment on it, correct?

Rep. Weisz: You are suppose to have certain equipment but still by definition they *are* an authorized emergency vehicle.

Rep. Gruchalla: I believe that you are not a Class A emergency vehicle until you turn your lights on. You can only turn your lights on in an emergency.

Rep. Thorpe moved a DO PASS. Rep. Owens seconded.

Minutes:

Senator Gary Lee opened the hearing on HB 1087 relating to inclusion of vehicles of the state forester as authorized emergency vehicles.

David Geyer from the North Dakota Forest Service read the testimony of Larry Kotchman, State Forester in support of HB 1087. His written testimony is enclosed.

Senator Potter asked what the advantages of being emergency vehicles are.

David answered that what they were looking for is # 1 Visibility when going in and out of a fire and # 2 When they are on a fire scene people can tell exactly where they are.

Senator Lee asked if that would be the difference if this bill was passed, that they would be able to use a light code on their vehicle.

David answered yes and supplied photos for the committee to look at. It would allow them to use red lights on the engines for the visibility.

Senator Lee asked if the bill offered anything more than visibility.

David said right now we are just concerned about visibility and safety for our fireman and the public.

Senator Fiebiger asked if this bill reads that any of their vehicles would qualify for these lights. He asked if they envisioned all their vehicles could have these lights.

David said that they had the same question in the House Transportation Committee. He said the fire engines are one part of this and then they have the Command Units. The strike team will have a strike team leader to make sure that everyone is safe and working in an efficient manner and he would have a light. Also the instant commander will have one on his vehicle.

Senator Lee asked if there was anymore testimony. Hearing none, Senator Lee closed the hearing on HB 1087.

Senator Andrist moved a Do Pass on HB 1087.

Senator Nething seconded the motion.

The clerk called the roll 6-0-0.

Senator Andrist will carry the bill.
