Minutes:

Brigadier General Alan Dohrmann, Deputy Adjutant General, Office of the Adjutant General, presented the attached testimony in support of HB 1138. **(Attachment 1)** He gave some other information: They are competing with border states, principally Minnesota, to recruit and retain their members. Minnesota currently has a program in place where they can get university fees, either under the federal or state program as they administer in the state of Minnesota. This tuition assistance program is challenging to administer. Since 2006 they have received approximately \$4.765 million from the federal government to run the Army National Guard Tuition Assistance program with the federal money. All that federal money is funded through supplemental, so every 6 months, 12 months, they are waiting around to see what is going to be in the supplemental—to see how much money they have to administer the program on the federal side and then figure how much state money they need based on what was received from the federal government. Obviously, when the federal money begins to dry up, and they think that at some point in the future, it probably will, they will have to bring the scope and tuition program back down. Pre 911 they were paying roughly half of all our service members' tuition. Right now they think the federal money will be there. They think the VA or the new GI benefit will help them make their state money go as far as possible but would like

the flexibility in the future to draft this program based on current requirements and current federal funding to give the best possible package to their service members.

Vice Chair Lisa Meier: About how many enlisted members actually attend college right now?

General Dohrmann: On the Air National Guard side, we have about 120. On the Army National Guard side, about 600.

Rep. Jerry Kelsh: What does the repeal section do—what does that say?

Chairman Kelsch: The repeal is that ND National Guard Tuition Fund--is hereby established a special trust fund.

General Dohrmann: Back in the 70s there was a trust fund set up, the tuition assistance program of \$7-\$8 million. That was exhausted probably by the late 80s and that is what we refer to in that section.

Rep. Corey Mock: I am curious. The appropriation--you mentioned there was no fiscal note because this would be provided in the current appropriations for tuition reimbursement. Is there currently a surplus or are you utilizing the entire appropriation for the tuition reimbursement?

General Dohrmann: Yes, we are. The appropriations line item is actually for tuition assistance and recruiting retention programs. There is some flexibility within that to pay for both recruiting retention programs and tuition assistance. We kind of lump them altogether because tuition assistance is a recruiting retention program. The money has not all been spent this biennium. We have two more semesters yet to pay out. We pay at the end of the semester. They have to prove that they completed their coursework and abided by all the rules established by the Adjutant General. We anticipate all the money will be spent. Again, in the years where there was no federal dollars coming in, we needed to use all our money for

the tuition assistance program because that is first and foremost the must pay program we have within the National Guard for recruiting retention.

Rep. Lyle Hanson: Does it make any difference which career they decide to go into? If they are going into medical, it would be a lot more than if they were going to technical school.

General Dohrmann: It gives them the fees. I don't think we will ever have enough money where we can say we can kick out the tab for medical school or for someone to learn how to fly helicopters. That is a possibility under this, but living within our current means, we just wouldn't have enough money to do those sorts of things.

Rep. Lyle Hanson: Do you just deny them before they sign up for the guard?

General Dohrmann: We wouldn't deny them. They would be entitled to the same tuition assistance that is there for all the other soldiers. On the federal side, if you are on some of those specialties—doctors, nurses—there are some federal programs out there where they will provide a pretty nice bonus program on a commitment that you then serve six to eight years with the active or reserve component. There are programs for those professionals, because that is a tough area to fill both in the National Guard and the active side.

Rep. Phillip Mueller: Does the tuition fees cover basically all the expenses of a guard person going onto a higher education?

General Dohrmann: No. My oldest kid is 11, so I have lost touch what it costs to go to college. Just the basic fees, my understanding, can be between \$400 and \$600. This does not include books. This does not include room and board. There continues to be expenses for our service members. Again, in this competition with Minnesota, what they have done is maximize on the army side the federal dollars, and then they have taken their state money and above and beyond what you would consider the cost for them going to school, they have been actually able to provide stipends to the service members. I just don't think we can afford to go

there, but we at least need to get our service members to the point where when we say 100% tuition, we have the options. That means fees, because those fees with ConnectND and some of the other ones that have popped up over the last several years are getting quite expensive. There was no opposition to HB 1138. The hearing was closed.

Chairman Freborg opened the hearing on HB 1138. All members were present.

Captain Michelle Hagel, Joint Staff Judge Advocate, Office of the Adjutant General, testified in favor of the bill. See written testimony.

Senator Taylor asked if their goal of 100% tuition would be 100% of tuition and fees.

Captain Hagel said that is correct, fees are not currently included.

Senator Taylor asked the ratio of state and federal funding.

Captain Hagel said that has been changing. The new GI Bill on the Army side has been covering more. They do not know what to expect from the new GI Bill. They will go after the federal funds first and use state funds as a backup.

Senator Bakke asked why they are repealing the special trust fund in the state treasury.

Captain Hagel said it is old language, they haven't used that trust in ages. They use general fund dollars.

Senator Bakke asked if there is money left in the trust.

Captain Hagel said there was no money put into the trust.

Senator Flakoll asked if the bill is revenue neutral or are there other dollars in another bill.

Captain Hagel said they requested money through their appropriation bill. This bill is for permission to pay fees.

Senator Flakoll asked how big of a change does this make to the appropriations bill.

Captain Hagel said they have not requested a change. The fees on the Army side are being paid with federal dollars. The dollars in the appropriations bill would cover fees, estimated to be \$66,000 per semester.

Senator Flakoll said UND is specifically referenced, can their members take classes at other institutions?

Captain Hagel said yes, they referenced UND because it is the most expensive.

Senator Flakoll asked if their students are mostly undergrads or if this can be used for the aeronautics school or medical school?

Captain Hagel said it is all undergraduate students currently.

Senator Bakke asked if they are contemplating a change to include graduate school.

Captain Hagel said she is only thinking of being allowed to pay fees for their students for undergraduate study.

Senator Bakke asked how many of their members are in school now.

Captain Hagel said 1500 plus.

Senator Taylor asked the number of their appropriations bill.

Captain Hagel said it is HB1016.

Senator Bakke asked if there is any portion of educational expense that is paid by the students themselves.

Captain Hagel said they pay for books and housing.

Chairman Freborg closed the hearing on HB 1138.

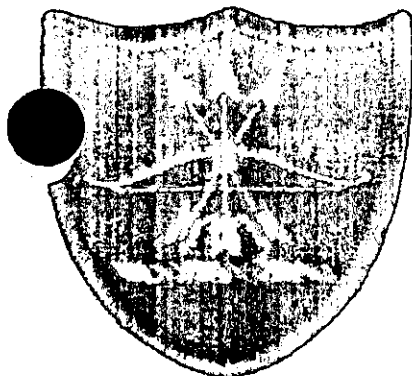
