**Chairman Lyson** opened the hearing on SB 2235.

**Senator Klein** introduced the bill. People with grown children who have moved out of state brought the idea for this bill to him. He also is aware of the possible economic impact of this bill on our state.

In favor: **Mike Rud**, President of ND Petroleum Marketers and ND Retail Association, spoke in favor of the bill for the same reasons Senator Klein put forth. It is good for the economy and our retailers.

In favor: **Alexis Brinkman** presented written testimony on behalf of Dana Bohn, Executive Director of Tourism Alliance Partnership. See **Attachment #1**.

In opposition: **Foster Ray Hager** presented written testimony. See **Attachment #2**. The non-resident hunters already have adequate time to come here and hunt. This bill appears to help the hunters in neighboring states.

**Mike Donahue**, ND Wildlife Federation, spoke in opposition to the bill. He feels this would put pressure on access to the land, and pressure on the wildlife. We feel we are at a good balance and feel we ought to leave it alone.

**Senator Triplett**: You represent wildlife clubs across the state, is that right?

**Mike Donahue**: Most of our clubs are in the central and in the eastern part of the state.

**Senator Triplett**: It seems there is more support for economic development coming from the western part of the state than from the eastern part. The eastern part of the state is more concerned about the pressure. Where would you draw the line from speaking to club members? Where does the competition for hunting time and space get critical?

**Mike Donahue:** Wherever the birds are, that's where the pressure is.

In Opposition: **Nancy Beuchler** representing the United Sportsmen of North Dakota, an association of approximately 600 sportspeople throughout the state, spoke in opposition to the bill. They feel the balance has already been struck and would like leave it as it is.

Chairman Lyson: Closed the hearing on SB 2235.

Nonresidents are allowed to purchase only one waterfowl license per year. This bill expands the options for nonresident hunting periods to include a three 4-day hunting period in addition to the current two 7-day hunting periods. The new three 4-day hunting period would be at the same price.

We do not anticipate a change in the number of licenses sold based on this bill. Nonresident hunters can only purchase one waterfowl license per year and they will pick which hunting period option meets their needs. The addition of the three 4-day hunting periods will have no fiscal impact on license sales.

Testimony of Dana Bohn

SB 2235

Chairman Lyson and members of the Senate Natural Resources committee, my name is Dana Bohn and I am representing the North Dakota Tourism Alliance Partnership (TAP). TAP is a coalition of tourism-related industries including convention and visitors bureaus (CVBs), state attractions, businesses and other stakeholders in the viable and growing tourism sector of North Dakota's economy. I am here today in support of SB 2235 and urge a do pass on the bill.

Tourism is one of the largest industries in North Dakota, offering some of the best opportunities for economic development in the state, and hunting and fishing are important components of the tourism industry. Each year, 139,000 people hunt in North Dakota and the average hunter spends \$729 annually. The total economic impact of hunting on the state is \$278 million.

Currently, the state's nonresident waterfowl licenses are valid for 14 consecutive days or two seven-day periods. SB 2235 establishes a nonresident waterfowl license that is valid for three four-day periods. This, in turn, will allow provide visiting hunters with more planning flexibility and the option to return to the state on additional hunting trips. This will also benefit residents of our neighboring states by providing an extra weekend to make a trip to hunt in our state.

North Dakota is attractive to outdoor enthusiasts from across the country and 23,625 nonresident waterfowl licenses were purchased in 2010. The dollars that out-of-state hunters bring to North Dakota are new money and benefit many tourism related business across that state. TAP supports initiative that bring tourists to North Dakota and we believe providing a more flexible option for nonresidents waterfowl hunters will help to bring additional visitors and dollars to our state. We ask for your support of SB 2235.
