Vice Chairman Schaible: Opened the hearing on SB 2222

Senator Flakoll: My name is Senator Tim Flakoll, District 44, Fargo: I wish to testify in support of SB 2222. (Written Testimony #1 and #2 attached)

Senator Heckaman: Has there been any thought to increase the rigor for proficiency on the ND state Assessments.

Senator Flakoll: There is a bill to do that. Several things have been discussed. Senator Cook has a bill he passed.

Senator Luick: For the record would you elaborate Cook's bill that was passed?

Senator Flakoll: That is the bill the Senate passed last week unanimously to mandate a study of how best to utilize the interest in income off of the legacy funds.

Senator Tony Grindberg, District 41: I was pleased when Chairman Flakoll asked me to sign on to the bill. There was a meeting on tying K12 education in August of 2006. An expert from Michigan described a Philanthropist in Kalamazoo Michigan called the Kalamazoo promise. The program was to incentive for families to put kids in the school system to grow the area. A similar bill has failed and I wholeheartedly support this concept. I would like to see this institutionalized. It is an exciting program that will change generations.

Representative Mark Dosch, District 32: I stand in support of SB 2222. This is an eight year incentive for students that is costing the state only four years. I fully support increasing this to \$10,000. It is a way that the state of ND can encourage students. It is the right thing to do for our kids.

Representative Joe Heilman, District 45: I have some data (Written testimony #3 attached) I think an initiative such as this to increase scholarship amounts can go a long way to help. It rewards achievement for high school and collegiate level.

Senator Heckaman: I am fully in support of this program. I am looking at the other 70% of graduates who don't have access to the funding. What would you suggest for them?

Representative Joe Heilman, District 45: We have several needs based that should be discussed on a separate note. Anything we could do to help lower cost of education will help.

Chairman Flakoll: As I read your handout we would be covering 74.5% of tuition at BSC and NDSU we would be covering about 44%.

Kirsten Baesler, Superintendent, North Dakota Department of Public Instruction: I am here today to offer my support of SB 2222. Anytime we can offer additional support to our students for the costs of higher education is beneficial to ND as a whole. Keeping them in North Dakota is an additional benefit. Today I want to focus on what this increased incentive could do. This bill has provided the opportunity for more interest of our parents in what their children are taking in high school. Often times students' parents aren't involved in course registration. This caused parents to be much more involved.

Chairman Flakoll: Could your office do some type of recognition certificates without legislative intervention or should we put something in the bill?

Kirsten Baesler, Superintendent DPI: I think all students should be recognized. I think it is a simple process. We should not need legislative action.

Senator Luick: If you take away the needs based funding and or the students that don't have the rigor in high school to get on this program, is there anything for someone in between?

Kirsten Baesler, Superintendent DPI: There are numerous proposals. This is only gaining ground and momentum. I believe more students will be seeing this and it will become more inclusive.

Senator Heckaman: What can I tell my administrators who are looking at this as a shift in their curriculum and their ability to keep the arts going in their schools.

Kirsten Baesler, Superintendent DPI: This program is a work in progress and the legislators will work through it.

Senator Luick: Bordering states qualify for this right? What about homeschooling? Is that inclusive?

Kirsten Baesler, Superintendent DPI: Bordering states qualify. The difficulty is with the transcripts for the home educators. There would need to be some changes to be inclusive.

William Woodworth, President of the North Dakota University System: I wish to speak in support of SB 2222. (Written testimony #4 attached)

Chairman Flakoll: Did your organization vote on this?

William Woodworth, President of the North Dakota University System: We voted on this in September on our last meeting. We had about 70 students across the 11 campuses. There was wide support.

Robbie Lauf, North Dakota State University Executive Commissioner of Governmental Relations Intercollegiate Affairs, Head delegate of the North Dakota University System: We brought five students from NDSU here that were recipients of this scholarship. As you can see from attachment #5, NDSU Student Government voted on this. We support SB 2222. This scholarship is why I am at NDSU and in North Dakota. This does not make it a problem for the arts students. I am excited for the raise of \$10,000. It is another reason to work hard. I am at the \$6,000 level but I am beyond thankful. I knew several students who had a goal of 24 on the ACT to qualify for this. It is becoming a determining factor of what we want now.

Senator Heckaman: What was your incentive in High School to do well on your Junior Assessments?

Robbie Lauf, NDSU GRIA, Head delegate of NDUS: My incentive was academic honesty but it is not equivalent to the ACT. It is important to me but the teachers make sure we know the importance of the testing.

Chairman Flakoll: What is the average ACT test score for your campus this fall?

Robbie Lauf, NDSU GRIA, Head delegate of NDUS: I will have to get back to you.

Bryce Heustis, Student Government member at NDSU: When you talk about higher education you are usually talking about dollars, facts, scores but family is important. A big aspect of college is the parents. College in North Dakota with these scholarships seals the deal for a lot of students. From my experience I can say this was a huge factor.

Chairman Flakoll: Are you seeing an increase of students working and decreasing student loans.

Bryce Heustis, Student at NDSU and member of Student Government: I am receiving scholarships and working so I cancelled one of my federal loans.

Jon Martinson of the ND School Board Association: We want to support this bill and want to increase the funding. I just want to raise the issue of the 2.75 GPA. It seems a little low but we do support the bill.

Bev Nielson of the North Dakota Counsel of Educational Leaders: We support SB 2222 primarily as recognition of significant academic achievement. I like the maintaining GPA in college as well.

Robert Kringler, Student Senator at North Dakota State University: I am speaking on behalf of a recipient of this scholarship. I see this as a true investment in our students. I am studying History and Music and if you are motivated you will find a way. I would not be in state if it wasn't for this scholarship.

Senator Heckaman: If we are giving this to the brightest and best, do you think the 2.75 GPA at college should be raised?

Robert Kringler, Student Senator at North Dakota State University: I think the 2.75 is a good level for the learning curve.

Cole Kuester, Student at the University of North Dakota: I am not receiving this particular scholarship but I am a part of the ND Scholars program. It took a lot of stress off my shoulders. I would like to show my support for this bill.

Robert Valley, Student of NDSU in district #16 in ND: I am here for support as a big brother who is a freshman in High School. He is looking to his future opportunities. In my time at NDSU, I know that he is looking forward to his opportunities. This mentality will shift where students are at higher levels of academic rigor than ever before.

Chairman Flakoll: Was the state board supportive of this when you were on there?

Robert Valley, Student of NDSU in district #16 in ND: I believe the state board would be supportive of any of these scholarships. It is one less thing for students to worry about.

Gina Padilla, Assistant Director of Financial Aid at North Dakota University System: I wish to testify in support of SB 2222. Seeing this program be put into place has been a wonderful experience. This program has prepared student for college. From the University System, I would like to offer our support for this bill.

Chairman Flakoll: Does anyone wish to testify in opposition of SB 2222? Seeing none I will close the hearing on SB 2222.





Explanation or reason for introduction of bill/resolution:

A Bill for an Act to amend and reenact NDCC relating to North Dakota scholarships.

Minutes:

Chairman Holmberg: Opened the hearing on SB 2222. All committee members were present except Senator Warner.

OMB - Tammy R. Dolan
Legislative Council - Brady Larson

Chairman Holmberg: It will cost 3.7 million dollars to implement this bill next biennium. The following biennium it would be 8.8 million dollars. This bill increases scholarships. Will you explain the similarity or differences between this and what is already in the Higher Education budget? There are changes to the scholarship program in the Higher Education budget.

Tammy R. Dolan: SB 2003 also increases the scholarship cap to the same level that is instituted in SB 2222. We included the amount of the appropriation for changing the scholarship cap.

Chairman Holmberg: Looking at this and looking at the fiscal report of this 3.7 million dollars, is this duplicative of what is already in SB 2003?

Brady Larson: You are correct that it would be duplicative; however SB 2222 does not include an appropriation.

Chairman Holmberg: The difference is different policy as to when the money would be available. This will end up going to the subcommittee of Higher Education.

Senator Flakoll, District 44, testified in support of SB 2222 relating to merit based scholarships. **Written testimony #1, Attachments # 2 & 3**

Senator Wanzek: When we changed the requirements for the scholarship from 12 credits to 15 credits per semester this young nursing student lost her scholarship. Is there anything we can do in that situation? .

Senator Flakoll: The North Dakota University system sent out notices to everyone and this young lady should have received the notice that the full load was at least 15 credits. As we know, 12 credits will not graduate our students in four years. This was changed last session to allow for 12 credits for two terms and 15 thereafter. There have been four cases that I've heard of across the state. There has been talk of modifying but the policy committee thinks we are in a good place at the present time.

Senator Wanzek: I am not saying we reduce the requirements. I was just concerned about this situation.

Vice Chairman Bowman: Is the intent to get more students going to smaller colleges because of the requirements and percentage of tuition. I know to get into NDSU and UND you have to have a higher grade point average. This basically rewards students going to a smaller school that doesn't require that grade point average.

Senator Flakoll: There was discussion prior to passage of HB 1400 that had the original language in it. It was concluded that we needed the open market in the system to hold down tuition. Here they can do some shopping and there is a greater tendency for institution to hold down their tuition costs.

Senator Carlisle: Do I understand that when including the word "private", these student scholarships can be given for all the institutes including Jamestown, University of Mary and others.

Senator Flakoll: Yes, it would include University of Mary, Jamestown College, Rasmussen, and Ellendale Trinity Bible Institute. With this bill the dollars are sent to the institution on behalf of the child. We are not directly funding those campuses because that would be a violation of the constitution.

Chairman Holmberg: This scholarship program is for North Dakota residents.

Discussion followed on other programs that would help students at these levels. Many of these students would qualify for additional scholarships.

Senator O'Connell: Would tribal colleges qualify under this?

Senator Flakoll: Yes.

Discussion on ways to hold down tuition and tracking to see if this type of scholarship program helps keep the universities from accelerating tuition at the same level. Continued discussion on the base amount of credits and if there could be exemptions for students or grandfathered in program.

Chairman Holmberg adjourned.



Explanation or reason for introduction of bill/resolution:

A Subcommittee hearing regarding North Dakota Scholarships

Minutes:

Chairman Holmberg called the subcommittee hearing to order at 9:00 on Tuesday, February 19, 2013 in regards to SB 2222. All subcommittee members were present: Senator Wanzek, Senator Erbele, Senator Krebsbach, and Senator Robinson. Brady Larson from Legislative Council and Tammy R. Dolan from OMB were also present.

Chairman Holmberg: this bill is problematic from the standpoint that it does provide the framework for an increase in scholarships but does not provide money. The University System shall provide X dollars and then the money is supposed to come from someplace.

Senator Wanzek this is the bill trying to address the issue. I brought up the situation of the student who took dual credits in high school, she has met every other criteria. Last session when we went from 12 credits per semester to a requirement of 15 per semester. Because of that change she lost her scholarship. Some of us felt that in fairness to someone like that we should have grandfathered them in. I have spent time with council and DPI and found that this had been a problem with some other folks. The best thing I could come up with is an amendment to allow them to receive their scholarship in their senior year. I passed out the amendment #13.0147.03002. We did not put any fiscal impact in this amendment. I'm assuming it will be minimal. Didn't we figure some numbers were duplicative.

Brady Larson: there would be maybe 100 to 200 students that could potentially qualify for scholarships under this amendment but it is unknown if those students are still in school.

Senator Wanzek: It appears we are trying to put a band aid on a situation. I remember the people were upset because we gave them the scholarship and yanked it away when we changed the amount of credits.

Chairman Holmberg: I suggest we put the amendment on then decide what we want to do on the bill so it can be on the floor. And then we can add in to SB 2003, the money for the concept. If that is a direction you are comfortable with, make the motion.

Senator Wanzek: Moved the amendment 3002.

Senator Erbele: Second

All in favor.

Senator Wanzek: moved the bill as amended.

Senator Erbele: Second.

Chairman Holmberg: All in favor. Put it on our list.

Brady Larson: There is \$3.7 million in SB 2003 for the programs so this bill is duplicative of what is in SB 2003 already as far as the funding and the statutory changes being made.

Chairman Holmberg: So we don't have to make a change in SB 2003.

Brady Larson: The only change required is to remove the statutory changes for the program included in 2003.

Chairman Holmberg: Then it isn't as critical. If this doesn't make it to the calendar, all we have to worry about is you telling the House that there is duplicate language. We will take 2222 later this afternoon. Closed the hearing on SB 2222.



Minutes:

Chairman Nathe: Opened hearing on SB 2222.

Senator Flakoll: Sponsor, support. See attached testimony #1. Ended testimony at 5:23.

Chairman Nathe: In regards to Senator Wanzek what line was that on?

Senator Flakoll: Page 3 lines 10-16 inclusive.

Representative Wall: You mentioned the change in the ACT test score. Am I assuming the work keys requirements stay the same?

Senator Flakoll: I didn't touch too much on the requirements kept them really all the same as they were established originally in the 2009 session. The one thing that has been discussed is if there is a student who didn't want to go to college right away but when they are out in the work force they decide they want to go to college after all. If they don't fill out the forms in a prescribed time they are ineligible so we thought we would leave it up to the committees to allow them a window for a year after they graduate to go back and do that.

Representative Rust: What school is still on the quarter system?

Senator Flakoll: I believe it is Rasmussen. I provided a list of those within the university system the 2012-13 tuition fees and rates and how much of this new proposal it would cover. It ranges approximately from 34.5% at the University of North Dakota up to a high of 64.3% at the Dakota College of Bottineau. See attached testimony #2.

Chairman Nathe: In the 2011-13 how much of this program was under the current structure?

Senator Flakoll: The challenge we had was the first class was 2010 and we started the second year of the biennium and we had freshman and sophomore then the next year we had freshman, sophomore, and juniors and now we have freshman, sophomore, junior, seniors, and some deferred and because of that our data will be lagging in terms of their outcomes.

Representative Meier: Do you have any data on those two thousand some students that receive the North Dakota scholarship what percent of those students were not eligible their second year for the North Dakota scholarship?

Senator Flakoll: Last session we made the provision where you could have one mulligan where if they drop down below the 2.75 required and even with that our data would be changed this fall because of that change we made last session. We're still kind of early to know. One student who had a 36 ACT score apparently had enjoyed their freshman year and didn't make the required GPA. There is some data that shows those with a 35 ACT test score average a cumulative GPA of 3.96. There really is a correlation between their ACT and their GPA.

Representative Meier: So we don't have any data on how many students took advantage of that mulligan opportunity?

Senator Flakoll: We could get that but we didn't request it. The system should be able to provide you with those with an oops and those with two oops who would be out of the program.

Chairman Nathe: Can you explain to me why you're reducing the credit hours from fifteen to twelve?

Senator Flakoll: That would only be for that 2010 class because as we passed the bill in 2009 we only required them to have 12 credits but as we move forward and we have more knowledge there is concern on getting these students through in a timely fashion. We increased that starting with the second year to gently knudge them forward. It would save them a full semester by taking 15 credits rather than 12 credits. In the data last session there were approximately 80% of those who took 15 or more but there was also some who did not. Medical schools look at a rigorous class loads.

Representative Heller: Do you think this scholarship program is not currently popular because the amount of this scholarship is too low and that's why you decided to increase it?

Senator Flakoll: I think this program is wildly popular.

Representative Heller: The fiscal note says by 2015-17 this could cost a total of \$25 million?

Senator Flakoll: That's because as we move from more students being on it we believe we will have more students that will be eligible because we are increasing the rigor with the curriculum requirements. Going from \$6,000 to \$10,000 that will cause that 65% increase.

Chairman Nathe: Why the \$1,000 increase per year?

Senator Flakoll: I think we like the fact that looking at a reward system where the money follows the students and if we were to pick them out \$10 million a lot of people have a

preference to reward our North Dakota students to stay in North Dakota and rather than send that comparable amount of money to the campuses.

Chairman Nathe: Any further support of 2222?

Representative Mark Dosch: Co-sponsor, support. There wasn't a scholarship program for my first two children who went through the system but my last one we did. As a parent and school board member the excitement not only from the school but also the parent involvement and when they know there is money on the line and their kids can get a scholarship it has shown improvements in test scores. Because a student has to qualify for the scholarship program every year it keeps them motivated throughout high school and college. With tuition increases this is putting money into those hands of the kids that helps offset the increases in tuition.

Representative Koppelman: Does this have any overlap with the house bill that dealt with GPA and things?

Representative Dosch: My house bill will change the requirements from a 24 ACT and a 3.0 GPA to 24 ACT or a 3.0 GPA. Either student would then qualify for this opening it up to more students.

Chairman Nathe: Any further support of 2222?

Senator Wanzek: About a year ago I was contacted by a constituent who is very deserving of the scholarship and she achieved the scholarship. When she entered college she had already completed 30 course credits through the dual credit program in high school. She attended Jamestown College and took up nursing. We gave her the scholarship before the 2011 session of \$1,500 and she achieved the GPA needed to continue receiving that money. Last session we changed the credit requirements from 12 to 15 and she ended up losing her last two years. The amendments grandfathered them back in. She won't be able to retrieve her past two years of scholarship but it would allow her the scholarship for her senior year. I feel we should grandfather them in and allow them to finish under the agreement we made with them at that time. This is an effort to try and address where we maybe have made an error last time in not grandfathering some of those people in.

Chairman Nathe: These are students who are graduating for college?

Senator Wanzek: Yes.

Representative Johnson: Have you found others where this has happened?

Senator Wanzek: When I was first contacted I immediately got in contact with DPI and they said this has happened to a number of students. It impacted more than just one person. The best number I could come up with is about 100 people who would be in the same situation.

Representative Koppelman: For those that were grandfathered in and would only be taking 12 credits would the amount of the scholarship be grandfathered in to the old amount as well? Obviously when you buy more credits it costs more so we're giving them more money.

Senator Wanzek: I believe there is language in the bill that those who are under the old number of \$1,500 would only be getting that amount their last year not the \$2,500.

Representative Rohr: If this bill passes whose responsibility would it be to notify those 100 people?

Senator Wanzek: I would make it known to the DPI and hope they would contact those individuals who would be in this similar situation. I hope that this is some kind of notification or awareness sent out so these individuals know they can redeem their senior year.

Representative Mock: Do we need to put an emergency clause on this in order to give them a chance apply and become eligible?

Senator Wanzek: I would agree with that.

Chairman Nathe: That's a good suggestion. Representative Schatz will be the carrier on the bill and he's going to talk to DPI and come up with some language to make an amendment as far as notifying the effected students.

Senator Wanzek: I understand the reasoning by going to 15 credits and why we want to encourage kids to pursue college vigorously.

Chairman Nathe: Further testimony for 2222?

Abigail Mel, student at Jamestown College: I'm currently a junior nursing student at Jamestown College. I graduated from Jamestown High School in 2010 and at that time the scholarship requirements were the 24 or higher ACT score and enrollment when in college was a minimum full time credits of 12 credits per semester. I think the GPA was around a 3.0. I am set to graduate in 2014. My GPA has maintained well above the requirement; I have about a 3.8 GPA. I met the 24 or higher on the ACT. When I started college as a freshman I started with 30 credits that I had already earned through dual credit courses and AP courses while in high school. I received a letter after my freshman year in college notifying me that the scholarship requirements had changed for 2011 changing the credit requirements to 15 credits per semester and they made it retroactive to my graduating class of 2010. I was disappointed because I already had my semesters planned and I had all my general education requirements completed so I knew how many credits I needed in order to graduate. As a freshman I took 16 credits in the fall and in the spring. I also took four semester credits in the summer. My sophomore year was the first year I wasn't able to receive my scholarship. In the fall of my sophomore year I had 12 credits and in the spring I had 13 credits. In my junior year I took 12 credits and I am currently taking 12 credits this spring. I will be taking 14 credits both semesters in my senior year. Besides my credits I

also have clinical hours, about 23 ½ hours per week. I also have hours of work to study for exams, papers to write, care plans, and four to five hours of pre-clinical prep work.

Chairman Nathe: Any further support of 2222?

William Woodworth, President of the North Dakota Student Association: See attached testimony #3. Ended testimony at 35:09.

Chairman Nathe: Anyone else here in support of 2222?

Leeann Nelson, North Dakota Education Association: NDEA supports the current scholarship along with the increase in the scholarship but we also support the eligibility requirements currently to receive those scholarships particularly if you're going from a possible \$6,000 to \$10,000. At first when I saw this bill I thought this was more money for the high achievers but I talked with some English teachers who told me the significant increase in achievement they have seen has been coming from the students with special needs. As teachers we have to get through a certain curriculum and students who are struggling anyways are getting further behind. I thought maybe we could get some of these kids with special needs to be able to qualify for some of these scholarships with some of these common core standards coming into play.

Chairman Nathe: Anyone else here in support of 2222? Anyone in opposition? Seeing none we will close the hearing on 2222.

Ch. Nathe: Discussion pertains to page 3 line 10-16. Dealing with 12 credits, changing it to 15 and catching kids falling through the cracks. One question was if this bill was to pass, notifying those students who were grandfathered in and we were told the higher education system would catch it and do it. DPI indicated there may be an issue on the higher education side.

Matt Strinden, DPI: (0:56) Brought with him Gina Padea, with the ND Academic Scholarship on the University side. Once we make a determination scholarship with the department that goes to Gina and then students and their scholarship award are taken care of by her on the University side and follow the students. Discussed with Rep. Nathe the 12 and 15 credits and I wanted Gina to visit with you about some of the concerns with that.

Gina Padea, Assistant Director for Financial Aide at the University System office: (1:40) I am the person parents call when their students don't get 15 credits. Currently if they are required 24 or fewer credits then they could take 12 to be eligible for the scholarship in their last year of scholarship eligibility or graduate between certain dates. On management side, it is going to be difficult because we don't track how many credits students have left till graduation. It can only be implemented if a student requests their degree to be audited. As written the students may be able to use it the last quarter but no way for them or us to find out how many credits they have left for graduation until they go through the degree audit process.

Ch. Nathe: If they came and showed you, bringing it to your attention, they would be eligible?

Gina: (3:51) Absolutely, if they brought it to our attention.

Ch. Nathe: How many students are affected by this?

Gina: About 250 every semester.

Ch. Nathe: From your standpoint, there is no way to notify these kids, should we just go back to 12 credits, the way it was originally done?

Gina: If you want to do something for these two cohorts, the one who are originally under the 12 credit rule when the bill passed, that would be the easiest for them to understand and us to manage because we don't have that how many credits they have left item.

Rep. Heilman: (6:08) Out of the 250 students, those are the ones who don't have 15 credits but they have 12 but otherwise would qualify for the scholarship?

Gina: Yes.

Rep. Heilman: How many are currently participating in the scholarship program in total?

Gina: Last fall there were 2759.

Rep. Heilman: That's after the 12 credit or 15 credit?

Gina: That is with the 15 credit requirement.

Rep. Heilman: There would be roughly around 3000 then if we went to 12?

Gina: (6:57) For the fall semester there were 208 students who didn't for fall semester.

Rep. Meier: Out of the 250 students do you have any data showing how many up their credit hours and then got back on the scholarship funding?

Gina: I haven't pulled that data.

Rep. Meier: I think it would be good to look at if you could pull it.

Gina: For clarification, you would like to see the ones who were deferred for a semester because they weren't at the 15 credits but then were able to get the scholarship after that?

Rep. Meier: It would be helpful.

Gina: Currently we can't use professional judgement or an appeal for students because the law is written very black and white that there isn't any rule making authority. Even students who are progressing at an amazing rate and if for one semester we see they are at 12 but they are two semesters ahead of their academic program, we can't do anything for them.

Ch. Nathe: It is almost like they are being punished. I think they upped it from 12 to 15 to encourage. But it seems a lot are being hurt by this.

Gina: These are our best and brightest students, not the ones who go to party.

Rep. Heller: Do you think putting it back to 12, do you think it would be detrimental, would any student try less?

Gina: What I haven't done that I would like to do is look at these different cohorts and see how many credits they have completed and if they are an average above an average of 15 credits.

Rep. Heilman: When preparing data, I would like to see how many percent are taking 12, 13, 14, 15, up to 21 or whatever. Rather than here is the average of all, I would like to see how many percentage of the students that are qualifying would we affect if we changed it from 12 to 15.

Ch. Nathe: All the new ones would be at least 15. I would like to see it at the end of their career.

Gina: Unfortunately we don't have the ability to look at how far they are into it.

Ch. Nathe: I think the intentions were good in 2011 when they made the change but there are some serious problems as we found out.

Rep. Rust: I'm wondering if we are going to change it back to 12, then it might be a good idea to contact Anita Thomas and see what kinds of problems we encounter with that besides going ahead and doing it here because it may have a reference back to something else.

Ch. Nathe: It is in the bill on page 3, line 7.



Explanation or reason for introduction of bill/resolution:

A BILL for an Act to amend and reenact section 15.1-21-02.6 of the North Dakota Century Code, relating to North Dakota scholarships.

Minutes:

Chairman Nathe: Reviewed the bill and background.

Matt Strinden, DPI: Representative Koppelman had mentioned a potential change to the third bullet that might be a little easier, cleaner for the university system to track those students. The idea is that instead of putting a sunset window, essentially taking the group of students that were the original cohorts under the original rules of the scholarship, which require the twelve credits, and allowing those students to complete their scholarship course with the twelve credits. The students who got the scholarship after that change was made would continue to move with the twelve credits and five credits subsequently as those students who were aware of that requirement when applying.

Chairman Nathe: Do you have amendments to that effect?

Matt Strinden: I do not.

1:50 **Rep. B. Koppelman:** I have language for an amendment. Read the suggested amendment.

Chairman Nathe: Would you work with Kirby to put that in amendment form so we can see it? Gina, would you come to the podium?

2:55 **Gina Padilla, North Dakota University System:** Distributed handout, **attachment 1.** Rep. Meier had asked about students who do not receive the scholarship due to insufficient credits, if it would be reinstated in subsequent semesters. Provided data. We talked about whether the credit requirement is doing as intended. Provided data.

6:11 **Rep. Rust:** Of those students who did not receive scholarship payments, was the credit load the only criteria they failed to make?

Gina Padilla: The only criteria they missed was the credit criteria.

6:35 **Rep. B. Koppelman:** If we're encouraging students to take fifteen credits and to finish school in a reasonable time, I believe that is one piece of the intent. Another is to make sure that for a time period of a semester or year, that they are getting as much out of school as they can. Gave personal example. If a student is short of the necessary credits, are there not courses that would be beneficial to them? Wouldn't there be benefit in encouraging them to be better rounded?

7:52 **Gina Padilla:** Referred to testimony given during hearing given by a nursing student regarding a very defined program and expensive credits. We also talked about situations concerning internships or special courses outside of course load. A lot of students can pick up one or two extra classes, but it does not always work for all students.

8:59 **Rep. Meier:** Do you know what percent of students drop classes over the course of a semester?

9:38 **Gina Padilla:** That's for the official add/drop date to get a full refund of the tuition. After that, they can drop a course without a grade, but they still pay for it.

9:59 **Rep. Meier:** Do you have any data on the percent of students who start with the fifteen credits but drop a class because of not maintaining the GPA?

10:16 **Gina Padilla:** I pulled two data sets for the average number of credits taken. One was for data for the beginning of term after the add/drop date, and the other was data for the end of term. The second set matched the first set. On average, students are picking up classes at the same rate as they are being dropped.

10:50 **Rep. Heller:** Comment about students in nursing program. I don't know why we cannot go back to the twelve credits for students in high-pressure disciplines. Wasn't twelve rigorous enough?

11:55 **Chairman Nathe:** The rationale was to move students along on pace to a timely graduation.

12:02 **Rep. Kelsh:** The whole point is that those students may have taken eighteen credits for several of those semesters to get where they are. I think we can fix this so they get it at the end.

12:35 **Chairman Nathe:** We have Rep. Koppelman's amendments. We are also sending around some amendments from Rep. Rust, **attachment 2**.

12:52 **Rep. Rust:** I believe that one of the questions here was what happens if someone needs fewer than fifteen credits to graduate. What is coming around to you has a C on the upper right corner. Explained amendment, attachment 2.

14:22 **Chairman Nathe:** There was talk about credits tailing off at the end of the program.

Rep. Rust moves the amendment, attachment 2. Seconded by Rep. Heller.

14:38 **Chairman Nathe:** I see we struck lines 15-16 in this amendment?

Rep. Rust: At this point, I would only be looking at Part B(1).

Chairman Nathe: Was it your wish on the amendment to leave lines 15 and 16 on page 3?

Rep. Rust: Referring to page 3, section 7, B(2). Was that to take care of students who started in this program? Then that is separate. As such, I would only propose what is there as 7B, but I'd list it as a C.

Chairman Nathe: I think we could take lines 15 and 16 out. The language above in your amendment takes care of that; it covers students under twelve credits at the end of their program.

Rep. B. Koppelman: I think the real question for Rep. Rust with his intentions is that if you remove lines 15 and 16, you are basically saying that no matter when you started in the program, we are going to allow you to take fewer credits your last year if... Whereas the intent of the original exception and the intent of my amendment (**attachment 3**) to fix that original exception was just to band-aid the people who started with different expectations. Rep. Rust, do you intend to make an exception your senior year for everyone forever, or was that just a band-aid?

17:15 **Rep. Rust:** My intention in 7B would be that if that person requires fewer than fifteen semester hours to graduate, from here and forever, they can qualify for the scholarship if they take at least twelve.

17:41 **Unidentified speaker:** Then you should probably strike lines 15 and 16 if that is your intention.

18:00 **Rep. Kelsh:** This would also take care of anyone who started when it was still twelve hours, maybe had to take a semester off. I'm assuming they still qualify for the scholarship. Rep. Koppelman's is limited to 2010-2011 school year. So that would limit that not happening.

18:27 **Chairman Nathe:** That's how I understand it.

18:30 **Rep. Koppelman:** There is one other thing we need to be aware of if we not do my amendment and simply do Rep. Rust's. In the situation of the nursing student, Rep. Rust would essentially give her a scholarship for the fall semester, but she definitely would not qualify for the spring, maybe not for the fall because she will have more than fifteen credits left going into fall. Separately, we should discuss whether or not we want to fix that for the 2010-2011 students.

Voice vote on adoption of amendment presented by Rep. Rust, attachment 2. Voice vote carries.

19:38 **Rep. B. Koppelman:** Distributed proposed amendment, **attachment 3**. If we wanted to do something simple with what we have started here, we could do the amendment in front of you and add the remainder of lines 11-14 and essentially duplicate them to part 2. That would fix both semesters for the 2010-2011 students who went into it thinking they could do twelve per year and get the full scholarship.

20:15 **Chairman Nathe:** Asked for additional explanation.

20:20 **Rep. B. Koppelman:** I wouldn't be doing anything to lines 11-14; we did that with the amendment from Rep. Rust. I would duplicate the language, starting in line 11 with *may retain* and ending with what's in line 14. We'd paste that to the end of my amendment as part 2. For the students in the 2010-2011 year, it would provide scholarship for the fall and the spring of their senior year as a band-aid to the transition. Then it would expire off and could be deleted in a future session. We could add to that.

Chairman Nathe: Let's have Kirby write that up.

21:15 **Rep. Heller:** I wonder if we should run that past Anita and tell her our intent and ask her how we should do that.

21:26 **Chairman Nathe:** Rep. Rust should have that. He may have something addressing what you're talking about, Rep. Koppelman, which Anita had given him earlier. There is a fiscal note on this bill, so it will be re-referred to appropriations. Some of the changes we make will affect that fiscal note.

23:08 **Rep. Rust:** This one says that after six consecutive semesters, they require twenty-four or fewer hours, that they can do two semesters of twelve each.

23:23 **Chairman Nathe:** That's the original language.

23:34 **Unidentified speaker:** One of the concerns was that some people may get through school an entire semester early. If you say six consecutive semesters... Do they have to be consecutive if they took an internship or something?

24:06 **Rep. Wall:** Requested Matt Strinden review the amendments.

24:52 **Matt Strinden:** What was problematic in the original text of the bill was the credits themselves. The university system is unable to track that number of credits because of the audit issue we talked about. We would have no way to determine officially how many credits that student has remaining.

25:44 **Rep. Heller:** In order to fix this problem, could we turn the fifteen into a twelve on page 3, line 7?

26:02 **Matt Strinden:** My suggestion would be that in the original language regarding the exception, you may want to consider allowing those two initial cohorts the ability to maintain

the scholarship with twelve credits. Beyond those graduating years, those students would be required to maintain the credits currently in the code.

27:00 **Rep. B. Koppelman:** I think for what we have already talked about, this is correct. Since we struck subsection 2 with Rep. Rust's amendment, there would be a new subsection 2. Are you suggesting we need 2009-2010 as well?

27:30 **Matt Strinden:** Yes. The 2009-2010 would be that the tenth grade graduating class would be the first year of students who got the scholarship. Those students would have one more year remaining on their scholarship eligibility.

27:52 **Rep. B. Koppelman:** I would **move this amendment** (attachment 3) **with one addition**, and that it say during 2009-2010 or 2010-2011 school year.

Motion to adopt the amendment seconded by Rep. Meier.

28:20 **Rep. Kelsh:** Are we in trouble with the former amendment?

Chairman Nathe: I don't believe so. We are adding new lines on the bottom of page 3.

28:25 **Rep Rust:** I think it could still stay because I think you could still have students who end up that last semester not needing a full fifteen hours. I think that one is still good; it's just that I didn't cover the problem they were having.

Chairman Nathe: Matt, does this amendment before us address your issue?

Matt Strinden: You're referring to the most recent one with the addition of the 2009-2010? We believe that will fix it.

Voice vote on adoption of amendment offered by Rep. B. Koppelman. Voice vote carried.

Chairman Nathe: We have amended SB 2222 before us. What are your wishes?

29:34 **Rep. Mock:** Referred to case of a student on a specific program track to graduate. It does not matter what the law says; that individual or any student in that same program would only be enrolled in twelve credits in the final semester, correct? If someone graduates from high school this spring and enrolls in the very same program at the same college, four years from now they will likely be enrolled in twelve credits. They would not be in fifteen, so we will still have people who would not be eligible for this scholarship in their senior year. Correct?

Chairman Nathe: Under his amendment, they would be.

Matt Strinden: If I understand Rep. Rust's amendment correctly, in their last semester they would be able to do fewer than fifteen. Gina has said those students would have already filed their intent to graduate, so we would be able to track that.

Rep. Mock: So the auditing issue is not going to be an issue moving forward?

Gina Padilla: Hopefully not. If it is their last semester, they should have done their degree audit to know what they have remaining.

Rep. D. Johnson: We still have not addressed the issue of the junior year of that nursing student or of the student who had thirty credits toward a degree before she graduated from high school. Spoke of junior year for nursing students.

Rep. B. Koppelman: I am familiar with dual credit classes in high school. If you come into college with thirty credits, you can look at graduating potentially a semester early. Given that dual credits are often taken at a lower tuition rate, I think the student is better off than trying to stretch it out to make sure it's a full four years.

Rep. D. Johnson: The junior year is crunch time in a nursing program. Twelve credits is a good load when you're doing your clinicals.

Rep. Heller: I don't care if you leave high school with a hundred credits. Once you get accepted to that nursing program, you have to follow their schedule. You cannot jump ahead or graduate early.

Rep. B. Koppelman: My understanding is that once the state changed the law for all the schools in the state, knowing what the state will pay for, I'm assuming that some have taken into consideration how they schedule their roadmap to the degree. I don't see a way for us to make a ton of unique exceptions and still have the rigor the legislature was originally looking for. 1:06 Tammy Dolan, OMB: There was \$3.7M in the budget to increase it to \$10,000 for the original bill.

1:33 Representative Dosch: Went over amendment .04005. We were trying to expand the program to make more kids eligible. It takes it back to the Senate version, and reduces scholarship from \$10,000 to \$8,000. It then reduces the ACT requirement from 24 to 23. It doesn't change anything else. I've asked Laura Glatt (NDUS) to come up with some numbers. This increases it \$3.6M over the executive budget; how we got it from the Senate would have increased it \$3.7M. Chairman Delzer: I think the amendment is fine; but on the appropriations side the fiscal effect we need to look at.

5:36 Representative Skarphol: It does apply to both CT&E and academic scholarships and all students. I personally would rather give money to students rather than institutions; this is how we give money to students. Give students incentives. I'm going to support the amendment.

Chairman Delzer: Did you check if we had kept the amount at \$6,000 but went to the 23 on the ACT, how that would have affected the students?

Minutes:

Chairman Flakoll: opened the conference committee. All present.

Rep. Dosch: The House made two changes. The first is the dollar amount. There was concern it was going up too much, too fast. We backed that from \$10,000 to \$8,000. The other thing is trying to make more students eligible for the scholarship. A lot of kids were not getting the ACT score. If we did an "or" there was pressure on teachers so we changed the ACT from 24 to 23. Another 450 students would be eligible now.

Chairman Flakoll: I had Brady run some numbers of the total dollar amounts for the different version. (Attachment #1)

Senator Poolman: I really would like us to keep the ACT score at 24 because it is rewarding on a merit based scholarship rather than getting the average kids.

Rep. Skarphol: With that logic we should go to an ACT score of 28.

Senator Poolman: I would fully support that.

Chairman Flakoll: Did you change the work keys?

Rep. Dosch: No. My daughter had a 3.8 GPA in high school. She has issues with tests and got a 23 on the ACT. She refused to take it again because she was so nervous. I hear the same thing from parents.

Senator Poolman: I think helping 450 more kids is great but from an investment view, the greatest predictor of college success is the ACT score. If we lower the ACT score we are investing in kids who don't have as good of a chance of earning a degree and making it through those four years. On average scores go up 3 points if the ACT is taken again.

Rep. Williams: I was a high school principal for many years and there are some students that can't get the ACT score but they do very well in college.

Senator Poolman: I would just say again from the college standpoint, we have a lot of kids who work really hard. When they get to college they don't have the aptitude to take those tests. It is still about the end product and this is the only true objective measure.

Rep. Dosch: We are basing an entire scholarship on one test score and telling kids this is all that matters. They still have to prove themselves in college. What is wrong with giving more kids an opportunity?

Senator Poolman: Next biennium are we going to drop it to 22? Is it a merit based scholarship or are we subsidizing the cost of higher education? If it is a merit based scholarship let's keep it merit based.

Rep. Dosch: I believe by opening it up to a 23 that 33% of the kids would be eligible. Now only 20% qualify. It is still the top third. Giving them an opportunity is important.

Chairman Flakoll: I have a handout for college cumulative GPA's. (Attachment #2) We are at about 450 additional students in the first year which may translate to 1350 maximum.

Rep. Skarphol: I would rather see it help 600 instead of 450.

Chairman Flakoll: Do you think they will be more enthused about \$8,000 or \$10,000?

Rep. Skarphol: They would be excited with either.

SB2222 - Merit based scholarships

Mr. Chairman and members of the Senate Education committee. For the Record I am Senator Tim Flakoll. As a bit of a background, I also sponsored HB 1400 the original merit based scholarship bill and it had its genesis in the Governor's Commission on Education Improvement where I chaired the subcommittee on curriculum and rewards where the idea was launched.

Prior to the 2009 session, the state only required a certain number of credits for graduation but generally was not specific as to which courses need to be taken. The challenge that we were dealing with was we wished to pass curriculum requirements for the first time in the state's history and needed to find requirements that would suit our needs.

Our committee desired to continue our state's national reputation for high academic performance but we also recognized that not everyone could be successful with the rigor that would make us globally competitive. As such we decided to develop two tiers of graduation requirements. One, for the minimum requirements to graduate and the second curriculum requirements that would challenge students at a higher level and reward them if they made certain benchmarks.

Merit based scholarship eligibility requires an ACT test score of 24 or higher. I would note that historically about 27-30% of the students meet that threshold. I would also note that students can retake the test if they missed the threshold and want to take it. In 2011 23.5% of the Juniors had an ACT test score of 24 and above and 28% had a test score of 24 and above.

SB2222 is in keeping with our ongoing desire to retain the "best and the brightest" in the state of North Dakota. SB 2222 is relatively simple but extremely powerful. It raises the merit based scholarship threshold from \$750/semester up to \$1,250/semester starting with students that graduate this spring. That translates to about a 65% increase. It also increases the allowable cap up from the current \$6,000 to \$10,000 per student for students who graduate during the 2012-2013 school year.

Fall 2012 data reveals that 2,759 students were receiving the merit based scholarships including:

- 337 at two-year or Tribal Colleges
- 384 at four-year public institutions
- 1,706 at public research institutions
- 332 at private institutions
- Plus 681 students who deferred it till a later date

SB 2222 is one of a number of scholarships that the state offers. I should also note that the scholarship funds go to students both at public and private campuses. The merit based scholarship program is the one scholarship program that open to all majors and is not prejudice against family income.

Mr. Chairman I feel comfortable that our Senate colleagues will support this increase because in 2009 it passed the floor at \$8,000/student prior to being reduced through later action. The proposed increase will also help students keep pace with inflationary increases in tuition.

I would also like to note that this popular scholarship program has received a resolution of support from student organizations including the North Dakota Student Association, an organization that represents approximately 48,000 students across the state.

Mr. Chairman, I would also like to go on record as thinking that the funds for the merit based scholarship should eventually come out interest and income of the Legacy Fund which opens up after 2019. I originally had that language in the draft of this bill, but with the passage of Senator Cook's bill last week I thought it would be better to use his bill a vehicle to accomplish this portion of my goal.

SB 2222 provides a great incentive for both students and their families. It sends the funds directly to the school on behalf of the student which can help keep down student loans. It is limited to just North Dakota students who attend a North Dakota campus. It establishes a system of rigor and rewards and people like the fact that the money follows the students.

Quick Facts:

- *Students can defer the scholarship under current law, but funds are only available for six years after graduation.*
- *681 students deferred the scholarship during the fall 2012 semester (see Report of the North Dakota Legislative Management, 2013, page 183).*
- *Data has revealed that a student with a 24 ACT test score has about a 70% chance of obtaining a grade of "C" or higher and a 30% chance of obtaining a "B" grade or higher.*

HIGHER EDUCATION STUDENT SCHOLARSHIP AND OTHER FINANCIAL INCENTIVE PROGRAMS

#2

This memorandum provides information regarding programs administered by state agencies that provide scholarships or other financial incentives to higher education students or graduates.

SCHOLARSHIP PROGRAMS

Student Financial Assistance Grants

The North Dakota state student grant program provides approximately 7,900 to 8,500 nonrepayable grants to North Dakota residents pursuing their undergraduate degree while attending a North Dakota public, private, or tribal higher education institution. The purpose of the grant is to assist students with the costs of attending a North Dakota higher education institution and reduce the amount of money students need to borrow for their education.

To be eligible for a grant, a student must meet all of the following requirements:

- Be a citizen or permanent resident of the United States and a North Dakota resident.
- Be a high school graduate or have a general educational development diploma.
- Meet all admissions requirements as a full-time student of an eligible institution.
- Use the grant at an eligible institution in North Dakota.
- Be enrolled as a full-time student as defined by the institution attended.
- Enroll in a program of at least one academic year as defined by the institution attended.
- Be a first-time undergraduate student during the period of award.
- Not be in default on any federal financial aid loans.
- Not owe a refund on any Title IV grants or loans.

The application for the grant program is the federal Free Application for Federal Student Aid (FAFSA) and a student may apply for the grant each year by completing the FAFSA or renewal FAFSA application. Grant awards range from \$800 to \$1,500 for an academic year.

The state student grant program received a general fund appropriation for the 2009-11 biennium of \$19,025,594 which is an increase of \$13,202,097 from the 2007-09 general fund appropriation of \$5,823,497. The program is also anticipated to receive \$348,428 of federal funding for the 2009-11 biennium.

North Dakota Scholars Program

The North Dakota scholars program is a merit-based scholarship program that provides approximately 45 to 50 new scholarships to North Dakota high school graduates who attend a North Dakota higher education institution. To be eligible for the program, a high school student must take the American College Test (ACT) between October and June of the student's junior year and score in the upper five percentile of all North Dakota students who take the ACT.

The scholars program provides a full tuition scholarship to eligible students attending a public or tribal North Dakota higher institution. A recipient who attends a private North Dakota higher education institution is eligible for a scholarship equal to the cost of tuition at a North Dakota public research institution. The scholarship is renewable for up to three years provided the recipient maintains a cumulative 3.5 grade point average.

The North Dakota scholars program received a general fund appropriation for the 2009-11 biennium of \$2,113,584 which is an increase of \$635,018 from the 2007-09 general fund appropriation of \$1,478,566.

Native American Scholarship Program

The North Dakota Native American scholarship program provides scholarships to approximately 150 to 175 eligible American Indian students per year. Scholarships range from \$500 to \$2,000 per year and a student must meet the following requirements to be eligible to receive the scholarship:

- Be an enrolled member of a federally recognized Indian tribe and a resident of North Dakota.
- Have been accepted for admission at an institution of higher learning or state vocational education program in North Dakota.
- Be enrolled full time.
- Have a grade point average of at least 2.0.

The Native American scholarship program received a general fund appropriation for the 2009-11 biennium of \$381,292 which is an increase of \$666 from the 2007-09 biennium appropriation of \$380,626.

Career and Technical Education and Academic Scholarship Programs

The 2009 Legislative Assembly created the North Dakota career and technical education scholarship program and the North Dakota academic scholarship program. To be eligible for a scholarship, a student must be a resident of the state, graduate from high school during or after the 2010-11 school year, complete the requirements for a high school diploma,

and meet the following program requirements for one of the programs as follows:

Career and Technical Education Scholarship	Academic Scholarship
Complete one unit of algebra II	Complete one unit of algebra II and one additional unit of mathematics for which algebra II is a prerequisite
Complete two units of a coordinated study plan as recommended by the Department of Career and Technical Education	Complete two units of the same foreign language; one unit of fine arts or career and technical education; and one unit of a foreign language, fine arts, or career and technical education
Complete three additional units, two of which must be in the area of career and technical education	Complete one unit of an advanced placement course or a dual-credit course.
Obtain a grade of at least "C" in each unit or one-half unit required for a diploma	Obtain a grade of at least "C" in each unit or one-half unit required for a diploma
Obtain a cumulative grade point average of at least "B"	Obtain a cumulative grade point average of at least "B"
Receive a composite score of at least 24 on the ACT or a score of at least five on each of three WorkKeys assessments	Receive a composite score of at least 24 on the ACT

Students who graduate from high school during the 2009-10 academic year are also eligible for the career and technical education or the academic scholarships. To be eligible for an academic scholarship, a student must have obtained at least a 24 on the ACT. To be eligible for a career and technical education scholarship, a student must have obtained at least a 24 on the ACT or a score of at least five on each of three WorkKeys assessments as recommended by the Department of Career and Technical Education.

Any student that meets the requirements for a career and technical education scholarship or an academic scholarship is to receive a scholarship of \$750 per semester for each semester the student is enrolled at a North Dakota higher education institution up to a maximum amount of \$6,000. The Legislative Assembly provided a \$3 million general fund appropriation for the program for the 2009-11 biennium.

OTHER FINANCIAL AID PROGRAMS

In addition to student scholarship programs, funding is also provided for other programs that reduce the educational costs of students.

Professional Student Exchange Program

The professional student exchange program provides access to out-of-state institutions for North Dakota residents seeking to enter dentistry, optometry, and veterinary medicine programs. The

North Dakota University System has established contractual relationships with the Western Interstate Commission for Higher Education, Iowa State University, and the University of Minnesota regarding these programs. The contracts provide that the University System purchase a selected number of slots in the eligible programs in other states to ensure the acceptance of North Dakota students.

The professional student exchange program received funding for the 2009-11 biennium of \$3,337,100, of which \$2,346,130 is from the general fund and \$990,970 is from the student loan trust fund. The \$3,337,100 is \$614,154 more than the 2007-09 appropriation of \$2,722,946.

Education Incentive Programs

The 2009 Legislative Assembly provided funding of \$3,176,344 from the general fund for education incentive programs, which include the technology occupation loan forgiveness program and the teacher shortage loan forgiveness program. The \$3,176,344 represents an increase of \$1,436,030 from the 2007-09 biennium appropriation of \$1,740,314.

The technology occupation student loan forgiveness program is intended to reduce student loan indebtedness for individuals who have graduated in a technology-related field and have been employed in a technology occupation in North Dakota for one year. Recipients are eligible to receive up to \$1,000 per year in continued loan forgiveness for each year they are employed in an approved technology occupation in North Dakota subject to a maximum of \$3,000. Eligibility requirements for the program include:

- Successful completion of an approved, technology-related program at a public, private, or tribal higher education institution.
- Maintaining at least a cumulative 2.5 grade point average based on a 4.0 system.
- Having a student loan from the Bank of North Dakota or other participating lender and not being in default on the loan.
- Being employed in a State Board of Higher Education-approved technology occupation in North Dakota for at least one year following graduation.

The 2009 Legislative Assembly provided statutory changes to expand the technology occupation student loan forgiveness program to include recipients pursuing studies in science, engineering, and mathematics. In addition, the maximum loan forgiveness amount will be increased to \$1,500 per year up to a maximum of \$6,000. The revised program will begin in the spring of 2010 and will be called the science, technology, engineering, and mathematics loan forgiveness program.

The teacher shortage loan forgiveness program is intended to reduce the student loan amount of an eligible recipient teaching at a grade level or content area identified by the Department of Public Instruction as having a teacher shortage. Recipients are eligible



A strong merit-based support program is even more important with the current economic boom in North Dakota. 

As such we decided to develop two tiers of graduation requirements. One, for the minimum requirements to graduate and the second curriculum requirements that would challenge students at a higher level and reward them if they made certain benchmarks.

Merit based scholarship eligibility requires an ACT test score of 24 or higher. I would note that historically about 27-30% of the students meet that threshold. I would also note that students can retake the test if they missed the threshold and want to take it. In 2011 23.5% of the Juniors had an ACT test score of 24 and above and 28% had a test score of 24 and above.

SB2222 is in keeping with our ongoing desire to retain the "best and the brightest" in the state of North Dakota. SB 2222 is relatively simple but extremely powerful. It raises the merit based scholarship threshold from \$750/semester up to \$1,250/semester starting with students that graduate this spring. That translates to about a 65% increase. It also increases the allowable cap up from the current \$6,000 to \$10,000 per student for students who graduate during the 2012-2013 school year.

Fall 2012 data reveals that 2,759 students were receiving the merit based scholarships including:

- 337 at two-year or Tribal Colleges
- 384 at four-year public institutions
- 1,706 at public research institutions
- 332 at private institutions
- Plus 681 students who deferred it till a later date

SB 2222 is one of a number of scholarships that the state offers. I should also note that the scholarship funds go to students both at public and private campuses. The merit based scholarship program is the one scholarship program that is open to all majors and is not prejudice against family income.

Mr. Chairman I feel comfortable that our Senate colleagues will support this increase because in 2009 it passed the floor at \$8,000/student prior to being reduced through later conference committee action. The proposed increase will also help students keep pace with inflationary increases in tuition.

I would also like to note that this popular scholarship program has received a resolution of support from student organizations including the North Dakota Student Association, an organization that represents approximately 48,000 students across the state.

Mr. Chairman, I would also like to go on record as thinking that the funds for the merit based scholarship should eventually come out interest and income of the Legacy Fund which opens up after 2019. I originally had that language in the draft of this bill, but with the passage of Senator Cook's bill last week I thought it would be better to use his bill a vehicle to accomplish this portion of my goal.

For students who did not receive their scholarship for a semester because they were carrying less than 15 credits, but were enrolled with 12, 13 or 14 credits, were they able to get their scholarship reinstated in future semesters?

Answer:

According to the scholarship database, to date 535 students did not receive scholarship payments. 178 students did not meet the credit requirement during the spring 2013 term. Of the other 357 students that did not receive their scholarship for at least one semester, 250 students or 70% were able to meet the credit requirement and received their scholarship in a future semester.

Question:

Are scholarship recipients taking enough credits to complete their education in a timely manner and did the 15 credit requirement impact their average credit load?

Answer:

As a freshman, students are the requirement to take 12 or more credits. Even though they were only required to take 12 credits, students on average exceeded 15 credits.
