Explanation or reason for introduction of bill/resolution:

Relating to the monthly rent for games of chance sites.

Minutes:

Testimony #1

Chairman K.Koppelman: Opened the hearing with testimony in support.

Rep. Streyle: Introduced this bill on behalf of the ND Hospitality Association. Last session was passed what was allowed to pay for rent from \$200 roughly to \$400. I think that was an error. If you only had pull tabs it applied to. If you had pull tabs, a pig wheel and blackjack you weren't able to capture that. This is a fairness bill. It says if you have multiple services you can capture a higher rent.

Rudie Martinson: **ND Hospitality Association:** (See Testimony #1) (1:34-6:30) (mike not on)

Rep. Mary Johnson: So you think since the charities have less expense due to expensing devices they save on labor; the bars should get to charge more. Is that what I am hearing?

Rudie Martinson: It has less to do with their expense; someone still has to pay along with the utilities and labor. (mike not on)

Rep. Lois Delmore: Does each charity do a job of negotiating with the bar if they want to set up a site?

Rudie Martinson: Yes that is true. They negotiate with each site.

Rep. Lois Delmore: With the additional cost added do you know what the charity would pay to a bar for that space to the bar for renting that space?

Rudie Martinson: There is a ceiling but I don't have data on that.(mike not on)

Rep. Lois Delmore: I would like to see that data? I would assume since we all negotiate that there is a price range; there is not just one price.

Rudie Martinson: (mike not on).

Chairman K.Koppelman: It is a service or benefit to the charities but I assume it is also a benefit for the establishment to collect tickets for pay out winners or whatever else they are doing. At the same time I assume it is also a benefit to the establishment to have the charitable gambling there. Is that correct?

Rudie Martinson: (mike not on) That would vary with each bar owner.

Chairman K.Koppelman: Is the section of code we are looking at the same section that was amended last session with the unintentional issues?

Rudie Martinson: (mike not on)

Rep. L. Klemin: The \$200 to \$325; what did you say there that this was changed last session in an equitant amount or is this something new?

Rudie Martinson: (mike not on) It wasn't \$75 four years ago and the other section

Rep. L. Klemin: On line 6 it talks about paddlewheel tables and if you have been setting here a while you heard about this electronic paddlewheel. It seems there wouldn't be any reason to have more than one paddlewheel in a bar if they are electronic because they would all be doing exactly the same thing at the same time if they are run from a statewide server. Why have more than one paddlewheel table ever?

Rudie Martinson: It is more common to have more than one; there are more blackjack tables; (mike not on)

Rep. L. Klemin: It is set up so if you do have more than one paddlewheel table there would be rent times the number of paddlewheel tables.

Rudie Martinson: I don't know if there are more than (mike not on)

Rep. Mary Johnson: Bars with one liquor license have different parts of the bar so there are cases where it is not just a one room bar more than one paddlewheel in a larger bar wouldn't be uncommon, I wouldn't think.

Rudie Martinson: I don't know how common this is. (mike not on)

Chairman K. Koppelman: Do you see in your industry with technology a movement more concentration on that versus the analog for lack of a better term games and products and devices?

Rudie Martinson: We heard that in more rural areas (mike not on)

Rep. Brabandt: How do you handle situation whereby charitable organizations get behind on their rent.

Rudie Martinson: I don't know that answer.

Deb McDaniel: I think it would bring in a different customer base.



Ch. Hogue: We will open the hearing on HB 1448.

Rep. Roscoe Streyle: Sponsor, support. This bill is to make the rental fees for all games in the charitable gaming arena be the same. Costs have increased; the rental rates were changed in the last session. The last increase was over 15 years ago. Obviously with increasing costs the rents need to keep up.

Ch. Hogue: Thank you. Further testimony in support.

Rudie Martinson, Exec. Director of the ND Hospitality Association: Support (see attached 1).

Sen. Casper: So we're raising the rents, so that the charity pays the rental rate for each game.

Rudie Martinson: The maximum is for the game of pull tabs. There are sections surrounding this that dictate how much can be charged for the Black Jack and the paddlewheel, etc.

Sen. Casper: This is just in regard to the pull tabs.

Rudie Martinson: Yes.

Ch. Hogue: When did the legislature start capping the amount that your organization members could charge for rent?

Rudie Martinson: I don't know that. Prior to last session, the last time that the statutory cap had been moved up for the game of pull tabs was 1999.

Ch. Hogue: Thank you. Further testimony in support. Testimony in opposition.

John Jorgenson, Gaming Manager for Sharehouse, Inc.: Opposed. This bill, essentially, could increase their rent up to \$1500/year if they were to have a jar bar and a pull tab machine. We're not necessarily opposed to the rent increase; it's more of a wording of the bill, possibly needing an amendment. Our concern is primarily that the bar would see that they could get extra monthly rents for an additional game. They might be tempted to look at other charities that might have more games; more games, more rent. We would like to see a minimum quarterly gross for that rent to have to be paid. Similar to black jack, if you have multiple tables, your second table would have to open 13 times a quarter for you to be able to pay your rent on that table, which prevents the situation where the bar says we'd like you to have three black jack tables so you can pay triple of the rent, even if you only use one table, we want more money for you to operate in our site (the bar). Even when the bar staff is operating on behalf of the charity, paying people for their winnings, if there is just a pull tab machine. The charities are still required that they have to visit that machine weekly, to refill it, handle the paperwork, etc. There are still costs to the charities associated with putting a pull tab dispensing device in a bar.

Ch. Hogue: I understand the dynamics in the small town. But in a large town, with lots of bars, why does the legislature need to tell the establishments how much they can charge in rent; is there no negotiation that goes on between the charity and the establishment.

J. Jorgenson: At times there can be negotiation. If you have gaming in a bar that doesn't do well, as far as gaming, you may be able to get your rent lowered, but that is a very rare situation where you are not paying the maximum rent. There are times when another charity might come in and say that they think they can do better than the present charity, we'll get you more rent because we will put in a machine which has happened in the past.

Ch. Hogue: Thank you. Further testimony in opposition. Neutral testimony. We will close the hearing.




